MILK SUPPLY IN EUGENE.

and unwholesome condition, the Commissioners may notify the proprietor that said dairy must be put in a healthful condition within three days.

Section 7. An article of food or drink or medicine is deemed to be adulterated within the meaning of this act, when— 1. Any substance or substances have been mixed with it so as to reduce or lower or injuriously affect its quality or strength;

Section 18. Every person who manufactures butter or cheese in this State from milk drawn from cows not owned by such manufacturer, shall report to the Food Commissioner every three months; and in case such manufacturer owns any cows from which milk is used in conjunction with purchased milk, the report shall state the fact, and shall include such cows the same as if owned by any other person.
