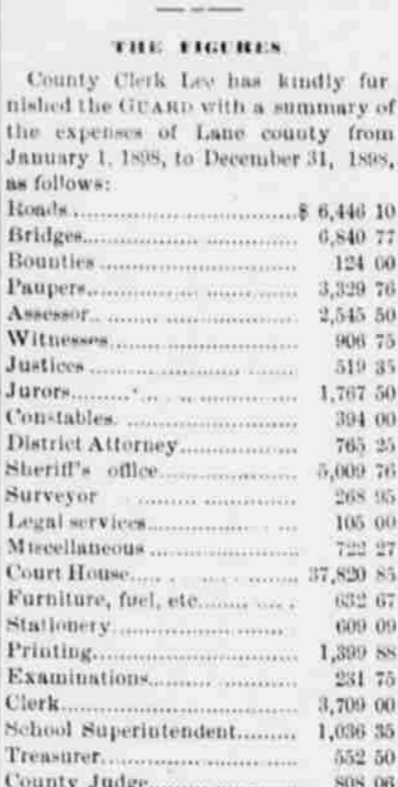

#### TWENTY MILLS.

#### A FARCE

County Commissioners Today Levied the 1899 Tax.

Clerks Allowed All Who Ask for Them.

#### Includes a Court House Fund.

The county commissioners today made the levy for the 1899 tax as follows:

Last year the tax was 17 1/2 mills, and the advance this year is mainly due to the increase of the state levy.

#### Body Reported Found.

Corvallis, Or, Jan 18.—Reports are in circulation that the body of a K Handy, who was lost in the Coast mountains December 30, has been found, and that a bullet hole in the head indicates foul play. While not confirmed, the report is generally believed, because J H Wilson, son-in-law of Handy, was this morning summoned to Falls City in connection with the case. Falls City is 12 miles from the place where Handy was last seen alive.

#### LATER.

The sheriff has gone to Rock Creek with warrants to arrest parties suspected of having murdered Handy. Blood has been found in the snow near where Handy was last seen alive.

#### Court House Clock.

The last of the new court house tower clock arrived here today, including the striking bell, which weighs about 800 lbs. Mr Butterfield writes that he will be here in a few days to place the clock in position and running order. The bell was cast at Cincinnati, Ohio. On the bell is cast the following words:

"I am rung by time's faithful gear,  
Calling men to work and men to cheer."

"Erected by Lane county, Oregon, January, A D 1900."
