DANGER FROM FEDERAL JUDI-CIARY.

The best legal minds of this country realize the danger from the federal judiciary that little by little encroaches upon the rights reserved to the states, and the privileges and domains of the state courts. We well remember a conversation of the present chief justice of the supreme court of Oregon, then judge of the circuit court, on this subject, Judge Bean was of the opinion that the liberties of the country might be menaced by the constantly increasing encroachments of the federal judiciary, and their trenching on the authority and jurisdiction of state courts on the least and most flimsy pretexts. A recent correspondence in the Oregonian is well in point. The writer says:

"A greater danger than the organization and existence of trusts overshadows our country today, and that danger is the silent and steady encroachment of the federal judiciary into the realm of state authority. It is the wooden horse of the Greeks, filled with armed men, Seeking to intrench itself within the limits of state jurisdiction, it will eventually overthrow the last vestige of state autonomy. Government by injunction is simply despotism wrapped in ermine. The trust is but the creature of one branch of the three departments of state government. The injunction is the weapon in the hands of the most powerful department of the federal government. The abuse of the one can be crushed by restrictive legislation. The abuse of the other is beyond the reach of state legislation."





OREGON SUPREME COURT.

Decides an Act of Last Legislature is Unconstitutional.

SALEM, July 10 .- The supreme court today handed down a decision in which it holds that the act passed by the legislature in 1889 entitled "An act authorizing the county courts of the several counties of this state to declare unnavigable streams highways for the floating of logs and timber, and provide for the improvement and use of the same," is unconstitutional so far as it authorizes the taking of private college at that place. property for public use without due process of law.

The case was the Hood River Lumbering Company vs Wasco county. The opinion was written by Judge Bean and is somewhat lengthy.
