PRESIDENT'S MESSAGE

Recommends Support for the Gold Standard.

RECOGNIZES PACIFIC COAST

Favors Admission of Hawaii as a Territory.

ON THE AFRICAN WAR.

Special to the Guard.

WASHINGTON, Dec. 5.—President McKinley's message went to congress today, and its reading occupied the time of today's session. The president exhaustively reviews general conditions, favors legislation for the security of the gold standard, upholds the views of the party taken in regard to island possessions, and outlines by his recommendations what will, in all likelihood, be the republican policy in the coming national campaign.

By recommending the early construction of the Nicaragua canal, and laying of a Pacific cable, the president has prominently called to the attention of the world the Pacific Coast states.

A synopsis of the most important recommendations are as follows:

RECOMMENDATIONS: That legislation be enacted to support the existing gold standard, to the end that a parity may be maintained between the two metals—gold and silver.

That power be conferred on the secretary of the treasury to issue and sell bonds, long or short time, to maintain the gold reserve.

That greenbacks presented for redemption in gold shall be reissued for gold only.

That national banks shall have authority to organize with a minimum capital stock of \$25,000.

That legislation favoring the building of a merchant marine should be enacted.

That proper legislation regarding trusts should be enacted.

That the Pacific cable should be laid [The route outlined is from the Pacific coast of the United States to Honolulu, to the Ladrones, and to Manila.—ED.]

That a bill should pass creating the Sandwich Islands a territory of the United States under present laws.

That the early construction of the Nicaraguan canal is necessary for commerce and our naval uses.

That Cuban independence must be made a reality.

That self government in Puerto Rico should at once be granted.

That our sovereignty over the Philippines must be maintained and demands the suppression of the insurrection before congress acts in affairs there.

SOUTH AFRICAN WAR. President McKinley declares in the message that the kind offices of the American government in averting war in the Transvaal would have been gladly tendered had such a course been possible or had they been desired.

LORD ROBERTS Will succeed General Buller in Command of British African Forces

Special to the Guard. London, Dec. 5.—Field Marshal Lord Roberts has received orders from the war department to proceed to Cape Town, South Africa, and will carry with him a commission as successor to General Buller, in command of the British forces in the transvaal war.

DOCTORS DISAGREE

The Family of J. O. Hunnicutt Quarantined.

SMALLPOX OR CHICKENPOX.

For several months rumors have been floating around that Eugene had several smallpox cases.

Yesterday afternoon a consultation was held between Drs. T. W. Harris, Kuykendall and Prentice over three children of the J. O. Hunnicutt family who reside on East Eighth street. It was decided the child had varioloid, a mild form of smallpox, and Marshal Stiles about 5 o'clock in the afternoon put flags out and quarantined the family. All of these children are nearly well. Three others of the same family have had the disease and have fully recovered.

A GUARD reporter called on several physicians to obtain their respective opinions concerning the disease.

Dr. Kuykendall said that the children were afflicted with a very mild form of varioloid; that there was very little danger; that there had probably been 25 cases of the disease in Eugene during the past few months, eight cases being in the Winfrey family, on East Eleventh street, 1st August; that it was the same disease that so many Springfield people had this summer.

Dr. T. W. Harris: "I am satisfied that the children spoken of are suffering from a mild form of smallpox."

Dr. Prentice reiterated the above, excepting in it being the "Springfield disease," and said the father said the children had contracted the disease at Springfield; that there had been numerous cases of varioloid in Eugene this year; thought there was no danger of contagion to speak of.

Dr. J. W. Harris said he was called to Springfield to examine some cases this summer; that it was plain chickenpox.

Dr. Brown said he had treated professionally the three Hunnicutt children that had fully recovered; that they had the chickenpox; that two children of the Barnes family near by also had the same disease, the chickenpox, and had recovered; that he also treated other cases of the same disease; was certain it was not the smallpox; has had a large experience in treating smallpox; was certain the Hunnicutt children did not have smallpox.

A rumor is around that one of the Hunnicutt children was sent home from school all broken out. This is a mistake.

THE GUARD knew of all the cases named above some time since, especially the Winfrey cases, but was assured that the disease was not anything more than the "Springfield disease," or in other words, chickenpox. It seems impossible that these cases should yield so quickly to treatment and yet be smallpox. Generally a virulent form of smallpox is contracted from the varioloid, when the patients have not been vaccinated, yet we understand that most of those having the disease had not been vaccinated.

The doctors in attendance yesterday on the Hunnicutt family think that there is nothing to fear from the disease spreading, as the children are nearly well.

Geo Minnemeyer.

Members of the Second Oregon volunteers in Eugene learned today for the first time of the death of their comrade, Geo Minnemeyer, who, it is said, was buried one week ago today at Springfield. Mr Minnemeyer had been employed on the new Mohawk railroad, and a notice was sent to him requesting that he come to Eugene today to assist in the organization of the new National Guard company composed of Spanish war veterans. It was in response to this notification that the boys received notice of Minnemeyer's death, but did not learn of any particulars of his illness or burial.

The boys regret that they were not notified, as they would have given the comrade a soldier's funeral. So far as known Mr Minnemeyer had no relatives in Oregon.

AN EXPENSIVE LAW.—The last legislature passed a law providing that one-quarter of a mill tax be levied on the property of each county and two cents per head on each sheep and goat to provide a fund to be used as a bounty for wild animals killed. Lane county will be compelled to "dig up" \$180 for this fund, for which she will receive \$200. The law was made for the benefit of Eastern Oregon sheepmen, who graze their herds on Uncle Sam's domain. It ought to be repealed.

SPRINGFIELD ELECTION.—Monday Springfield elected the following officers for the ensuing year: Councilmen, G. W. Skeels, V. W. Harshbarger, M. B. Huntley, Treasurer, J. W. Stewart; recorder, F. E. Roberts. 75 votes were cast.

A Subscription Paper For Funds to Bring Body Home.

A TEMPORARY BURIAL

Mr R. E. Eastland is in receipt of a dispatch from the point of his son's death in British Columbia in regard to shipment for burial. Drew Griffin started around this morning with a subscription paper for funds to bring the remains home, and we doubt not that our charitable people will give the unfortunate boy a decent interment in the land of his birth and kindred.

From the dispatch it appears that the laws of British Columbia require someone to accompany bodies in transit over transportation line. That being the case someone would have to go from here, else arrangements could be made to have the body accompanied to the boundary shipping line. The dispatch is as follows:

LUMBER BUSINESS.

The Booth-Kelly Co. Shipped 78 Car Loads from Coburg Last Month.

AGUINALDO

Is Reported to Be Ready to Surrender.
