Barren, Cold, and Devoid of Timber-Whence Comes the Gold!

Let no man go to Cape Nome thinking it a holiday excursion. True there are no Chilcat passes to climb, and in summer no ice and snow to encounter. But the best of the weather, except for a few exceptional days in July and August is trying in the extreme. It rains, blows and storms almost continuously. The sun shines only at intervals while the north wind has "let go" to give the south wind a chance or vice versa, and neither is very long "getting hold" again. There are but four or five months in the year during which any work can be done. The days are long with 18 to 24 hours of daylight and a man can work as many hours as he can stand up to it. The country is a barren waste so far as vegetable life is concerned. A species of moss grows on the tundra or level places into which the foot sinks from an inch or two to a foot or eighteen inches according to the amount of moisture present. A kind of grass grows on the lower slopes of the mountains and above that all is desolation. No trees grow in that latitude, of even the most stunted character-nothing that would suffice to build a fire. All fuel has to be carried there save such as has drifted in from warmer latitudes from the sea. The supply of this, though sufficient for last summer, will be totally exhausted by the return of spring. Whoever goes there next summer should be as sure to carry a supply of tuel as ot tood.



In places they himself above pothouse political have been broken; sections of them buried deep under vast mountains of rock. In other places lifted high upon their tops and shoulders.

BAKER COUNTY DEPOSITS. Running across the central part of the country in the Baker county mining district is one of these ancient channels lifted to an average elevation of 5,000 feet above the sea. It is 300 to 400 teet wide and can be as plainly traced now in some of its course as it could have been while the ancient river flowed in its bed.
