They bring a good account of the wealth of the diggings." When Gen. Crook says anything in his quiet and unostentatious way, everybody sees and feels that he means it.

**OREGON TIMBER.**—Some of the citizens of Whitefield, Oregon, propose furnishing for the Centennial Exhibition some samples of their timber products which will be certain to attract great attention there. One of the samples is to be a solid ship's mast, 124 feet long and three and a half feet in diameter at the top, which it is safe to say will be the largest finished spar ever seen. A citizen of Nostocton, Oregon, also informs the commissioners that he will furnish Tillamook fir plank, 12 feet wide and 100 feet long, spruce plank 8 feet, larch and cedar plank 7 feet wide, and hard wood plank of large dimensions, including "shittim wood," such as he says was used by Noah in building the ark. The exhibition of such samples of the timber resources of our coast, the Contra Costa Gazette truly remarks, will greatly enhance its fame and demonstrate the advantage it offers for shipbuilding enterprises.
