Democratic State Convention.

A Democratic State Convention is hereby called to convene in the City of Salem on Wednesday, April 28, 1876, at 11 o'clock A. M., to select six delegates to the National Democratic Convention, candidates for Judges of the Supreme Court in the Second, Third and Fifth Judicial Districts, and for Prosecuting Attorneys in the several Judicial Districts, and for the transaction of such other business as may be thought proper. It is recommended that Primary and County Conventions in the several counties be held as follows: Primary Conventions on Saturday, April 23, at 1 o'clock P. M., and County Conventions on Saturday, April 23, at 1 o'clock P. M. It is expected that in counties where the time thus suggested for holding Primary and County Conventions does not meet the convenience of the voters, the proper Committee will fix a different time.

Republican Nominations in Lake.

The following is the Lake county Republican ticket nominated at Linkville last Saturday:

For Representative, O. C. Applegate; for County Commissioners, Abram Tenbrook and W. J. Small; for Sheriff, T. J. Brattain; for County Clerk, J. J. Charlton; for Treasurer, George Nourse; for Assessor, Milton Riggs; for School Superintendent, H. M. Thatcher; for Surveyor, Lyman Hawley. No nomination for County Judge was made, but was left vacant pursuant to an understanding with E. C. Mason, Democrat, so that Republicans may vote for him as an Independent candidate.

Advices are to the effect that, strictly speaking, the above nominations were not made by the Republican party of Lake county, but by a clique of swamp land jumpers living in the vicinity of Linkville.

Immediately upon the defeat of E. C. Mason as a candidate for nomination on the Democratic ticket an alliance was entered into between him and the Linkville Republicans, by which it was agreed that all the Republicans and disaffected Democrats in the county were to vote for Mason for County Judge and O. C. Applegate for Representative. Whether Democrats and intelligent Republicans of Lake county will support any such corrupt and dishonorable bargain and sale remains to be seen. As the six eastern precincts were wholly unrepresented in the meeting which put forth the above nominations, we don't believe that any Republicans or Democrats of that section will feel obliged to endorse such an alliance.

Harmonious and Confident.
The Convention last Saturday was another evidence that the Democracy of Jackson county is united and confident and constantly gaining strength. The attendance was large for the nature of the Convention (only a few small precincts being unrepresented) and the proceedings harmonious in the utmost. Several persons, who, two years ago, affiliated with the Pizzarinkums, were present as delegates, and signified their intention of hereafter remaining with the party of principle which is now bringing about the reform so necessary in the affairs of the Nation and in whose success—County, State and National—the future welfare of the Union depends. Verily, many years have elapsed since our prospects were as favorable from the outset as they now are.

Let no Nominations be Made.

It is probable that the question of making nominations for Congressman and Presidential Electors will come before the Democratic State Convention next Wednesday. We are decidedly of the opinion that no such action should be taken at present and that it will be for the best interests of the party to forego this matter at present. Several reasons could be advanced why no nominations should be made, but we consider the Convention will have judgment enough to do what is best for the party without any advice from us.

THE REPUBLICAN PRIMARIES.

Wednesday last was the time set for the election of delegates to the Republican Convention, which meets for the nomination of county officers on the 26th, and a right lively skirmish transpired in this precinct between the two wings of that party, which was hugely enjoyed by the average Democrat. The Pizzarinkums were bent on capturing the affair, so as to send delegates of their kind to the Convention who would favor a fusion between the Republicans and themselves and the nomination of a cayuse ticket. They had been in training for some time for the event and had things already cocked and primed, even going so far as to fix on the delegates in secret caucus the night before. Orders had been issued to assemble at the Court House at one o'clock sharp, when it was proposed to gobble the meeting and shut out the "straights." But the "best laid plans of men and mice gang aft a-gley;" for the Republicans, who are such from principle and who propose nominating a straight ticket, thought eleven o'clock a good time for a primary. Accordingly, several assembled at the Court House at that hour and proceeded to business. Capt. Caton, Chairman of the County Committee, called the meeting to order and stated its object to be the election of nine delegates to the County Convention. Nominations for officers being in order, Mr. Caton was chosen Chairman and J. H. Penn, Secretary. Election of delegates was then proceeded to, and the following chosen as such: George Brown, Jas. Herd, C. W. Savage, Jos. Blatt, Matt. Obenchain, John Bilger, Geo. W. Frey, David Cronemiller and J. B. Coates. The meeting then adjourned.

Great was the rage of the Pizzarinkums. They imagined they had such a certain thing on capturing the "straights" that this rebuff completely bewildered them. Several fights were imminent and hard words were freely used, the "softs" giving vent to their feelings in no amiable manner, while the "straights" gave them as good as they sent. However, while the belligerents were working off their wrath on the outside, a consultation was had among the leading Pizzarinkums and it was concluded to have another primary at two o'clock. A resolution, sweeping in style, with which it was intended to demolish the "straights" and proclaim themselves as the only true Republicans, was speedily arranged, and Sam, the bell-ringer, engaged to announce the programme. Quite a crowd sallied down to the Court House to witness the fun, where the following proceedings, as furnished us by the Secretary, were had:

The Republican party of Jacksonville precinct held their primary election at the Court House on Wednesday, the 19th inst., at 2 o'clock P. M. Thirty-nine voters were present.

N. Langell was elected Chairman and J. A. Boyer, Secretary.

The following gentlemen were elected as delegates to the County Convention, to be held in Jacksonville on Saturday, April 15th, at 1 o'clock P. M., and was called to order by Hon. Henry Klippel, Chairman of the County Committee.

Nominations for temporary Chairman being in order, Mr. Klippel was elected, and explained the object of the Convention.

E. J. Farlow was elected temporary Secretary.

On motion, a committee of three on Credentials was appointed, consisting of W. J. Plymale, E. DePeatt and John M. Black.

After a short absence the Committee returned and submitted their report, which was received. All the precincts, with the exception of a few small ones, were reported as being represented.

On motion, the temporary officers were made the permanent officers of the Convention.

E. DePeatt was elected Assistant Secretary. Nominations for delegates to the State Convention being in order, several names were proposed.

On motion, the delegates were voted for by ballot.

The first ballot resulted in the election of E. DePeatt, Samuel Furry, Thos. F. Beall, W. J. Plymale, A. C. Jones, Henry Klippel, Thos. Wright, John O'Brien, as delegates.

On motion, the proceedings were ordered published in the DEMOCRATIC TIMES.

PIZZARINKUM PRIMARIES.

The primary meetings of the so-called "People's" party transpired last Saturday, pursuant to call. To use a popular expression, they were powerfully thin, and in poor contrast with those of the Democrats held a week before, if we take the one in Jacksonville as a criterion, which precinct the Pizzarinkums claim to be a stronghold. Such extensive button-holing and caucusing and blowing as was done by them for several days previously would lead one to believe that there was something enormous afloat; but the person entertaining such an opinion would have been grievously—yea, woefully mistaken.

After the last sound of Sam's bell had been wasted upon the desert air, we sauntered to the new Masonic building, the base of operations. Here we found some ten or twelve of the "patriots" sitting around promiscuously in a small space cleared of the accumulated rubbish, and about as many more spectators present to see the sport. There was "Dad" Ross, who assumed the Chair without ceremony; Bill Owen, of Flounee Rock, who presided at the desk; conveniently in front of the valiant General sat Jim Neil, the man of all work, who made every motion and seconded them, too, when necessary. Judge Watson, Mike Hanley, W. M. Turner, H. Kelly, G. W. Mace and N. H. Berry, of Bear Creek, Mr. Stont of Eden, A. W. Sturges, of Applegate, and two or three others, completed the coterie who manipulated this great "People's" primary.

Here was the "grand mass meeting" Chairman Ross has told about so often in all its glory. A greater conglomeration of office-hunters could not be packed in as small a space. Upon actual count there could not have been more than three of the entire number who are not rabidly hunting for place. Nor is this all. Instead of naming delegates from among their own number they elected two who, while they were not present at the time, emphatically decline to participate in any manner whatever with this abortion. The little business was soon transacted, and the general expression was that if this is a sample of Pizzarinkum enthusiasm and strength at this stage, Heaven preserve us when we witness their demoralization next June.

People's County Convention.

The People's Central Committee met at Jacksonville, March 18, 1876, when it was resolved that a People's County Convention be held at Jacksonville on

Saturday, April 22, 1876.

At 1 o'clock P. M., for the purpose of nominating county officers and transacting such other business as may come before the Convention. It was recommended that primary meetings be held at the usual places of voting in the several precincts at one o'clock P. M. of Saturday, April 15, 1876.

The representation of the several precincts was based upon the vote for Mathew Fountain, for State Senator in 1874, allowing one delegate for every twenty votes cast, and one delegate for every fraction of thirteen. Precincts not casting thirteen votes were given one delegate at large. The above apportionment entitles each precinct to the following number of delegates:
