Our contemporary sensibly suggests that the citizens of Curry, Josephine and Jackson counties unite and build a wagon road to the mouth of the Illinois river from Galice creek down Rogue river, or from Deer creek down Illinois river to its mouth, say 35 miles, and we will have an opening to the Coast and to San Francisco.

INDIGNATION!!!

A SUBLIME EFFORT AND GREAT SPEECH.

Intimidation of the Democracy.

After a lapse of nearly two weeks, some exceedingly virtuous Republicans of Ashland finally got up to the indignating point over the Oregon electoral matter and exploded last Saturday evening. Such resolute and blowing off of "indignation" was never before witnessed in this section. The audience (what there was of it) was called together by James Kilgore, and a string of resolutions after the Custom House plan was read and adopted. Governor Grover and several other prominent gentlemen were resolved out of political preferment and it was promulgated that they should never have any more offices. A true bill was found against the Canvassing Board, and it was decided that the Constitution had been grossly violated by said officials. (Shades of Boise, Pratt, Deady and Watson! Oh! where can you find a place to hide your diminished heads after this decision by these Ashland Solons?) Senator Grover was ordered to keep out of his seat, and a copy of this order was resolved to be sent to the illustrious Mitchell—with quotations—to see that it was carried out.
