VERY POINTED DECISION, The Bureau of Navigation of the Treasury Department has issued the following instructions to the United States Shipping Commissioners, with instructions to post them in their offices, copies of a decision of the United States circuit court for the district of Oregon, M. P. Deady, judge, in the case of the United States v. Meares have been taken also to bring the decision to the attention of United States Consular officers.

In this case the members of the crew libeled the vessel to recover their wages. The court reviewed the testimony and found in effect that the men had been guilty of premeditated and persistent striking and signing of duty that they had refused to discharge the cargo and had been discharged at a foreign port by a United States Consul. The decision of the court was that the crew were entitled to wages to the date of discharge and an extra month's pay.
