The supreme court sat twice a week, on the first Mondays in March and October, also at Pendleton, and on the second Monday in June and December, in Klamath county; and on the third Monday in May and the second Monday in November, in Medford, and on the second Monday in March and August, in Ashland.

For Jackson county, there were probate and chancery courts, which meet every month, commencing with the first Monday, January, April, July and September; for Lake county, the first Monday in January; for Klamath county the 8th Wednesday in March; June, September and November.
