A head-end collision took place at Uplands, a small station on the Southern Pacific railroad near Salinas, Calif., Dec. 19th. The force of the impact was so great that the passenger coaches were absolutely driven into each other for most of their length. The wreckage took fire and the helpless victims in some cars burned to death. Several persons were killed outright and many injured, some of whom are certain to die.

Is the recent decision by the U. S. Supreme Court Chief Justice Fuller and Justices Brewer, Harlan and Peckham hold the same opinion in the Dooley case as in the Pepke case, that the Constitution followed the flag, and that when the Spanish treaty was signed Porto Rico and the Philippine Islands both became part of the United States and therefore subject to certain provisions of the grand old instrument framed by the illustrious founders of this government, namely, that "all duties, imposts and excises shall be uniform throughout the United States," and that "no tax or duty shall be paid on articles exported from any state." Justices Gray, McKenna, White and Shiras, the benighted members of the court, who seem to have not yet discovered that the Philippines and Porto Rico are American territory, see the matter in a wholly different light in both cases. Each of these eight learned legal gentlemen, four on a side, hold the same opinions in every case that has come before the court, growing out of the war with Spain. The ninth justice, Brown, draws upon himself the wondering eyes of the nation, by siding with one set of fours in the Pepke case and with the other set in the Dooley case, although both of them are identical in construction.
