From the Washington correspondence of the San Francisco *Herald*, received by the overland mail, we extract the following:

The Pacific Railroad.

The fight for a Pacific railroad, which must be the characteristic of this session, may be said to have partly commenced by the enemies of Mr. Gwin to get his bill considered—The Administration is said to favor the Butterfield overland route. Many think it is not the best, because it is too long and runs too far south. Any road, however, is better than none, and I say by all means, gentlemen of Congress, since you agree on the general fact, that we ought to have a Pacific railroad, try and settle the minor matter in some way to have the work done at once.

Mr. Mason is pressing the Armitage case, but is vigorously opposed by the Republicans. I suppose the eleven years during which this case has been before Congress will be considered as entitling it to a consideration which would fairly leave it still in the docket.

He was recently examined at considerable length before the Mobile Grand Jury, as to his life in California, as well as in other parts of the country, that one extraordinary case of suicide has almost invariably been immediately followed by others. This is generally supposed to result from some unfavorable state of the weather, causing melancholy and indigestion. It is remarked that in Oregon, where the Graefenbach family medicines are in universal use, cases of suicide are very rare, but three having occurred during the last four years, and all of them were known to have been caused by mental derangement.

SINGULAR MATCH.—Man vs Steam.—The Buffalo (N.Y.) *Courier* says that some time since a match was made between Capt. Beman, of the steam ferry boat Uxbridge, and Mr. I. Mr. Stanley winning by a minute and a half—the whole distance being accomplished in one hour and thirteen minutes which, considering they had a four-mile race to pull against, is very fast time.
