Pistols are charged at \$55 each, muskets at \$125; oats at \$5 a bushel; hay at \$120 a ton, and other things in proportion. At the last session of Congress, when the debt was first brought to the notice of the committee, the War Department recommended its payment, but Mr. Faulkner caused action on the matter to be deferred, in order that it might be fully investigated. By this delay and investigation, the sum of from four to five millions will be saved to the Treasury.

Admission of Oregon. The question is settled at last! Oregon is a State. In our telegraph despatch furnished us by Brown of the Yreka Union, there can be no doubt of its correctness. The objection made by some is that it is hardly possible for the Overland express to make the trip in 21 days, it has been made in that time and less—and then why the necessity or use of a self? We shall believe in its truth until convinced to the contrary, the operators on the telegraph cannot be mistaken.

The correspondence is different from the original.

Com.
