After making an investigation, they reported as follows: Physala, Manzanita, Ashland, Table Rock and Jacksonville Precincts, fully represented...

A communication from Hon. J. C. Tolman, directed to the Chairman of the Union Mass Convention, was read by the Secretary, stating that his absence was not attributable to any want of desire on his part...

FROM THE NORTHERN MINES. One Chance in Fifty! Mr. Samuel R. Taylor, of this place, has allowed us to publish the following letter, received by him from his friend, Doc Watkins.

Mr. Watkins has been in the Nez Percés since the early part of last Summer. His statements will be relied upon by all who know him.

Ono Fios Criv. March 7th, 1862. Binal Sam—Years of Dec. 4th and Jan. 12th came to hand this evening, by the first express from Portland since the middle of December.

We were now drowned out, and had our claims filed on the 1st of December; by the middle of the month, we had about five feet of snow; since that time we have been from up—have not done a lick of work since, except get wood.

It has been so cold, and the snow so deep, that all the stock between here and the Dalles has perished. Several men have been frozen to death between this place and the Dalles, and a great many more are badly frore-bitten, and will lose their toes and feet, and some their hands.

I heard of one that had to have both hands amputated. There has been and is yet a vast amount of suffering in this Northern country at Walla Walla. Wood is \$35 a cord; all the stores and eating houses closed; two thousand broke men are camped around the town. Lewiston is about deserted; what few men are there, are engaged in running off the Indians; there is no grub there.

At Salmon, things are near about as bad; fifteen hundred broke men; not two weeks grub for all hands; they are leaving in droves for Walla Walla. Some come to this place. \$2.50 a plug, whisky \$1 a drink [that's a clincher]; ax handles \$6, camp-kettles \$20 each; flour and bacon, your own price.

Several men went out some time ago and bought some poor cayuse horses, and got them within twelve miles of this place. They paid 15 cents a pound for having their whisky and tobacco packed out to their horses. They are trying to get to Salmon. The first pack train that get into Salmon will make fortune.

They have struck nothing new at Salmon. I talk with men from there almost every day. They all agree in saying, as far as they know, that the mines are confined to two or three miles square; that it has been prospected for twenty miles round, but nothing found that will pay.

They are getting up an excitement there about the Carrizo mines. I sent Tom Ord a letter some days since, in which you can find my opinion of this Northern country. Don't come up here with the calculation of mining for God's sake! If you have got three or four hundred dollars that you want to spend to see the country, why come up here; but don't come with any calculation of making money at the mines.

You would have twice as good a show at a waste bank. Now, I suppose you will see accounts in the papers about new diggings having been struck all around Salmon. Don't believe a word of it. They have not been struck yet. As I have said before, they may strike some next Summer; but when there is one that will get a claim that will pay, there will be fifty will not get a thing.

Claims that will pay eight dollars a day are not worth a cent, for the reason that the working seasons are so short, and every article so dear, that it would not grub a fellow. Now, I don't want you to understand that eight-dollar claims can be taken up any place around here; they are very scarce, and if a man has got one, he will ask you \$1200 or \$1500 for it. Now, I suppose you will think I am "down in the mouth." So I am; but those that come up here this Spring will find to their cost that I have told the truth.

Half the men here have got the scurvy, some so bad that they cannot walk. I am troubled with it slightly; no ankle lame; have to eat fir brush, and such other cures and preventives as I can get. D—n the fir brush. I have got plenty of grub, such as it is. We have had no fresh beef for four months.
