

Proceedings

of the Oregon State Educational Association and Teachers' Institute at the Annual Meeting, held at Eugene City, August 6th and 7th, 1863.

FIRST DAY.

The Association met according to appointment, at 10 o'clock, A. M., in the Court House. In the absence of all the other officers of the Association the Recording Secretary, A. C. Daniels called the meeting to order.

On motion of Prof. E. A. Tanner, the Association proceeded to the election of officers for the ensuing year, which resulted as follows:

President—Hon. A. C. Gibbs, Portland. Vice President—Prof. B. Cornelius, Oregon; Prof. E. A. Tanner, Forest Grove; J. B. Underwood, Esq., Eugene City.

Corresponding Secretary—Prof. T. H. Crawford, Sublimity.

Recording Secretary—A. C. Daniels, Salem.

Treasurer—Prof. E. B. Henderson, Harbortown.

Executive Committee—C. T. Finlayson, Albany; A. C. Daniels, Salem; F. Stilson, Corvallis.

After the election of officers, in the absence of the President elect, Vice President Prof. Cornelius took the chair, when, on motion, the Association adjourned to meet at 2 o'clock, P. M.

AFTERNOON SESSION.

The President being absent, Vice President Prof. B. Cornelius took the chair.

After the minutes of the morning session had been read and approved and some important business being transacted, Prof. B. Cornelius addressed the meeting on the importance of union among teachers.

At the conclusion of Prof. B. Cornelius' address, Prof. E. P. Henderson made some appropriate remarks on School Discipline. A general discussion of the same subject followed, in which most of the members of the Association participated; the conclusion of which the Association adjourned to meet at the Court House, at 8 o'clock in the evening.

EVENING SESSION.

The Teachers of the Association listened to a very interesting address by Prof. E. A. Tanner, of Forest Grove; Subject, "The Age of Pope Leo X."

THURSDAY.

The Association met at 10 o'clock A. M. to adjournment, Vice President Cornelius in the chair.

After the disposal of some miscellaneous business, Mr. F. Stilson was chosen Assistant Secretary by the request of Secretary A. C. Daniels. On motion, C. F. Finlayson was appointed Critic, to criticize the proceeding of the Association.

On motion of Prof. Henderson, the Association proceeded to select a suitable place to hold the next Annual Meeting of the Teachers' Institute. After considerable discussion of the merits of different towns, Albany was unanimously agreed upon.

On motion, the Association adjourned at 11 o'clock, and the Teachers repaired to the M. E. Church, where they listened with great interest to a very excellent and patriotic sermon by Rev. I. D. Driver.

AFTERNOON SESSION.

The Association met at 2 o'clock, Vice President Cornelius in the chair.

After the transaction of some miscellaneous business the subject of Grammar was taken up, when Prof. Henderson made some practical remarks on the best mode of teaching grammar, and was followed by remarks by Messrs. Hall, Daniels, Crawford and others, when the Association adjourned to meet at 8 o'clock in the evening.

EVENING SESSION.

The Association met according to adjournment, at 8 o'clock, when Prof. Cornelius delivered an address on "The Distinction between Instruction and Education."

FRIDAY.

The Association met according to adjournment, at 9 o'clock, A. M., Vice President in the chair.

After disposing of some miscellaneous business, the following preamble and resolutions were adopted by the Association:

Resolved, That in view of all that has been said upon the subject of teaching Geography it is the opinion of this Convention that the use of globes and outline maps are indispensable in the successful teaching of that science.
