**A DECISION IN MINING LAW.**—We publish, this morning, an opinion rendered by the Supreme Court in a question of mining law. A party of thirty men, including one Colman, took up a claim to a copper mine in Calaveras county. They did not incorporate themselves. Some of them employed men to open the mine; others including Colman, refused to contribute. Those who contributed, in five months after the first location, formed another company, taking in some new members, and leaving out Colman and his set. This new company has possession of the mine. Colman and his associates brought suits against some of those who, having belonged to the first company, went over to the second. The District Court decided in favor of the plaintiffs, and the Supreme Court affirmed the judgment. The defendants, on trial, said that the plaintiffs had forfeited their claim by neglecting to work it. But the claim was a joint one; the plaintiffs did not own a divided interest; and when defendants worked the claim, they worked it for all. The original locators were tenants in common, and the possession of one was the possession of all—at least so long as those in possession did not take some measure to deny or set aside the title of their delinquent associates. The attempt then to transfer the claim from one company to another was not justifiable.—*S. F. Alta, Nov. 30th.*
