

Religious.—Rev. W. H. Cain, (Presbyterian) of Fort Jones, California, will preach in Phoenix, to-morrow, at 11 o'clock A. M.

INEXPLICABLE.—We learn from the best authority, that Judge Caldwell of Josephine county, refused to hold Horton on a charge of grand larceny, although he acknowledged in the presence of several witnesses that he had stolen Mr. York's horse. He not only made such acknowledgment, but corroborated the statement by tracing most accurately with a pencil the route to the spot where he had left him. It is difficult to understand why. Probably the Judge thought it expedient to have him tried for his offence in this county first, or that Josephine county was too poor to punish offenses committed within her limits. If Horton be not convicted of the charge against him in this county, and the evidence is really so overwhelming against him in that, he should be returned to its jurisdiction and punished. Horse stealing is something the people of this section are peculiarly sensitive about, and if the officials will not enforce the law when the evidence is plain, people cannot be blamed for enforcing it themselves. We intend no reflection on Judge Caldwell, and if our statement is not sustained by facts, will cheerfully correct it.

IN HIS OLD QUARTERS.—Horton, who broke jail here a short time since, was brought from Kirbyville on Wednesday evening, by Sheriff Owen. The authorities of Josephine county were about to turn him loose, but our Sheriff requested the honor of his company, and tendered him the hospitality of Jackson county until the next term of court. Owen expresses the belief that the fellow is an accomplished burglar, but thinks he can hold him this time. He broke the heaviest kind of shackles in the Kirbyville jail, with very little difficulty, and nearly turned the building—which is constructed of heavy, hewn timber—topsy-turvy. It is only to be regretted that the evidence against him here is slight, and if he is convicted it will only be on general principles.

DEVILISH CRUELTY.—On Wednesday, about noon, Mr. Kilgore found the stolen horse of Comstock & Cawley, securely tied in the timber, between his house and the stage road, together with the saddle that was taken at the same time. The poor animal had stood in the scorching rays of the sun for nine days and a half, without a drop of water or any sustenance whatever, and when found was wasted to a skeleton. He is now in the owner's stable, unable to rise, and it is very doubtful if he survives such cruel treatment. Whoever stole that horse and left him to starve, is deserving of precisely the same treatment himself, and we have only to say that Hell is too cool a place for the wretch, whoever he may be. Since the above was in type the horse has died.

CAPTURED.—On Wednesday last, Jack Ferguson, who is supposed to have stolen the horse from Comstock & Cawley's stable, on the 12th inst., was arrested by constable Webb, at Rock Point, brought up to Jacksonville and immediately lodged in the county jail. Ferguson had hired out to Capt. Kelly, at Roseburg, and was on his way to Fort Klamath with the command when he was nipped. On Wednesday the prisoner was examined before Justice Hayden, who deemed the evidence sufficient to warrant his commitment to appear at the next term of Court. He was accordingly remanded to the custody of the Sheriff.

SEVERE ACCIDENT.—On Monday afternoon last, Mr. L. J. White, of Rock Point, sustained a serious and painful dislocation of the right shoulder blade, by being thrown from a horse. His boys reduced the dislocation by tying him to a post and pulling the joint into place with a rope. The operation was well performed, and we are glad to say that the patient is getting along finely, having visited us a few days since.

PAY YOUR TAXES.—To-day is the last chance to pay your Annual Federal tax, without an addition of ten per cent. Those who are wise will walk up to Deputy Collector Sutton's office and settle. Tax payers in Josephine county are allowed till the 27th in Kirbyville, and 29th in Waldo.

MAIL ROUTE.—A petition is in circulation for a mail route between Albany and Brownsville—so says the Journal.

Proceedings of the Board of Trustees.

August 22d, 1867, the Board of Trustees assembled pursuant to adjournment. Present—D. Linn, President; H. Judge, A. Martin and John Orth. Absent—John S. Love. The Journal of the preceding meeting was read and approved. A. Martin and H. Judge, the committee to whom was referred the matter of changing the width of the side-walks on California St., above 5th, and on parts of Oregon St., with instructions to examine and report upon the propriety of amending the Ordinance governing the same, made a verbal report to the Board, and recommended that the side-walks on California St., above 5th, be fixed at 6 feet wide instead of 8 feet, as at present, and also that the same change should be made on Oregon St., except that part of the street lying between Main and California Sts.; and also recommended that the Town Attorney report a bill to amend the Ordinance as proposed. Some other amendments were proposed in regard to the same Ordinance, and the Town Attorney was ordered to prepare an Ordinance, to be submitted to the Board at their next meeting, fixing the width of side-walks in accordance with the suggestions of the committee; and also to except the south side of C St., the west side of 4th St., fronting the stable property, the south side of D St., from Oregon to 3d, and all of 3d Street except between D and Main from the operations of this Ordinance.

BILLS PRESENTED.
Sutton & Hyde's bill of \$25 for Record Book for the cemetery and \$2 75 for stationery—\$27 50. R. S. Dunlap's bill of \$7 for articles for cemetery. SENTINEL OFFICE bill of \$8 for cemetery advertisement. J. W. Hull's bill of \$15 for completing fence. They were all referred to the Finance Committee. Proposals for making cross-walks were then laid before the Board—being read, they were as follows: John R. Peacock proposed to construct the same for fifty cents per running foot. H. Young for \$30 each for three foot walks, and \$20 for two foot walks. A. M. Berry for \$15 each, for all cross-walks two and three feet wide. Jas. Hubbard for \$26 and \$30 each.

The bid was awarded to A. M. Berry, and the Town Attorney was directed to prepare the bond for security for the work, to be approved by the Board. No further Business—the Board adjourned.

THE PROTESTANT CHURCH.—We visited the church during the present week, and find the work on it progressing well. The walls are now white as "the driven snow," and the pews and other wood work we found very handsomely painted and grained in imitation of Maple and Mahogany. The painting and graining is the work of Mr. P. B. Coffin, and the workmanlike manner in which it done reflects credit on him. We understand that the carpet and curtains are to be purchased in San Francisco and that the church will not be opened for public service until they arrive and the "fixing up" is completed.

SUICIDE.—We learn from the Albany Journal, of the 19th, that a prosperous farmer in Linn county, named Reuben R. Blunt, committed suicide on the 18th, by shooting himself through the head. His mind seemed to be diseased, and he was laboring under mental depression on religious subjects. He was considered one of the best citizens of that county, and is sincerely mourned by a large circle of all parties.
