The Prospect.

Our national prospects, just at this time, are highly flattering. The principle of the fifteenth amendment has been tried in every shape that it is likely ever to come up in, in many of the reconstructed Southern States, and none of the terrible disasters, foretold by the copperhead newspapers and politicians have been realized, or are likely to be realized. The Northern States, to remove any ground of complaint by their Southern sisters, on the score of inequality, have many of them ratified it, and it will soon become a part of the Constitution by the ratification of a greater number than the Constitution requires.

Greenbacks have gone up to 86 cents on the dollar, and the price which the qualified negotiators have set on the national integrity,—the difference between greenbacks and gold—is fast sinking into nothing. The fifteenth amendment and the finance questions, as party issues, may indeed be said to be no longer in the field. There has been bitter opposition to these measures, but when once settled, which they promise soon to be, it is idle to talk of disturbing them hereafter. Nor can a party sustain itself on past and settled political divisions. The disappointed minority will not tarry long to mourn over defeated projects, but hasten on to new grounds of controversy. There is a deep settled conviction throughout the country, that the great dividing questions between Republicanism and Democracy are practically determined, and hence the general feeling, everywhere, of independence from party discipline. It is useless, hereafter, to try and drag men up to the polls, to vote for every political trickster who may have wormed his way to party nomination by wire pulling and chicanery, under the impression that the good of the country requires this sacrifice. Party nominees must come up on the square, or make up their minds to take a look at the Salt River country. The "boys" are going in for the "men," and they can't be either humbugged or coerced into supporting nominees who don't suit them.

Reply to "Clod Hopper."

JACKSONVILLE, March 1, 1870.

ED. SENTINEL—I date this writing at Jacksonville, the political head-center of Jackson county at large. I am little conversant with country matters, and should hardly succeed in describing the agricultural condition of the county any better than "clod hopper," who in spite of his lowly appellation, ample venue, and zealous endeavor to appear interested in country affairs, is evidently much more of the politician than farmer. For the present I shall confine myself to the political part of his letter to the *News* of the 24th ult., pausing, however, long enough, to express my satisfaction at the flattering prospects of the farming community, and suggesting to my country friends, that if they can make it convenient to spare a day, about the first Monday of next June, for "clod hopper" and his associates, it is all they will require of them. The arrangements will all be made, and participation in electing the "regular ticket" is all that is asked. But to his letter. He says, he wants a "new deal." So do I, but not out of that same old enchiridion. I want a full, new deck, composed of the best men in the county, to deal from. I do not ignore principles; but how the election of good, sober, upright, and substantial men to county offices—men to whose honor we are ready to confide any personal interest, men whose naked word is as good to us as the most solemn instrument, and men who are pre-eminently qualified to meet the duties and requirements of official life—can tend to overturn just political principles, I am at a loss to comprehend. But I can easily see that unqualified support of tricky, scheming, and selfish men, on strict party grounds, is not only a blind policy for any party to pursue, but what is above all party claims, it is a public injury. A citizen's duty to the community in which he lives, is paramount to any party claims, and that duty demands the best and most suitable men in county offices. I do not believe in rotation in office as a means of perpetuating party ascendancy. If our naked political principles are not strong enough within us to make us work for the best interests of our country at large, I am not in favor of retaining a band of mercenary office seekers with the hopes of "spoils." Let aspirants to public honors recommend themselves by their suitableness and integrity, and not demand office as party nominees. Let this sentiment be once fairly adopted in this community, and we shall see public virtue springing up and strengthening everywhere, which is incomparably better than mere party bigotry. Put men in office whose talents and integrity are a fair equivalent for official emoluments, and the word "spoils" will lose its significance in politics. I am in favor of the best men for county offices, and against any candidate who does not come out fairly and squarely, and let the people judge whether they want him or not. Let good men, everywhere, join to effect this, and all will be well. In such "unity there is strength" and hope for the people.

ONE OF THE "BOYS."

Correspondence.

ROSEBURG, March 1, 1870.

ED. SENTINEL—The steamer *Sean*, Capt. Haun, commander, arrived at Roseburg, at 5 o'clock, p. m., the 25th ult., having been about a week making the trip from Scottsburg.

She is a stern wheeler, 100 feet long, 20 feet wide, 100 tons burthen, and when loaded, draws 16 inches of water. With considerable freight, and a large number of passengers, she set out, yesterday morning, at 8 o'clock, on her return trip, confident of reaching Gardner last night.

The *Captain* is deserving of much praise, while the crew, consisting of about 20 picked men from the lumber regions below, are also deserving of great credit for their herculean efforts in bringing a steamer 100 miles, over a rapid, rough, rocky, and dangerous river, never before considered safe, (even by the Indians), to be navigated with canoes.

Whether she ever reaches this place again or not, it is certainly a memorable event in the history of western steam navigation.

Tremendous excitement prevailed during her short stay, and crowds of men, women, children, could be seen at all times, flocking in from the country, to obtain a view of the Upper Umpqua.

The *Captain* intends to make regular trips between this place and Gardner, bringing freight up for \$10, and carrying it down for \$6, per ton.

Great efforts will be made to secure an appropriation from Congress to im-

prove the river; and business men are hopeful that the time is at hand when steamboats will ply regularly between this place and Gardner.

Politicians are busy, laying their wires, and pulling their strings for the coming campaign. The Democrats held their primary on Saturday, last; and to say the least, the "bed-rocks" gave the "barnacles" a terrible raking.

A "Reminder."

Last Saturday, after the candles had been fairly lighted in Jacksonville, a cry broke on our ears, from the street, which vividly recalled the sights and sounds of other days. It was the long suppressed but not forgotten "hurrah for Jeff Davis." Again, and again, the proud, defiant, "hurrah," rung out, like a clarion, on the still night air, as though the heart of its author was in ecstasy over a brief moment's relaxation from restraint. Finding a diversion in favor of Jeff Davis and the Southern Confederacy impracticable, and burning with indignation over the downfall of the "Caucasian," the lone hero of the lost cause muttered a deep malediction against "the nigger," and departed.

We, subsequently, learned that on the day the shouting, alluded to, took place, there had been a horse race on the Bybee track, and after the principal race came off, scrub-racing began. Among others, one of the "unfettered" proposed a race with a light complected nigger, who, for some reason, could not see in that light. The was "unpleasant," and calculated to disturb the "normal condition" of the races, and the sequel was that the "unfettered" went after the light complected African with a long knife; who, not liking the turn things were taking, turned about and fled. The "nigger" outstepped his pursuer, but Southern blood was stirred beyond the bounds of prudence, and found vent in cheering for Jeff Davis, and "cussin" the internal nigger, who wouldn't make the race.

Such is pure, genuine, seecesh to the backbone, bed-rock Democracy, in Jackson county.

Precept vs Example.

Last week, our cotemporary launched into us, in fine style, for dragging our law suits into our newspaper, but unfortunately for the effects of his piece, fell into the same error for which he was censuring us. He there asserted that a newspaper was not the proper forum for the discussion of a law suit; that such a course obstructed justice, and that he would not go into such a discussion; and yet, in the same breath he charges Wm. Nus, one of the victims of the Hamlin prosecution, with having been a convict, and even cites authority to prove it. Now, when we consider that our neighbor has been retained by Hamlin to prosecute the defendants, Nus and Schneider, such vilifications of character do seem, to us, to be clearly in conflict with the rule he has laid down for our guidance.

This uncalled for allusion to a mistortune of one of the defendants—which was brought about by just such detestable and pernicious scheming as is now at work in the present prosecution—could only be calculated to make capital for the prosecution; and the design is too apparent to escape any one. Now, one word about the grand jury that found that bill. Our neighbor seems desirous to shift the whole responsibility upon them. Whether the allusion to the men who composed it, as being very respectable, was for argument or adulation, is not very plain. We never mentioned the grand jury, and furnished no grounds for an inference even, against them. We know them to be good men, and we here solemnly protest against their being loaded down with the sins of Hamlin and his retainers.

We have but one remark more to offer on the Moon case. There again the standing of the jury was not impeached, but, on the contrary, our esteem for them, personally, was openly expressed in the article referred to. We neither characterized their verdict as "corrupt," "false," or "willfully unjust." We believe they erred, and thereby did the defendant a great injustice—but that they acted conscientiously we never questioned. On the whole, neighbor, we think you stand convicted an equal offender with yourself, and without even the palliation of being in a "bad humor."

REVELS, the colored Senator elect, from Mississippi, was admitted to his seat, on the 26th of February, by a vote of 48 to 8. He was escorted to his seat by Senator Wilson, of Massachusetts.
