

The Suckling Democracy.

The new departure of the rebel Democracy means, if the dear people will only give them office, they will pretend to be good Republicans. They will swallow everything that they have denounced for the last ten years, if the dear people will only give them the loaves and fishes. They are like unto the anecdote of Governor Barber of Virginia during the war of 1812. It was rumored that the British were marching on Richmond, and Governor Barber issued a proclamation calling on the citizens of Virginia to rush to the army and to save their capital from the invaders. The old farmers, true to their instincts, without waiting for the Government to furnish them good horses, mounted their brood mares that had young colts. After they reached Richmond, the Governor made a forced night march down the James River towards the enemy. Early in the morning there was a tremendous whinnying and neighing in the army. The Governor rode up along the line at full speed and shouted at the top of his voice, suckle colts, gentlemen, suckle colts. The Democrats want to suck. The rebel Democrats have been marched far away from the public tit for the last ten years. They are very hungry. It is with them now, good Lord, give us any kind of principles, so you get us the public tit.

Nearly ten years ago the Southern States seceded. The Democracy shouted it's unconstitutional! unconstitutional and tyrannical to coerce a State! still the war progressed, and the people declared it constitutional and the only way to save the Union. In January, 1863, Mr. Lincoln declared in his emancipation proclamation, that slavery should no longer exist. Democracy solemnly resolved it was unconstitutional and void. Near the end of the war, the Democracy met at Chicago to nominate a candidate to run against Mr. Lincoln for President, and they solemnly resolved everything the Republicans had done was unconstitutional, and that the war was a failure and ought to cease. During the last Presidential canvass, Frank Blair, the Democratic candidate for Vice President, in his celebrated letter to Col. Broadhead, declared the Executive should disregard the reconstruction acts of Congress, and declare them unconstitutional and void. A large portion of these resolutions are good sound Republican principles, with the usual Democratic thunder of unconstitutionality.

The truth is, Blair who preaches war against the late constitutional amendments; Pendleton who, with the Oregon Democracy, preaches repudiation, are no longer to control the hungry Democrats. The rebel Democrats and old time honored Democrats must give way to the hungry office seeking Democrats. They must suck. They will lead the Democracy in the next national convention, and they will repudiate, even in Oregon, their last set of State resolutions and endorse the Republican principles, with some high-sounding words of unconstitutionality. The Democracy must suck, or be continually whinnying, or whining regardless of principles.

MURDER IN A COURT ROOM.—The Portland papers contain full particulars of a murder committed in the Court Room of T. J. Dryer, Justice of the Peace, on Wednesday morning. A suit was pending against a colored man, named Thomas Ward, brought by Josiah Graham, another colored man, on charge of threats to assault. While Graham was giving his testimony, which was being taken down, Ward drew a navy revolver, advanced towards him and shot him dead. The parties were involved in great difficulty and trouble. Graham was under indictment for the seduction of Ward's step-daughter, and all possible ill-will existed between them, but the murderer had no cause or excuse for the act committed.

A Just Demand.

The United States Government has notified France and Germany that a bill for damages to the persons and property of American citizens during the recent war will be presented at the proper time. It is probable that the demand will receive prompt attention, and be paid without any difficulty. France is not in a condition financially to pay any large amount, but with the establishment of a stable government her Ministers will have no difficulty in raising the amount. Germany is well able to pay her share, and being convinced of the justice of the claim, will no doubt promptly pay it.

The German Democrats.

The Oakland News, in speaking of the Germans and their relations to the Democratic party, says: "Unlike the main body of that party, the Germans are generally an educated, reading, and reflecting people; they are naturally attached to enlightened freedom of thought and action; they are not revengeful in spirit, but they are thoughtful and wise, and are capable of reasoning intelligently and accurately from antecedent facts. They cannot doubt that the Democratic party of the United States has been hostile to their national cause all through the recent war; and without an actually miraculous infatuation they cannot possibly sympathize with it, or act with it in the future."

Springer; for Surveyor General, R. Gardnier; for Attorney General, John L. Love; for Secretary of State, Drury Malone of San Francisco; for Clerk of Supreme Court, Grant I. Taggart; for Judges of the Supreme Court, R. Hoge and H. Niles; for Superintendent of Instruction, M. H. Bolander.

Democratic Nominations.

The Democratic State Convention of California has made the following nominations: For Governor: H. H. Haight; for Lieutenant Governor: E. J. Lewis, of Tehama; Judges of Supreme Court: Jackson Temple, of Sonoma, for the short term; for the long term, Seldon S. Wright, of San Francisco.

Paris at the Mercy of the American Minister.

A Paris correspondent relates the following incident: During the reign of the Commune in Paris a body of Communists entered the house of the American Minister, Mr. Washburne, with the intention of committing depredations. The commander of the Prussian forces to the northward of Paris, being informed of the fact, notified the Commune that it Washburne was not in person and property held inviolable the city would be bombarded within twenty-four hours. This warning had its effect, but Paris was at the mercy of the American Minister, and at his word one thousand guns would have opened at the city.

The Right Sentiment.

The Richmond (Va.) Enquirer, in calling attention to the day set apart for the decoration of the graves of Union soldiers, makes the following appropriate and excellent remarks:

"To day has been set apart for the decoration of the graves of Union soldiers interred in the cemeteries near the city. Whatever bitterness may have marked our feelings towards those soldiers, when they stood in our front in the fiery times of war, it becomes us now, ignoring those antipathies of the dead past, to approve all expressions of sympathy and honor given by those who shared their convictions and approved their cause. We wage no warfare against the dead. Whether clad in gray or blue, in our bloody and unhappy collision, they stand now all clad in white, and elevated above the contentions which divide and distract us here."

This is the right sentiment, and a severe rebuke to those Northern Democratic papers and Democrats who even now, whenever the slightest chance offers, lose no opportunity to vilify and abuse the honored names of Lincoln, Stanton, and other illustrious patriots.

A Call for Horace Greely.

A card appears in the Portland dailies, signed by a large number of influential citizens of that place, asking for a special meeting of the Board of the State Agricultural Society for the purpose of taking into consideration the propriety of extending an invitation to Hon. Horace Greely, to be present at the Annual Meeting of the State Agricultural Fair, and that he be invited to deliver the Annual Address.

The Railroad is Coming.

The San Francisco Bulletin says that a large grading and bridge building force is now being concentrated at Tehama, 127 miles above Sacramento—the design being to build the California and Oregon railroad rapidly toward the Oregon line. It is thought probable that Shasta will be reached this year. A magnificent bridge will be built over the Sacramento river at Tehama. The stage travel from California northward, as well as from Oregon southward will be greatly shortened this year. Soon it will be a slight undertaking to pass through overland.

Women Suffragists.

The New Northwest contains a correspondence from Mrs. Emily Pitts Stevens and John A. Collins, San Francisco, notifying the public that the celebrated Woman's Rights lecturers, Mrs. Elizabeth Cady Stanton, and Miss Susan B. Anthony will be in San Francisco on or about the 4th of July, and they may, under sufficient inducement, visit Portland and other points in Oregon to lecture. Let them be invited, and a graceful reception be accorded to them.

Open for Travel.

The Albany Democrat says: "We are authorized to announce that the Willamette Valley and Cascade Wagon Road, leading from this city to Eastern Oregon, via Lebanon, Sweet Home, Soda Springs, Fish Lake, Ochoco, Crooked River, Camp Harney, &c., is now open for travel."

General News.

The waters of the Willamette and Columbia rivers are receding.

The corner stone to the Masonic Temple, at Portland, was laid on the 29th inst., with appropriate ceremonies.

BUNKER HILL DAY was grandly celebrated at Boston, this year.

THE Mountaineer says: "A private letter from Major M. P. Berry, dated June 10th, informs us that he had arrived at the place of his destination in Idaho Territory. While at Corinne he made a short visit to Salt Lake City, to see Gov. Woods, whom he found well and doing well. He also met Hon. Sam E. May, formerly Secretary of the State of Oregon, at the Mormon capital.

FROM the Plaindealer: "We have a Schultz item at last. On last Tuesday, two men passed through town in pursuit of this celebrated convict. They stated that they had found his shackle, and had proof that he was on his way south, on this road."—"The damage to the crops by the hail storm has not been as extensive as we feared last week, being confined, so far as we have learned, to portions of Camas Valley, the South Umpqua, from Canyonville to Myrtle Creek, and the head waters of Roberts and Deer Creek. It is bad enough, but might have been worse.

A SALT LAKE paper says there is to be a grand celebration of the Fourth of July, in that city, with Governor Woods for orator.

INDIANS on the Upper Missouri river threaten to oppose the survey for the Northern Pacific Railroad.

THE Democracy of Iowa have accepted the situation, and have adopted the Ohio platform.

HANDSOME Gift from American Odd Fellows to their German Brethren.

California Lodge, No. 1, the first Lodge of Odd Fellows established on the Pacific Coast, is about to forward to Wurtemberg Lodge, No. 1, the first established in Germany, a very beautiful and appropriate gift, consisting of two gavel, one for the Noble Grand of the Lodge, the other for the Vice Grand. The heads of the gavel are of California rosewood. They are encircled by four heavy, solid gold bands. Into one face of each gavel is imbedded a heavy gold plate with the following inscription, elegantly engraved and enameled: "Wurtemberg Lodge, No. 1, Germany, 1871. From California Lodge, No. 1, California." This inscription encircles the emblematical clasped hands. The reverse face of each gavel bears a similar plate with an inscription, "The Orient and Occident." The three links and the All-seeing Eye appear on this plate. The handles are of zebra wood, and are silver mounted. The total cost is \$75.

COMPLIMENTARY.—The East Portland Era says: "Mr. E. B. Watson, of the OREGON SENTINEL, has retired from the editorial management of that paper. Although differing politically from Mr. Watson, we will give him credit for having published one of the most readable Republican papers in the State."

Legal Proceedings.

State of Oregon vs. Loni Shing, Chinaman; criminal action for murder.

This case is still exciting great interest. The preliminary examination was long, and the writ of habeas corpus may last longer, from present appearances. The record shows:

The complaint was made and warrant issued on the 21st of April last. The trial lasted until the 6th of May. The Justice, verbally, held the Chinaman to answer the charge, and made out a commitment and delivered it to the Sheriff without making any order in writing. The statute provides the Justice shall make out a written order in these words:

"It appearing to me from the testimony produced before me on the examination, that the crime of" (designating it generally) "has been committed, and that there is sufficient cause to believe A. B. guilty thereof, I order him to be held to answer the same."

The Justice of the Peace having neglected to make this order in writing, as required by statute, and the defendant being confined in jail by the Sheriff, the prisoner on the 22d of June applied to Judge Prim for a writ of habeas corpus; it was granted and set for trial on the 23d. A dilatory answer setting out evidence at large before the Justice was filed by the Sheriff. This return was demurred to by the defendant, and the demurrer was sustained by the Court. Finally an issue was made on the 27th of June, to the effect that the Sheriff detained the prisoner on the commitment without any written order for the commitment. The Justice of the Peace who tried the case, soon after the commitment, left his minutes of the trial of the cause and his docket with the County Clerk, and left here for San Francisco. From either of these documents no order for the imprisonment appears.

The Sheriff therefore filed an affidavit to the effect that the Justice was a material witness for the prosecution; that he is the only witness by whom the State could prove whether an order in writing was made or not, and that Justice Wade was coming back soon, and prayed for a continuance until the 18th of July.

The counsel for the prisoner opposed the continuance and contended the evidence was immaterial, that the statute required the order to be in writing signed by the Justice, and entered at large in the Justice's docket; that the statute after specifying various cases to be docketed, said these words in reference to the docketing of this order: "All other matters which may be material or specially required by any statute." It was contended that an order which deprived a man of his liberty was a "material matter," and that it was specially provided by statute; and therefore it could not be proved by oral testimony. Also, it did not appear in the docket as required by statute, it was void and the prisoner was illegally confined.

The counsel for the State contended that the order need not appear on the docket, but might appear on any slip of paper signed by the Justice, and that there the evidence of Justice Wade was material.

Judge Prim decided that the law required the order to be in the Justice's docket, but if the Justice had minutes of the order taken at the time, his docket might be amended by his written minutes. The Judge granted a continuance to the 5th of July, in place of the 18th, for the State, so as to get the evidence of Justice Wade.

E. D. Foudray, Deputy Sheriff, who went to Portland, having in charge an insane person from this county, returned last Tuesday.

Mr. Smith, Agent of the C. P. Railroad, passed through here on Tuesday, going north. He said their company would complete the railroad to the American ranch this fall.

Major S. TRUAX, a former resident of this county, but lately from the East, has been on visit to this city during this week.
