Contemptible.

Under the head of "Telegraphic," the Times of last Saturday accuses the telegraph agent in this place of having withheld a sum of forty dollars sent by telegraphic transfer on Dec. 28th, by Mr. J. J. Lane to his son at Salem, and says that the money was not paid, up to the issuance of that paper, nine teen days afterwards. When the public understand the facts in this case, they will perceive the depth of meanness to which a journalist may descend, when he is lacking in manly honesty and has no sense of justice. The facts are these: forty dollars was paid into the telegraph office here to be sent to Salem, and a receipt given for it. Telegraphic transfers are made, not direct from one office to another, but through the cashier at San Francisco to the office where the payment is to be made. Telegraphic communication between here and San Francisco, as the public are aware, was broken for over twenty consecutive days, and hence the delay in the payment of the money. Another item; five days before the publication of the Times, W. R. Lane received the money—paid in advance of the official order from the cashier at San Francisco, at the personal request of the agent here. Again, the Times asserts that "the boy says he has telegraphed twice and has received no answer. The father says he has answered the only telegram he has received." The father states no such thing, but says, truthfully, that he never telegraphed directly to his son, and exonerates Mr. Turner from any blame in the matter. Mr. Lane, who is a stranger here, and with whom we have no acquaintance, but who, we believe, would not wrong or lie about any person, can be asked as to the truthfulness of the foregoing. We learn that the editor's right bower was the "mouser" who discovered this shocking outrage on the public, and as some peculiar obligations exist between him and Mr. Turner, he must feel much gratified to learn that he has discovered a mare's nest. It is not by Mr. Turner's personal desire that this statement is made, but for the benefit of his friends who desire to know the truth. The agent's acts are open to the most searching scrutiny by those entitled to do so, but the public have a right to learn how low a man can descend when like the editor of the Times he is insensible to every obligation to his fellow man. Contemptuous silence would perhaps be the best answer to these silly charges; silly, because it is well known that no employee would retain his place long if they were true, and the public will hesitate long in future before believing anything from so disreputable a source as the Times.

For the Consideration of the Tax Payers.

The tax payers of this county are aware that the accommodations in the county buildings are extremely limited, in fact so much so that there is no room for the deliberations of a petit jury when the grand jury is in session. We will inform them that the choice room in the Court House is occupied by an attorney, Fay, as a law office, rent free, and has been so occupied for the last two years. We would like to know what warrant the County Court have to allow this man the use of the people's property without compensation; and why, if any rent has been paid, the item does not appear on the annual exhibit. This man, Fay, paid no taxes in 1870, other than poll tax, and we doubt if he has paid that; at the last term of the Circuit Court he cost the people of this county the sum of \$1,360 63 for a criminal prosecution, and that he is still allowed privileges that would not be asked by any other attorney, is somewhat singular. The time was when Fay thought he owned this county, but as he has been spewed out, we see no necessity for him being a burden to the people any longer. We will also inform the tax payers of this county, that when this man took this office in the Court House there was a splendid carpet on the floor owned by the county, and it is fair to presume that it has gained nothing in value by two years use. Will the taxpayers also notice that after the expenditure of much money to beautify the Court House yard, this free tenant has erected a woodshed in it in plain view of the street that adds little beauty to the grounds. As a tax payer we protest against this free use of the public buildings, especially by an attorney, as the room adjoins the grand jury room, and it is quite possible for him to learn everything that passes in it. If the people are to pay this man's rent, all right; but we protest against the furnishing of gorgeous carpets, and for aught we know, fuel, lights and stationery to any one at the expense of the people. It is due to the tax payers that this matter be examined into by the County Court, and that body must be able to show into what fund the rent has gone, if any has been paid, and they will be held to strict accountability for the value of the rent since it has been thus occupied. It is moreover their duty to turn this free tenancy out and let the room be put to its proper use—that of a jury room—we want no privileged paupers.

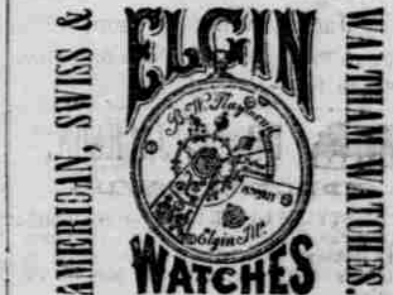
