A Prominent Georgian on Greeley.

(From the Savannah (Georgia) Weekly News.)

The Augusta Chronicle publishes a

long and able letter from a writer

whom the editor says has more than

once been honored by the people of

Georgia "with the highest office in

their gift, and whose public record is

one of which they are justly proud." We

make the following extract from the

letter:

It is rarely, if ever, safe to depart

from sound principles. The rule of

mere policy is never to be adopted, ex-

cept for the advancement of sound

principles. Now what sound prin-

ciples is promoted by the adoption of

Greeley and Brown? Is it not the

preference of one man over an-

other, when neither of them holds to

a single principle in harmony with the

Democratic creed? What I have said

proceeds upon the assumption that we

will elect Greeley and Brown. But I

have little, if any, expectation that we

can elect them. Then, how humili-

ating our position. To depart from

principle to vote for the worst enemy

the South and the Democratic party

have in the United States, and then

be defeated, combine the concentra-

tion of immeasurable humiliation. If

defeat must come, as I think it will,

I prefer to meet it under the old flag of

the party, illustrious with the glory of

its past renown.

But what must be the effect of the

support of Greeley and Brown by the

What H. G. Knew about the Democratic

Party in 1862.

"If the Democratic journals of the

Free States were truly loyal—may it

they were tolerably honest—they

would let their readers know that a

peace with the Rebels is impossible, be-

cause no peace can be had which does

not involve the absolute ruin of the

Republic. Henry May, M. C., from Bal-

timore, a dubious Unionist, elected in

good part by the Secession vote, went

to Richmond more than a year ago ex-

pressly to ascertain on what terms the

Confederates would make peace. They

promptly assured him that no terms

that involve a restoration of the Union

were admissible—that, if they were of-

fered a blank sheet of paper, with au-

thority to write on it their own condi-

tions of reunion, they would reject it.

This has for many months been a mat-

ter of notoriety; but how many of the

Pro Slavery journals of the Free States

have given it circulation? Has it ever

been alluded to in any speech of Gov.

Seymour or any one of his supporters?

Lieut. Maury wrote last Spring from

Richmond a letter to a French friend,

intended to serve as a Rebel manifesto.

In this letter he distinctly declared

that the terms of peace which would be

insisted on by his fellow Rebels were

such as the Unionists would not and

could not accede to until they should

be in the last stages of exhaustion.

They would require a popular vote to

be taken in Kentucky, Missouri, and

Delaware to decide whether those States

respectively should belong to the Union

or the confederacy. And the Lieuten-

ant, though he crammed his letter with

atrocious falsehoods, was frank enough

to admit that he did not expect the

Unionists to submit to such terms un-

til after they have been very badly

whipped."—Tribune, October 2, 1862.

One by One they Fall Away.

In a New York paper we find the

following under date of July 22d, from

Hon. S. T. Streeter, addressed to

Hon. Thomas E. Stewart, Chairman of

the Liberal Republican Central Com-

mittee of New York:

A Confederate Leader on Grant.

The Chattanooga (Tenn.) Herald
publishes the following extract from
a private letter, written by an eminent
ex Confederate General of Virginia to
the editor of that journal:

I have felt and do feel great satisfac-
tion that my course is approved by such
as you. Each day makes me more zealous
in General Grant's behalf. Gross
injustice is done him by a number of
the old Confederates; not so much by
those who fought, but by those whose
occupation it was during the war as it
is now, to abuse Yankees while at a
safe distance from them. Reflecting
that but for his magnanimity, scores
of our bravest and best men might and
probably would have been executed,
and a gulf would have thereby been dug
between North and South, so wide and
deep that ages could not have filled it
up, I do not see or understand why he
is not ardently supported by most
brave men of the South.

The Chicago Times, an extremely
orthodox Democratic, but not a purely
paper, publishes the following among a
host of similar letters:

POSTHUMOUS, July 16, 1872.

Where, in God's name, are we, as a
party, drifting to? Has the time come
when we, as a party, can't make our own
nomination? We, as Democrats, in this
part of the country can't support Gree-
ley, and won't. But next November we
must vote, and that will be for Grant
before Greeley. As for your not support-
ing Greeley with your paper, the Demo-
crats in this part of the country say
"bully." Where there is one Republi-
can in these parts that will vote for
Greeley there are ten Democrats that
will vote for Grant. So, Mr. Editor,
you may expect Livingston county to go
solid against Greeley this fall. If there
had been straight Democratic nomi-
nation Livingston would have redeemed
herself at this election, but the way
things are now, all is lost. Hoping that
Grant may be re-elected, and that it
may teach us a good lesson in the fu-
ture, I subscribe myself,

Greeley's "Pal."

We sometime since alluded to the
fact, says the Oregonian, that George
N. Saunders—one of the most active
of the infamous plotters in the interest
of the Southern Confederacy, who was
detected in a scheme to burn Northern
cities and who was obliged to take
refuge in Canada—had returned to this
country since the amnesty law was
passed, for the purpose of aiding the
election of his old friend Horace Gree-
ley. It did not need the following,
the exact truth of which is vouched
for the Albany Evening Journal, to
prove that Saunders is already deep in
Greeley's secrets:

On Sunday morning last, much to
the surprise and indignation of the
congregation, Horace Greeley, accom-
panied by George N. Saunders and
Theodore Tilton, walked into Rev. Dr.
Chapin's church, taking seats in Mr.
Greeley's pew. It was soon known
that the notorious traitor who was
hatching conspiracies in Canada during
the whole of the rebellion was Mr.
Greeley's guest, and an expression of
disgust was manifest in almost every
countenance, for in our whole city
there is not a congregation more dis-
tinguished for its intelligence and
loyalty than this one. Nor did the
circumstances fail to attract the at-
tention and rebuke of the eminent and
eloquent pastor, whose patriotic heart
must have burned with indignation to
see a man who had conspired to burn
our city and assassinate our President
thus openly and shamelessly patron-
ized by a prominent member of his
congregation.

"Brick Pomeroy says that his Dem-
ocrat reaches 200,000 readers." The
prevailing sentiment among them is
against Greeley. Pomeroy says he has
received 2,000 letters to this effect. He
will not support Greeley in any event.

The Chicago Times (Dem.) says that
the corrupt bargain and sale at Balti-
more places no Democrat under small-
est obligation to support the grantee
in that infamous transaction, which
has inaugurated the most shameful po-
litical contest this continent has ever
witnessed.

Wendell Phillips, it is said, will
heartily support Grant. If Mr. Wilson
be elected, Vice President and Gen.
Butler be made Governor of Massachu-
setts, both of which events are likely
to happen, Mr. Phillips is not unlikely
to obtain a seat in the U. S. Senate.

A telegram to the St. Louis Globe re-
ports a surprising political situation
in Georgia. Fourteen of the most in-
fluential Democratic papers in the
State, including Alex. Stephens Atlan-
ta Sun, the Columbus Sun, the Savan-
nah News, and the Griffin News, all al-
lie, are against Greeley. The Republi-
cans and anti Greeley Democrats pro-
pose a coalition ticket for State officers,
which it is believed will give the State
to Grant.
