Mr. John Maguire, the talented actor, was in town a day or two this week on his way to San Francisco. He will probably make us a professional visit about June—being now engaged in organizing a company.

On Friday evening last a land slide occurred in the canyon just South of Canyonville and the stage had much difficulty in passing it. One of the horses was caught in the slide and killed by being crushed under a tree that accompanied it.

We learn from an authentic source that legal proceedings are to be commenced against members of the late State administration for alleged malfeasance and misappropriation of public funds, the necessary papers now being in a state of preparation.

Papers noted for nothing but their adhesion to Democracy stoutly affirm that the Republican party is favorable to Chinese immigration. While the "World," "Sun" and "St. Louis Republican" loudly applauded the veto the assertion cannot be sustained. The question is not political but one between labor and capital.

Mr. Wesley Mitchell, a prominent and respected citizen of Ashland, died at that place on Tuesday, the 4th inst., of Pneumonia, after an illness of about two weeks. Mr. Mitchell was about 58 years of age, an old pioneer of this coast, and was buried by the Odd Fellows, of which order he was a worthy member. So the pioneers pass away.

The Amateur Dramatic Society are rehearsing frequently and will soon be prepared to give a first-class entertainment. A proposition to apply the proceeds of the first show to the extinguishment of the national debt or the building of a new Court House was promptly extinguished, and we may say that the entertainment will not be given to the Chinese Steamship Company.

We learn that the managers of the late concerts have determined to give the organ, when purchased, to the Union Sunday School instead of bestowing it on any particular denomination. It is proposed to place it in the hands of three trustees, with the understanding that it may be used at church services. This meets our views exactly, as the school represents all the protestant denominations, and as the general public patronized the concerts liberally we think such disposal will be quite satisfactory.

The members and their satellites of the late Democratic administration still wince fearfully under the association of the committee. Democratic organs are filled with plausible statements, explanations and excuses, and the defaulters evidently dread the introduction of the legal probe into the festering sore. They are in the condition of an unfortunate countryman of ours who was assured by a court that he would get justice "By my own honor," pleaded Patrick, "that's just what I'm afraid of." If the accused are innocent they will demand, rather than cringe from, the test of the courts, where the mouths of witnesses will be opened.

M. W. A. Snider, the sawyer, had a kind of supernatural escape from what in most cases would have proved a fatal accident. Though it happened last summer, the gist of which is probably new at this time. He had just seated himself to file the saw (a large circular) when his son, a boy of 16, inadvertently started the engine, and quicker than a flash, his father was thrown over the saw, his thigh passing between the main circular and the top saw. ST PATRICK'S DAY.—Next Monday is the natal day of St. Patrick, the patron saint of Ireland, and generally celebrated throughout the world where natives of the Emerald Isle have a footing. It may seem strange that a race, so readily becoming Americanized, should cling with such tenacity to the memories of the land that gave them birth, but our Hibernian citizens have no reason to be ashamed of their country or countrymen and are excusable. The Irish have infused their vigorous strength, their minstrelsy and their brilliant thought into every civilization in Christendom. Their swords have gleamed on every field where freedom struggled with tyranny, and that of an Irishman at Waterloo saved Europe from despotism. Let us look back to the day when they swelled the ranks of the "boys in blue;" when the voice of the intrepid Sheridan went ringing down the Shenandoah valley and plucked laurels of victory from the cloud of defeat, and confessing how much they have contributed to American liberty, excuse them if they take one day in the year for themselves.

It seems but a step from the bridal to the tomb as her marriage with Mr. Applegate only took place last Christmas, and she has too soon changed the bridal veil for the shroud.

THE CONCERTS.

Under the able management of Miss Mary Gass and Miss Ida Martin the concerts given on last Friday and Saturday evenings were a success. Assisted by Miss Tillie Miller, Misses Cora and Maggie Linn, Misses Fanny Dowell, Kate Hoffman, Kate Dorwin, Effie Bybee, Annie Miller, Eliza Langell, Mrs. J. W. Merritt, Miss I. W. Berry, Messrs Geo. E. Strong, John Boyer, J. H. Hyzer and Mr. Scott they gave the public a most delightful entertainment on both evenings. On Friday evening, notwithstanding the stormy weather, the house was crowded and the singers were encouraged long and loudly by an appreciative audience. The opening duet on the piano and violin, performed by Miss Ida Martin and Professor Scott, was very fine, and followed by a solo, "Kathleen Aroon," by Miss Fannie Dowell, very well rendered; instrumental solo very well played by Miss Effie Bybee; a very sweet duet by Mrs. Berry and Miss Martin; a beautiful solo, "Long live the Moments of Pleasure," by Miss Mary Gass; duet, "Phantom Bells at Sea," by Tillie Miller, Maggie Linn and Fannie Dowell, sweetly sung to Miss Miller's guitar accompaniment; solo, "Waiting," beautifully sung by Miss Cora Linn; trio, Misses Gass and Martin and Mr. Geo. E. Strong. Then a pretty Scotch song, "It's We Two for Aye," by Mrs. Merritt, which was loudly applauded. Duet, "Adieu to the Woodlands," sung with much grace and sweetness by Kate Hoffman and Tillie Miller.

Part second—Duet by Miss Martin and Mr. Strong. Solo, "Ninette," by Kate Darwin, beautifully sung. Solo and chorus, "While the Silver Tints the Gold," a most beautiful thing, and exceedingly well sung by Kate Hoffman, "Tillie" Miller and Messrs Hyzer and Boyer. "Two merry girls," a duet, very appropriately selected for Kate Dorwin and Fannie Dowell, who did the song full justice. Instrumental duet by Miss Annie Miller and Miss Martin, played in a very superior manner. Solo, "My Soul to God My Heart to Thee" by Eliza Langell, splendidly sung; solo, "Friend of the Brave," sung in a very artistic manner by Mr. Strong. The gem of the evening was "Kathleen Mavourneen," sung by request of a number of the audience by Miss Mary Gass, and sung with a sweetness and pathos that is rarely heard, and which makes that song lovable whenever a warm Irish heart beats or true music is appreciated, and the loud plaudits well repaid.

The performance of Saturday evening was scarcely up to the standard of the previous night but many of the most beautiful songs were again sung and a very difficult piece of music very well performed on the piano by Miss Ella Kubli, added much to the entertainment. The duet, "Hear Me Norma," the most beautiful selection from that grand opera, was sung by Misses Gass and Martin with a softness and expression that showed not only high culture but rare native talent, and those ladies certainly did justice to one of the purest gems of music. We can scarcely do full justice to all, and will add that all of the young ladies and gentlemen who so kindly contributed their time and talent to this beneficial concert, acquitted themselves exceedingly well, and can hereafter assuredly command a good audience whenever they desire. The receipts of the two evenings were \$133 75, and the net proceeds will probably be about \$110.

A GRAND SIGHT.—A gentleman just returned from Fort Klamath describes to us that the late breaking up of the ice in Big Klamath lake lately which he says was very grand. The ice was thawed all round the edge of the lake and a heavy gale setting in from the Northwest the ice began to heave and swell as the wind and waves increased till at last it commenced yielding to the drawing waves, breaking with a thundering sound that echoed up and down the lake, from point to point and hill to hill. From Modoc Point the view was splendid. The gale soon swept all the ice from Pelican bay and was driven rapidly to the Eastward, piling floe upon floe, till it was twenty five or thirty feet in thickness. Our informant says the scene was indescribably grand, and his saddle horse trembled and quivered with terror as the broken floes came crashing and surging with irresistible force to the eastern shore, accompanied by the swarms of screaming gulls and pelicans that circled excitedly over the lake.

The people of Douglas county are moving in earnest to secure a narrow gauge railroad to Coos bay. A company is incorporated and stock books will be opened immediately.

BOARD OF TRUSTEES.

The City Council met on Tuesday evening, March 4th. A full Board was present, with President Linn in the chair.

The minutes of the previous meeting of the Board were read and approved.

The President informed the Board that the meeting was called for the purpose of canvassing the returns of the election for town officers, which, being thereupon canvassed, showed the following as the result:

For Trustees, Charles Nickell received 137 votes; N. Langell, 108; John Orth, 106; T. J. Kenney, 78; K. Kubli, 53; Frank Krause, 63; David Cronemiller, 64; T. G. Reames, 105; M. Mensor, 47; M. Caton, 19; George Brown, 20. The Board thereupon declared Chas. Nickell, T. G. Reames, John Orth, N. Langell and Thos. G. Kenney duly elected Trustees.

For Recorder, J. H. Huffer received 41 votes and E. D. Foudray 122 votes, E. D. Foudray was declared duly elected Recorder.

For Treasurer Henry Pape received 162 votes, and was declared duly elected Treasurer.

For Marshal, J. H. Hyzer received 55 votes; Addison Helms, 84; John Bonham, 24; scattering 8 votes. Addison Helms was thereupon declared duly elected Marshal.

In the matter of mining and excavating grounds on fifth street. It was on motion, ordered that the Street Commissioner notify the parties, Smith & Waisman, to proceed immediately to fill up the excavations on Fifth street made by them in mining on said street and clear out the lumber thereon; and that said Commissioner was further ordered that if said parties failed to comply with said order to proceed immediately himself and place said street in good condition for the public travel at the expense of said Smith & Waisman.

COUNTY COURT PROCEEDINGS.—The following proceedings transpired in this court at the March term held on Wednesday last:

The change in the county road leading from Jacksonville to Phoenix over the lands of G. Naylor was granted.

Also the change in the road leading from Phoenix to Eagle Point over the lands of J. N. Hockersmith.

Viewers were appointed in the matter of road leading up Foot's creek, upon the petition of W. L. Colvig and others, to-wit: J. Dodge, J. H. Whipple, H. Cady, with C. J. Howard as surveyor.

The resignation of Jas. Helms, as Supervisor of Road District No. 3, was accepted and A. P. Talent appointed; also that of Franklin Wertz as Supervisor of District No. 30, in whose place J. E. Harvey was appointed.

The report of Jacob Ish as Supervisor of District No. 35 was accepted and Mr. Ish re-appointed.

The petition of J. M. Black and others for a division of Little Butte precinct for election purposes was postponed.

Bills to the amount of about \$2,000 were audited.

SERIOUS FIRE IN ASHLAND.—Yesterday morning a fire, originating in Smith's jewelry shop, swept all the west side of the main street of Ashland from J. M. McCall & Co's brick Northward to the bridge. This included the Post Office, J. D. Fountain's store, E. DePeats boot and shoe shop, Neil & Co's butcher shop, Geo. Smith's jewelry shop, Hemphill's blacksmith shop, the Odd Fellows Hall, office of W. F. & Co, Nutley's boot and shoe store, Inlow & Farlow's drug store, Rigg's photograph establishment, Robert's barber shop, Mrs. Jones' millinery store, Miller's Hall and Meyers tailor shop. The loss is estimated at about \$20,000 partial insurance. The stocks of J. M. McCall & Co. and C. K. Klum were damaged by water but fully insured. This is a serious calamity to our sister town, and the sufferers will have the sympathies of this community. We hope, however, to see our enterprising neighbors soon recover from their loss and re-build substantially again.
