The stage buildings at Grave Creek will soon be completed. The work of covering them commenced on Monday. It is the intention of Div. Agt. Carl to remove his family there in a few weeks.

The nuggets taken from the claim of Thornton, Kincaid & Co. on Silver creek have been underrated. They weighed eighty nine, forty-seven, and nineteen dollars respectively.

Dr. Aiken left here on Saturday for San Francisco where he will remain several weeks. It is expected that the Dr. will bring his bride back with him and they will both be welcome.

The Comstock House at Albany, the property of James Comstock, was entirely destroyed by fire on the Fourth. The building was insured. The railroad buildings adjoining were saved.

The frame work of the new church building at Phoenix was completed last week and will soon be ready for occupancy. Several other buildings are in course of construction at that place.

Mr. and Mrs. Savage of the New State hotel have the thanks of the printers for a pitcher of delicious sherry cobbler and a bountiful supply of cake. The boys say Charley can keep a hotel.

The mining claim of H. S. Brown and sons at Althouse has been increased by the purchase of mining property belonging to Mrs. Hansen. Those gentlemen have now over two miles of the creek.

Green Bros., of the "Sugar Pine" ledge on Galice creek, are still running two "arrastras" day and night on rock paying thirty-five dollars per ton. They have a considerable quantity of rock on the dump and plenty in sight.

The ball on the evening of the Fourth was well attended, fifty odd tickets being sold and festivities kept up until a late hour. The supper furnished by Mr. Savage of the New State was without fault in any respect.

The celebration next in order will be the Odd Fellow's anniversary on August 18th. Ex-Governor Chadwick is to be the orator and we understand that members of Ashland and Kerbyville lodges will be invited to participate.

John Chandler has now in operation a shingle factory on Clayton creek, six miles south of Ashland, and he will start a saw mill in connection with his business. He will establish an agency in Jacksonville soon for the sale of his shingles.

A very large emigration is passing through Lake county, mostly bound for the Walla Walla country. It is said to be of a very respectable and desirable character. Washington Territory will soon be knocking at the doors of Congress for admission as a State.

The Galice Creek Mill and Mining Co. held their annual meeting on the 1st inst. and elected the following officers: Pres., E. C. Brooks; Secretary, J. W. Merritt. Board of Directors, Joseph Wetterer, Chas Saunders, E. B. Watson, E. C. Brooks J. W. Merritt.

This is equivalent to saying that the fellow was too wicked for "Multnomah" but was good enough for Jackson or any other county in Oregon. For philanthropic impudence command us to his clemency.

We understand Sheriff Bybee, as the custodian of the public property, intends lowering the flag staff and putting new halliards on it in such a way that they will not get foul again. It stood on our national birthday like the naked ghost of liberty, and if the commissioners are not willing to pay for putting it in order it should be chopped down, as it is neither useful nor ornamental.

It is a great pity that the remaining few had not been staked out; they might have appeared at the next term of court in better condition, and perhaps it would be better for the people of Lake county to permit them to remain out during the winter.

HOW HE PLAYED THEM.

Everybody knows Jasper House, the genial host of the Ashland House, the man who knows how to keep a hotel. For years Jesse kept the first-class hotel of Crescent City, having for its patrons the "bon ton," and noted for a table that would please the most fastidious epicurians. Jesse was a very prince of caterers, justly proud of his table, but his guests, nearly all practical jokers, frequently soured his usual good nature by turning up their noses contemptuously at the delicate viands. Once a packer on his return from the mountains brought in a fat and juicy bear cub, weighing about forty pounds, and Jesse, always wide awake to the state of the market, secured it. Next day the host was happy. Roasted to the most delicate tinge of brown, stuffed with the most artistic care, ready to be served with the richest gravy, bruin was on the sideboard and the host only feared that it would not satisfy the gourmands. "Bear?" asked Jesse, with a French flourish of the "cub" tools, of the nearest guest. "No bear in mine," replied the boarder. "Bear?" he enquired of a second. "Can't bear it," was the answer. "Take some cub?" he said to a third. "What?" indignantly yelled the boarder, "do you think I'll eat what a dog won't touch—put it in the cub-board." The host grew nervous, and when after solicitation every boarder answered in the negative he felt that a little job had been put on him. Jesse's wrath needed no nursing—it was warm enough. That night he procured a fine "roaster" of the swine species, dressed it and hung it out to cool in front of the hotel. Next day the guests noticed it and were delighted. The dining room was redolent of savory smells and the appetite of the boarders were whetted to the keenest edge. At dinner the host was surly. "Roast pork, gentlemen," he announced in the bluntest manner. Every one took roast pork, smacked his lips and commended its delicious flavor, and many asking for a second installment were disappointed. "No pork," said Jesse as the plates were presented, "not cooked yet, how does cub set on your stomachs?" The guests looked at each other astonished, and when Jesse triumphantly came from the kitchen with the pig they had so fondly anticipated yet uncooked they acknowledged the sell. Several who were really prejudiced against "bear" meat went hurriedly out and saved themselves by the loss of a few shillings. Jesse was even, and thereafter no successful combination was ever made against any particular dish.

HOLT'S BRICK.—The second story of this fine building is beginning to loom up and we are informed by Mr. Holt that he expects to have it roofed in during August. The capacity of this hotel we think will be ample. It will contain twenty-two sleeping apartments besides office, ladies' parlor, dining-room and store rooms. The partitions on the lower floor are all brick, and the building when finished will contain not less than three hundred thousand. The spacious dining room on the lower floor is eighteen by sixty feet, and each bed room is provided with a fire place. The large hall on the second story is thirty-five by seventy-five, and intended for parties, concerts or public exhibitions, we believe is the largest between here and Salem, and will have room to seat five hundred people. Madame Holt is entitled to credit for projecting a building that will be the finest in Jacksonville, and we hope nothing will occur to retard its progress.

Pistol Practice.—On the evening of the Fourth a man in the employ of Veit Schutz, while in a brave state of intoxication, discharged a six-shooter from Breckenfeld's corner up Oregon street, which at the time was full of people, the ball crashing through the Franco American Hotel. There was no Marshall on hand to make an arrest. As a general rule people are allowed a little latitude on a public holiday, but work like this should not go unpunished. No man, drunk or sober, has a right to disturb the peace or jeopardize the lives of innocent people, and if the law is to be powerless we want to know it. There is no ordinance against the discharge of fire arms within the city limits, but it seems high time there should be.

SERIOUS ACCIDENT.—On Friday evening as many of our people were returning from the celebration a wagon driven by a man carrying a top heavy load of patriotism was upset on the grade near J. N. T. Miller's residence and it is only surprising that several lives were not lost. As it was, John Cimboraky was seriously injured about the hips, John Miller had his left elbow joint dislocated and August Bohn was severely bruised about the head. The driver who was running his team at the time should have been the one to suffer, but he was too drunk to get hurt.

THE FOURTH AT JACKSONVILLE.

The celebration here on Friday last was much more of a success than was generally anticipated, and notwithstanding the chilly weather there was a large attendance at Bybee's Grove and very general enjoyment. After prayer by Rev. M. A. Williams, the Declaration was exceedingly well read by Miss Emily Brown. The Oration of Mr. Robert A. Miller was unique in its way, and an evident departure from the old spread eagle style, being a very artistic grouping of historical facts, interwoven with poetic gems of thought. It was delivered in a manner that reflected great credit on the young gentleman, but could scarcely be heard by many of the audience on account of an unfavorable breeze. The games for the amusement of the young people were a success. One of them called "jar spearing" was new and laughable. A number of jars were suspended on a rope, each containing a prize, or something else; the boys advanced blindfolded underneath with an iron rod and were allowed a certain number of "prods," and if they punched the bottom out of the jar they won a prize or a shower of flour or water. The chief attraction was the sweet music of our fine band, which was dispensed liberally and with the best skill. Altogether our celebration was exceedingly pleasant, and not a single accident occurred to mar the general enjoyment.

WILLOW SPRINGS.—At this point the attendance was large on the Fourth, many going from town for a change. The reading of the Declaration by Mr. Frank Sifers was excellent and the Oration by Hon. Nat Langell was one of his happiest efforts. Among the most notable features of the celebration were the equine quadrille, which was very well performed by Colvig's company of lancers, and the feat of riding at full speed and catching a ring on the end of the lance. The champion at this game was John Ralls, he having caught the ring the greater number of times. The large dancing pavilion was well filled during the afternoon and many of our people from town joined in the dances. A side show given by the Foot's Creek minstrels, was said to be quite amusing, some of their performances being new. A large number of stands for refreshments and all seemed well patronized. There were no accidents of any kind and very general enjoyment seemed to be the rule.

WE ARE INFORMING THAT AFTER FRANK Rayburn, who escaped from the Corvallis jail, had been captured at Yreka and the Sheriff of Benton County went to our Governor to obtain a requisition for his delivery to the Sheriff, Governor Thayer declined to grant one and stated that Rayburn had done nothing very bad, and it was not worth while to bring him back to this State. The Sheriff insisted that the requisition should be granted, and threatened proceedings to compel the issue of one. The Governor very reluctantly gave the needed document. Of course the object was to prevent the return of a man to this State who is sure to go to the Penitentiary. He is determined to get as few persons into that institution as possible, and willing to let felons escape just retribution rather than have the number of convicts increased. This may be all very pleasant for the criminals, and may assist Mr. Bush to keep the expenses of the Penitentiary down to the economical maximum, but it is decidedly rough on the people.—"Mercury."

It is possible that we have another "Joanna Southcott" among us, but more probable that a weak minded girl has become half crazed with religious enthusiasm and it may be well enough to let it have free vent.
