James Gordon Bennett Jr. of the N. Y. "Herald" has given \$100,000 to the Irish relief fund. The "Record-Union" says: No doubt this is a capital advertisement, but if wealthy men and firms were in the habit of bringing themselves in notoriety by such benefactions it would be better for civilization generally.

Mr. Mensor's family now consists of nine boys, each of whom has four sisters—and still "he don't vas happy."

Dr. L. E. V. Coon who claims to be Grand Lecturer of the Champions of Honor sends a slip containing his defense against serious charges made by the press. Our Oregon exchanges generally say that he is a "coon" of the Jylst species and as we can work up our own temperance boom, know nothing about him and care less, we will devote our space otherwise.

Oscar Kilbourne, U. S. Ganger, is among us on official business. On Monday he visited the distillers at Phoenix and will attend to business here until Friday. He is accompanied by Edward Hall, manager of the Imperial, Lon on Northern and Queen Fire Insurance Cos. This fact creates a suspicion of the "fiery" character of Jackson county whiskey which needs explanation.

MINING ITEMS.

Thawing at Sterling and piping resumed with a fair water supply.

Miners in Josephine county are generally retarded in their operations by the freeze.

The Applegate Gravel Co. are still busy with a flush head of water and working in good ground.

Geo. McKnight of Footh Creek has been sojourning in town for his health. He reports the miners all very busy in that camp.

The English company at Galice creek are now piping with about 800' inches of water, everything working satisfactorily.

Miners in the Willow Springs camp are complaining of failing water, the freeze having locked up the springs for the present.

Blue Gravel company is using about 600 inches of water and prospects quite flattering. A few warm days will increase their water supply.

The Squaw Lake Co. are now busy driving dirt through the flume again. Ditch all clear and no more interruptions looked for. The "company" is working in rich ground.

From Mr. Chenoweth, just returned from the East, we learn that there is a good prospect that all the money necessary to complete the Grave creek ditch will be raised and that it will be pushed to completion next Summer. The ditch will be twenty-one miles long, and will probably require an expenditure of \$75,000. From our knowledge of this locality we have no hesitation in predicting that when this work is finished the property will be the most valuable in Southern Oregon.

THE MURDERER'S CONFESSION.—The "Statesman" has an account of a confession made by William Tubbs, alias Franklin, who killed his wife and himself in Marion County, July 4th, 1878. A few days prior to the tragedy he told his wife that he had killed fifteen men, among whom were Conrad Warner of Marion county, and a negro in Jackson county, from whom he got \$1,500. The confession was told to Mr. Munsell by Tubbs' wife, who now makes it public. Tubbs was convicted in this county in 1857 of an assault on an old German with intent to murder, and sent to the penitentiary by Judge Deady for ten years. After the commission of the crime the miners on Jackson creek gathered and Tubbs narrowly escaped lynching, being rescued by the Sheriff just as the rope was ready. His confession accounts for the mysterious disappearance of a negro miner, who worked on Jackson creek while Tubbs was here, and it is a pity that the miners who intended hanging Tubbs were interfered with. He was known here by the name of Isaac Tubbs.

"POP EYE GEORGE."—On Monday the 2d inst., Geo. Collins, known as Pop Eye George, shot and killed Clark Hamilton at the Molalla cross roads in Clackamas county, using a shot gun and riddling his victim with buckshot. Collins is well known among the old citizens of Jacksonville, having come here when a lad as a race rider, riding for Sam Oldham as early as 1855 and riding for Ad Helms at Crescent City in 1859. He returned here about four years ago in the role of a faro dealer, and after remaining a short time, left for California in company with a notorious woman named Mrs. Spaulding who we suppose was still living with him when he killed Hamilton.

NOT HIS FEET.—Our jovial friend Capt. Ankeny experienced some difficulty on his recent trip to Galice creek. Taylor creek, on the route had to be crossed on an alder log that was a little shaky and the party were obliged to "coon" it. The Captain, whose avocations is considerable, was crossing and the log bent so that the water was running over his feet when his companion, Frank Ennis, yelled out, "look out, Captain, you'll get your feet wet." "Feet the devil," growled Ankeny, "that ain't what's troubling me, can't you see I'm sitting down in it?" The Captain got safely over, however, but says he don't want any more "sits" baths till the water gets warmer.

RELIEF FOR IRELAND.

A meeting of the parishioners was held on Sunday evening, Feb. 8th, at the residence of Rev. F. X. Blancher, in Jacksonville, in aid of the Irish Relief fund, with J. Nunan as Chairman, and Matt Dillon Secretary. The following committees were appointed to collect subscriptions: Mrs. Judge and Mrs. Schumpf and Messrs. Dillon, Schumpf and Nunan. Father Blancher was elected Treasurer, and the sum of ninety-one dollars was collected at once and paid. The committee appointed to draft resolutions adopted the following:

Whereas, The daily cry of distress and misery in Ireland becomes more urgent and wide spread, and

Whereas, Over 300,000 people suffer appalling privations and are in utter destitution, be it

Resolved, That the canvassing committee appeal to all the friends and sympathizers of Ireland, in Southern Oregon, without distinction of nationality or creed, to unite in the common cause of humanity and charity in order to alleviate somewhat, the present awful necessities of the Irish peasantry.

Resolved, Also that a copy of these proceedings be given for publication to each of our county papers.

HOMICIDE NEAR YREKA.—The citizens of this place and Hawkinsville have been somewhat excited this week over the news of a homicide committed last Sunday, about the middle of the day, on the Shasta Valley side of the divide between Hawkinsville and Shasta Valley, about midway between Yreka and Hawkinsville. The news first reached town by Von Dorsen, who committed the act, coming to town to deliver himself up to the Sheriff, claiming that he was attacked by two or three Portuguese, and that he thought he hit two of them, the other running off. Von Dorsen was much excited, had a bruise on his face, and his coat was cut in the arm and side, as if by a knife. The Sheriff accompanied by the District Attorney, Doctors Harwood and Read and others started out to the scene of conflict, and found but one dead man, Manuel Sylvester, who was shot through the head by both charges from Von Dorsen's gun. Also found a dead sheep, which had been torn by dogs so much as to prevent any certainty of a knife being used in killing it. It seems Von Dorsen had been herding Flock's sheep at the place above mentioned, where a couple of Portuguese also herded a band of sheep, and both parties have had trouble for some time past. On reaching the ground, the Sheriff placed the deceased in a wagon and proceeded with the body to Hawkinsville.—Yreka "Journal." A Coroner's jury found a verdict in accordance with the foregoing facts, but a judicial examination was to take place and the "Journal" refrains from comment.
