

Republican County Convention of Josephine County.

A Republican County Convention is hereby called to meet at Wilderville on the 8th day of May, 1880, at 1 o'clock P. M. for the purpose of nominating candidates for the following offices, viz: 1 Senator; 1 Representative; 3 County Commissioners; 1 Sheriff; 1 County Clerk; 1 Assessor; 1 Treasurer; 1 Superintendent of Schools; 1 Surveyor and 1 Coroner.

It is recommended that primary conventions be held at 1 o'clock P. M. on the first day of May, in the several precincts. The several precincts will be entitled to one delegate and one for every 15 votes and fraction of 8 or over, based upon the vote cast for Governor, at the June election, 1878, which gives the following representation: Kerbyville, 4; Althouse, 4; Williamsburg, 3; Galice Creek, 2; Waldo, 2; State Creek, 2; Leland, 3; Pearson, 2.

BRIDGES TO BE BUILT.—As will be seen elsewhere, the county commissioners have invited bids for the contract to build three bridges, plans and specifications to be seen at the office of the county clerk. Contracts will be awarded by public outcry at the Court House on May 5th.

DISTILLING BUSINESS.—Oscar Kilbourne U. S. Gauger, informs us that he gauged twenty new packages at the stills in this county, last week, containing 1000 gallons of Apple and 500 gallons of grape brandy. There are only nine stills in the State, four of which are in Jackson County.

ROAD SURVEY.—J. S. Howard left on Monday morning for Waldo from whence he will proceed at once to examine the best possible route for the proposed road to Crescent City. He will be accompanied by Dan Hunt and Alfred Gaudon, and immediately after the selection of the route the survey will begin and will probably require about a month.

RETURNED.—Col. Whipple, commanding Ft. Klamath, returned on Saturday from the North where he had been on official business, and left for his post the same day accompanied by Mrs. Lieut. Backus. The Col. seemed glad to be so near his home where he can enjoy a little rest having been on the move for the last two months.

SCHOOL CLOSED.—At the School meeting at Phoenix, last week the anti tax party were in the majority and voted down the tax proposed to support a graded school. Mr. Nickols, feeling that he could not do justice to the large number of scholars immediately resigned and the school is now closed. We know of no better way to close a school except it is to nail up the doors with twenty penny nails.

PAINTING A KID.—A correspondent on Applegate writes us that a little seven year old goat herder, received a kid for his services; but was not satisfied with its color and thought he could enhance its beauty by painting it sky blue. The paint was put on and, naturally enough, the mother deserted the kid, greatly to the disappointment of the artist who will probably not try to improve nature again.

CATAMOUNT KILLED.—Eugene Armstrong tells us that on Saturday last while in company with his father in search of horses, a little North of Jacksonville, Sears' hounds treed a large catamount near them. Eugene ran home for a gun, the hounds keeping the "varmint" tree and when it was brought down by a shot it fought savagely with the dogs until they finally worried it to death.

SPLENDID DONATION.—Mr. S. G. Bayne of Bradford, in the oil regions of Pa., cousin of the editor of this paper, started out to collect 1,000 barrels of oil for the "Herald" Irish relief fund, and in a few days succeeded in obtaining donations to the amount of 4,140 barrels. It will truly be the "oil of joy" to Mr. Bayne's suffering countrymen and adds largely to the magnificent charity of America.

MATTERS IN LAKE.—We had the pleasure of a call last Friday, from Capt. J. D. Ferree, Post Trader at Ft. Klamath, and he says that prospects are very gloomy in Lake county. He estimates the loss of stock at fully fifty per cent and says it is idle to disguise the fact. The Applegate Bros. have lost more heavily during the month of April than during the whole winter, their feed having been exhausted, and as it has been storming heavily since Ferree came across the mountains his estimate of loss will probably be correct.

The beautiful flag of the Odd Fellows was floating from the flagstaff of their building on Monday in honor of the first anniversary of the order in America.

The "Mountaineer" learns that the immigration into the Hood river district in Wasco, during the past two years has been almost entirely Republican in politics.

A fearful hurricane swept over the town of Marshfield, Mo., on the 19th. The town was nearly all leveled by the force of the storm and the killed and wounded number over 200.

Al. Adams of Kerbyville was over with Mr. Hughes last week. He reports the crops in Josephine all in and the people very anxious for the building of the new road to the coast.

The beautiful weather of the past few days has given vegetation a wonderful start and buds are bursting so rapidly that we are inclined to think Spring has obtained a divorce from Winter.

Those attending the May day picnic are requested to meet at the Court House at 8:30 a. m. on Saturday from whence they will march to the Park. Also to have their baskets well provided with cups.

The foundation for the new grist mill of Foudray and McKenzie will be completed this week. The framing of the timbers will commence to-day and work will be pushed until the building is completed.

Our old friend H. L. (Curley) Webb is in town from Linkville, where he is engaged in the heavy business. "Curley" reports the weather here and stock now doing well, the loss has been mostly in stock cattle and will not reach forty per cent.

A jury down at Wilderville acquitted a man last week, accused of assault after he had confessed catching a man in the road and giving him some lick ory. Our informant is incensed and says it beats Mormon juries all hollow.

In his lecture at the Catholic church last Sunday evening on "Adam's fall and its transmission," Father Blanchet set forth that it was one of the doctrines of the Church that all humanity except the Virgin Mary were born in sin.

The Tidings says: "The Barron boys found a coyote's den and killed the old mother and six pups. This will bring them in the next little sum of \$30, as a bounty of \$4.25 is offered for each coyote's scalp by the Farmers' Club.

On Sunday Judge Hanna and Messrs. Autenrieth, Jones, Kahler, Dowell and Nickell dined out for Kerbyville to see how much trouble they could kick up among litigants, as court was to convene on Monday. It was understood that the docket was very light.

Father Blanchet has, so far, received for the Irish relief fund, from the good people within his jurisdiction \$630.45 and is promised a further contribution from Josephine county. This is exclusive of the amount sent him from Yreka.

Chas. Hughes, the genial clerk of Josephine county, made us a call last week. His business in town was the settlement of the bill of costs incurred by his county in the "Briggs" trial, some years ago which amounted to \$1,750.

The "Star" finds fault with "Lord" candidate for Supreme Judge because he is rather deaf. There are none so deaf as those who won't hear, and none so stupid as those who won't understand, which is the case with some of the present baronets of the Oregon bench.

A correspondent relates the circumstances of a cruel and extraordinary hearing, given to a little girl, by one of the school teachers in the valley, but as it is not authenticated we will not publish. The proper course to be pursued is to lay the matter before the directors.

Mr. Brown, living near Wilderville, Josephine county, intends going quite extensively into the syrup business. He will add improvements to his mill and be supplied with cane by his neighbors. If the "Early Amber" variety is planted, it will be as easy to make sugar as syrup.

A. G. Rockefeller, of Ashland, has found another "molar" of huge size in his diggings, evidently belonging to an animal of the Mastodon species. It is a memento of the far time when this portion of the globe had a tropical climate and was filled with the huge animals that live only on the rankest vegetation.

It is expected that Archbishop Seghers will officiate at the Catholic Church here on Sunday. The services will be unusually interesting. During his stay here there will be morning and evening services, which will probably continue until May 6th, which will be Ascension Thursday.

A drunk man named Edward Ward lay down on the railroad track near Canby on Monday evening, a week ago, and fell asleep. He was awakened by the South bound train, after it had cut off a leg and an arm, so says the Standard. Moral—neither get drunk, nor make your bed on a railroad track.

Sheriff Thompson, of Walla Walla, has received information by telegram that the arrest of Samuel Bremm, his wife, who are charged with perpetrating the double murder near Walla Walla recently. The parties were arrested at Kansas City, and will soon be returned to the place where they committed the terrible crime.

Father Williams who occupied the M. E. pulpit on Sunday morning, preached on the subject of Christ's remarkable answer to Peter's confession: "Thou art Peter, and upon this rock I will build my church," etc. The speaker set forth that it was upon the confession of Peter, and not upon his person that the church of Christ was built.

We are assured by Wimer & Son of Waldo, and other merchants of Josephine county, that if the proposed road is not built they must discontinue freighting from Crescent City and turn their attention to Portland. They say that the old road is nearly impassable, and that the North Fork of Smith river is now without a bridge and cannot be forded until late in June. They are strongly in favor of a new and permanent road.

The "Star" says: "We have noticed a number of Jackson county transients in our city during the week, but for the life of us we can't divine how they got here with their wagons. In a year from now we hope to be able to accommodate them with first-class roads and don't you forget it." The above is hopeful, but a "year from now" we will be unable to furnish the transients, as there is every indication that they will then be hauling over the new road to Crescent City. The authorities of Douglas have been too slow, but the first class roads will be a good thing for home use.

The following from the "Coast Mail" (April 17th) indicates the manner in which contracts are enforced in Coos county. The County Court last week ordered the contract with J. P. Messer for keeping the paupers to be annulled; that the County Judge be authorized to contract for their keeping, at not more than \$4.75 per week, till July, at which time a new contract will be let. This action was taken in consequence of a complaint having been made that proper care was not taken of the paupers with reference to their cleanliness, comfort and health; the charge was supported by the attending physician and other.

A correspondent of the Crescent City "Courier" writing from Ellensburg says the superintendent of the Salmon fishery, at the mouth of Rogue river, has controlled the priories and proposes to elect a Senator, who will stop the Josephine and Jackson county miners from sending their "delirium" down that stream. This would be very serious and alarming if the thing could be "dild," but there is not the slightest danger of electing a Senator who would take stock in such a scheme, or of his successful interference with the mining interests of Southern Oregon.

MINING ITEMS.

In the Willow Springs camp, nearly all the miners are engaged in cleaning up and the prospects are fine.

A quicksilver furnace is talked of to work cinnabar ore on the claim of A. G. Rockefeller near Ashland.

The Beck boys, below Wright's on Applegate are still at work and said to be making big wages ground sluicing.

The Pickle claim on Jackson creek is paying well—one of the boys picked up an \$8 nugget last week while sluicing.

Sam Lackland of the Palmer creek mine is piping continuously. He made a partial clean up last week with a fair result.

Supt. Fitzpatrick of the Applegate Gravel Co. is piping in a back channel with good success, frequently getting two bits to the pan above bed rock.

Gin Lin, the Chinese mining sharp, is said to be working in richer ground than he has yet worked. He made a clean up of over \$2,400 for about twenty days run.

Eckelson, Chappell & Co., of the Star Gulch mine, cleaned up \$1,064 on Saturday last after a little over two weeks run. This company still have ample water for piping.

Supt. Kippel of the Squaw Lake Co. has made a clean up which is said to be very satisfactory to the company. Everything is in good order at the claim and piping continues day and night.

Logg & McDonald have over an acre of rich bed rock to clean up and we are told that it is perfectly yellow with gold dust. They expect to clean up eight or ten thousand dollars for the season.

Frank Pickle, just in from Elliott Creek informs us that miners are just beginning to get into their claims in that camp. Pickle, Smith & Co. took out \$107, in three days last week and are still on the lead.

Emis of the Sterling mine is happy and Capt. Ankeny of the same Co. smiles all over at the apparently rich character of the gravel they are now rushing through their flume. They have a half mile of boxes and while opening their cut last winter have moved over 130,000 ton of rock with their power derrick.

APPLAGATE CORRESPONDENCE.

Weather changeable, grass growing finely and stock doing well. Loss of stock, light in this section. Severe colds prevalent and we have several cases of severe sickness. Wheat and all other grain coming up nicely and looking well and farmers are now generally preparing for corn planting. Wm. Robinson of Lake county is here from the 10th of the ground there has not been any snow. I did Mr. Wilder no injury in saying he rented the temperance hall for a saloon as he told me himself that he did it, and I might publish the fact.

Lumbering, a leading pursuit in this locality promises, to be quite active during the coming year.

Marsh & Patterson are constructing a car track from the steam mill to the head of the belt of saw log timber.

Stock raising, hitherto a prominent feature in this locality has received a damper last winter, which will have a deteriorating influence on that branch of industry, hereafter.

Olenchain Bros' have lost several head of horses, and Wash Olenchain says they will not save more than 30 head of calves this Spring.

MURDER OF CHAS. DE YOUNG.

SAN FRANCISCO, APRIL 23d.—Just before 8 o'clock, this evening, Charles De Young entered the business office of the "Chronicle" and stood talking with some gentlemen leaning against the counter. Directly the door opened, I. M. Kallach entered drawing a pistol and without saying a word began firing at De Young. The latter ran through the gate of the counter to the desk inside, young Kallach firing at him as he ran. On reaching the desk De Young turned to face his opponent with a pistol in his hand, when Kallach leaping over the counter fired again, the ball striking De Young in the mouth.

Kallach then started for the door, De Young raised his pistol in an attempt to fire on his assailant, but his strength failed and he was unable to discharge his pistol, and sinking backward fell on the floor. The bystanders ran to his assistance but the ball had evidently pierced the base of his brain and in a few moments he expired without speaking a single word.

Kallach endeavored to make his escape by running through the door by which he entered, but was instantly seized by a citizen, who detained him until an officer came, who took him into custody and conducted him to the City Prison where he was securely locked up. When arrested, he behaved with the greatest unconcern and the officer who took him in charge says he is the coolest man he ever saw, still carrying the smoking pistol in his hand which he surrendered to the officer. On the way to the City Prison he observed strict reticence, and on being shown to his cell he positively refused to have any intercourse with representatives of the press or allow himself to be interviewed.

In the absence of any explanations from the assassin, it is generally understood that the act of young Kallach is attributable to the publication of a pamphlet which has been recently circulated in the city, attacking Mayor Kallach, father of De Young's slayer. During De Young's recent visit East, it is believed, he devoted a great deal of attention in gathering material regarding the past life of Mayor Kallach, for the presumed purpose of using it on his own trial for shooting at Kallach last August, as a line of defence, or making it subservient general journalistic purposes. The pamphlet above referred to was a document of 60 pages and recounted the details of the Kallach scandal in Boston and contained other matter of a scandalous nature. The authorship of the pamphlet was unknown, but it is thought young Kallach considered De Young responsible for its publication and acted accordingly.

Further inquiries show that young Kallach fired five shots at De Young, of which only one, the last, took effect. It is quite evident that the deed was cold blooded and deliberate. The officer states that a few moments before the killing he saw young Kallach walk along Kearney street peering through the windows of the "Chronicle" counting room, evidently watching for the arrival of his victim.

At a quarter past 9 o'clock the Coroner's assistants took the body from where it had been lying on the floor, awaiting examination and removed it to a wagon for conveyance to the morgue. In the meantime the crowd increased to over one thousand blocking Kearney and Bush streets. It was composed of all classes, including very many of the sand lot gang, and as the body was brought out, cheers, howls and ejaculations of exultation and derision arose. The Coroner's wagon escorted by a body of police proceeded at once to the morgue, followed by a hooting jeering, whistling, yelling mob. The demonstrations were confined merely to words, no action of a violent nature occurring.

Arriving at the morgue, the crowd gathered there for a while and continued its demonstrations, but soon dispersed and officers retired. The conduct of the mob called forth many expressions of indignation and disgust from more respectable bystanders, but there was nothing whatever tending towards a breach of peace.

SWAMP LAND DECISION.

We find the following in the S. F. "Bulletin" of the 21st:
"Secretary Schurz has reversed the decision of the Commissioner of the General Land Office rendered in January, 1879, in the swamp land case of Dennis Crawley against the State of Oregon. The decision of the Secretary is in favor of the claim of the State. He holds that the obvious meaning of the law of 1860 is not to continue the disposal of land found to be swamp or to dispose of land in the face of the asserted and undetermined claim of the State.

This decision is a most important one, ignoring the pretence of good faith by settlers on lands actually swamp; and it will not only settle all controversy where the swampy character of land can be established, but will give the State the right to recover lands of such character wrongfully patented by the Government, under the homestead and pre-emption acts.

TIMBER KILLED.—It is said that the severe cold has killed many of the black oaks in this section. Mr. Ashmead, of Rock Point, has been investigating the matter, and has failed to find a single tree that has not been killed. In other localities it is evident that the oak has been severely injured; as the buds show no signs of swelling. When timber, indigenous to this section, is killed, the very exceptional character of the late winter will be understood.
