THE INDIAN CENSUS.—On the 1st of October a census of all the Indian tribes will commence. Major John W. Powell, Supervisor. The country has been divided into four Supervisor's districts. District No. 1 embraces all the territory east of the Mississippi, Louisiana and Texas included; the second district embraces the Indian Territory, New Mexico and Arizona; the third district, California, Nevada, Oregon, Colorado, Wyoming, Idaho, Utah and Washington Territory; the fourth district, Minnesota, Dakota, and Montana.

VERY NAUGHTY.—The "Statesman" is authority for saying that Gov. Thayer and W. H. Watkins on Saturday, the 18th inst., indulged in an altercation on First street, Portland. Watkins applied to his Excellency every epithet in the vocabulary of abuse, and threatened that when the troubles he had on hand were settled he intended to administer a severe castigation to the Governor. Watkins accused Governor Thayer of misrepresenting and trying to ruin him financially; he would have made an assault on the Governor but for the interference of a third party.

WATCHMEN AT THE POLLS.—Most of the papers in the State of New York publish the following item, peculiarly interesting at this time: In view of the coming election it is well that all should be familiar with the provisions of the statute passed by the last New York Legislature. It provides for the appointment of two watchmen for each political party at each polling place. These watchmen are entitled to be present at each election in the room occupied by the inspectors fifteen minutes before the opening of the polls; and can remain until they are closed. They have the privilege of examining the ballot boxes, the reception and depositing of every vote cast, and the canvass of the ballots. The ballots and ballot boxes are not to be removed from their constant sight and inspection and they have the authority to inspect the returns made.

A SUICIDE.—A lonely miner's cabin on the right fork of Birch Creek in this county, on the 23d of this month, was the scene of a lamentable suicide. On the day alluded to, Chas. Brown, an old bachelor, aged about fifty years, was suffering from his cabin. Wm. Williams, also a miner and partner of Brown in a mining claim on Birch Creek, whose cabin is located a short distance from the latter's, had occasion to visit his partner, and failing to find him at home, became suspicious at once as Brown had been on quite a spree for several days previous. Visiting Brown's cabin again later in the evening and still finding him absent Williams became convinced that something was wrong, and on the following morning secured the assistance of some neighbors who proceeded to hunt the missing man. They had only proceeded a short distance from the house when they found Brown's body lying at the foot of a tree with an empty shot gun at his side. Appearance indicates that he had placed himself at the foot of the tree, aimed the muzzle of the gun hard against his forehead and with a stick cut to the desired length, touched the trigger that launched him into eternity. The whole top of his skull was blown off and death must have been instantaneous as there were no signs of a struggle. Coroner Schütz was summoned immediately and the verdict of the jury was in accordance with the above facts. Brown had been quite morose and melancholy for several days past, but the actual cause of suicide is not known, except that he had become tired of life.

KILLING OF A GREENBACKER.—From a special to the San Francisco "Chronicle," we learn that Dr. P. A. Talbot, editor of the "Greenback Standard" of Mayville, Mo., was assassinated in his own house by some unknown person on the night of the 18th of September. It was nine o'clock when Dr. Talbot was sitting in his room reading, when suddenly a bullet came crashing through the window, striking the doctor first cutting off two of his fingers and then passing into his chest through his side, grazing the leg of Dr. Talbot and lodging in the wall beyond. Talbot died in a few hours afterwards.

We knew Dr. Talbot very well in Missouri. He had lived in Missouri 28 years most of which time he had been an active Democratic politician, but within the last five years he has acted with the Greenbackers to the great chagrin of his former political associates, who were very envious of his influence. It is more than likely that politics had something to do with his tragic end. Before he expired, he stated that it was hard for a man who had been laboring for the past fifty-five years in conducting his paper, and who had been honored with a number of letters from the Greenback candidates for Vice-President, should thus be shot down by a midnight assassin in his own house.

THAT RELIGIOUS DISCUSSION.—We attended an interesting religious debate on Wednesday and Thursday last week at Eagle Point, between Rev. Messrs. Sherrill and Peterson. The question was, Has Christ a kingdom on earth? If the term "kingdom" had been defined according to the accepted rules of ecclesiastical law and Webster's unabridged dictionary, the gentleman debaters would have found the subject less complicated, and the understanding among the laity would have been promoted. As it was, both sides claimed the victory and the public was not benefited much.

The debate was continued on Friday, Sunday and Monday. According to Elder Sherrill the soul of the patriarch Abraham has been asleep—dead—since his departure from this world, as are also dead all the souls of the departed; and will remain dead until the resurrection at the second coming of Christ into this world—whenever that will be. ROBERT TOOMBS' LATEST PROPHECY.—The great Georgian is still given to prophesying. The older citizens will remember when, 25 years ago Toombs predicted that the time would come in less than ten years when he would call the roll of his slaves in sight of Bunker Hill monument—a prophecy which never came true. In August of 1880, writing to an intimate friend in Washington, the Georgia oracle again makes a prophecy, and it is as follows: "I am so positive that Hancock will be elected as there is a God in the heavens. You may say he is a Yankee, well I know that; and know, too, that his sword has pierced the breast of many a gallant man in gray. But what are we to do? We may not put in one of our own men this time, and have to take a 'Yank.' That being the case, let us take one who is less 'blue-bellied' than the most of them. You may depend upon it, sir, that 'Yank' or no 'Yank,' if elected, the old boys of the South will see that Hancock does the fair thing by them. In other words, he will run the machine to suit them, or they will run the thing themselves. They are not going to be played with any longer. If you hear any man say that Hancock cannot carry all of the South, may put him down as a d—t—t." [Robert Toombs' letter to a friend in Washington. The people of the North are this very moment dissecting this new prophecy and will vote it overwhelmingly false on the 24 day of November next.]

A GREAT CAMPAIGN SPEECH.—Gen. E. L. Applegate, one of the Republican candidates for Presidential Election, spoke at the Court House, Jacksonville last Thursday afternoon to a highly appreciative audience. The course was the most argumentative we have ever heard, and stamps the General as one of the foremost political thinkers of this country. His delineation of the growth and baneful effect of the states right heresy which culminated in the election of James Buchanan, (who held that the National Government had no power to protect itself), was a masterly effort. His arraignment of the Democratic party for upholding and preaching principles that were calculated to weaken the national feeling in the mind of the people, thus encouraging and abetting secession was unanswerable. General Applegate's oration, continuing three hours in its delivery, had an electrifying effect upon every Republican present, and a number of Democrats who heard it declared that the facts therein stated could not be gainsaid. If this speech had been held at Faneuil Hall instead of Jacksonville it would not be long before its author would be considered a fit successor of Chas. Sumner.

A GOOD BILL.—House Bill, No. 12, introduced by Mr. Beale, a bill to regulate the practice of medicine and surgery, is before us. It provides for the organization of two Boards of Medical Examiners, which shall issue certificates to all doctors who have diplomas from Medical Colleges and to all other physicians who can pass an examination. It is a measure which if matured and short of some of its weak features, will do much to protect the people from the evils of quackery. Concerning the examinations to be made under this act, the bill in section 5, empowers certain persons therein named from being examined. This distinction should not be made, and if suffered to remain will destroy the usefulness of the measure, if not jeopardize its passage.

SAD ACCIDENT.—A sad accident occurred at Chicago on the 10th inst., which resulted in the death of Mr. Samuel Lake. He was driving a team belonging to Dr. Blake, and as he came to his own home a short distance this side of Mr. Blake's he stopped his team and went in to see if his supper was ready. The meal was not ready, and taking a piece of bread he started out, remarking that he would drive down to Mr. Blake's and unload. As he reached the door he saw that the horses impatient to get home, had started off, and being on a down grade had commenced to run. Mr. Blake ran to stop them, and his wife saw him try to catch the lines, and missing them, endeavoring to spring upon the wagon. This was the last she saw of him until running out she found him lying in the road. He endeavored to speak but could not do so. Mrs. Lake then screamed, and her mother, Mrs. McVey, living near by, hurried over, reaching there in time to see the unfortunate man breath his last, without uttering a word. It is difficult to tell in exactly what manner his death was caused, as a close examination was not made, and the only marks found upon the body were a contusion on one side of the head and a few other slight bruises on various parts of the body. It was reported that the wheel passed over his neck, but this is denied. [Des Moines Record.]

PRESIDENT HAYES IN JACKSONVILLE.

The Presidential party, consisting of the President and Mrs. Hayes, Gen. W. T. Sherman, Dr. D. L. Huntington, U. S. A., Dr. J. W. Herron and lady, of Cincinnati, Mrs. John G. Mitchell of Columbus and John Jamison, arrived at Jacksonville at 6:15 on Monday night, Sept. 27th, and put up at Madison Hotel's new Hotel, where a suit of rooms had been expressly fixed up for them. The town authorities not having made any arrangements to receive the President a number of the citizens took it upon themselves to extend the hand of welcome, and assist the high visitors off the stage and escorted them to the grand sitting room of the new Hotel. Nevertheless, the people of Jacksonville turned out en masse to see and greet the President. Holt's Hall was brilliantly lighted up, and the brass band taking position in front, the hall was soon filled to overflowing. At 8 o'clock the Presidential party, escorted by a committee of citizens, assembled in the hall, and President Hayes and Gen. Sherman took positions on the platform, accompanied by Messrs. C. C. Beckman and Adam Klippel. After the band discoursed several patriotic tunes, Mr. Beckman introduced the President with a few appropriate remarks. Mr. Hayes then spoke for about 25 minutes in a clear conversational manner. He stated the object of his visit to this coast to be to gratify a desire long felt to view the grand scenery of the country and to cultivate a closer acquaintance with the people. They stopped at the Madison for breakfast, after which they went on to Roseburg, where they will stop until the arrival of the President. From Roseburg the united party will take special train to Portland.

SAD ACCIDENT.—A sad accident occurred at Chicago on the 10th inst., which resulted in the death of Mr. Samuel Lake. He was driving a team belonging to Dr. Blake, and as he came to his own home a short distance this side of Mr. Blake's he stopped his team and went in to see if his supper was ready. The meal was not ready, and taking a piece of bread he started out, remarking that he would drive down to Mr. Blake's and unload. As he reached the door he saw that the horses impatient to get home, had started off, and being on a down grade had commenced to run. Mr. Blake ran to stop them, and his wife saw him try to catch the lines, and missing them, endeavoring to spring upon the wagon. This was the last she saw of him until running out she found him lying in the road. He endeavored to speak but could not do so. Mrs. Lake then screamed, and her mother, Mrs. McVey, living near by, hurried over, reaching there in time to see the unfortunate man breath his last, without uttering a word. It is difficult to tell in exactly what manner his death was caused, as a close examination was not made, and the only marks found upon the body were a contusion on one side of the head and a few other slight bruises on various parts of the body. It was reported that the wheel passed over his neck, but this is denied. [Des Moines Record.]
