The list of interments, kindly furnished the SENTINEL by Sexton Dunlap, shows a very low rate of mortality for Jacksonville, only six of the interments being from town. This gives a mortality of less than one per cent.

Capt. I. D. Applegate of Linkville was in Jacksonville on Tuesday last. He reports cattle in his section as faring well and fat. Cap. Applegate gives it as his opinion that Lake county will never be a successful Agricultural region.

There were twenty interments at San Francisco during the past eight months and not a single case of hanging. The climate of that city seems peculiarly favorable for "emotional insanity," but ill adapted to keep.

A pleasant social party was held at Geo. Brown's new residence last Tuesday evening in honor of the nineteenth birthday of his daughter, Miss Sarah. Dancing was indulged in until a late hour and a jolly time enjoyed by all present.

Effingham Schieffelin returned from a family re-union at Los Angeles on Sunday, eight children and the old folks enjoying a Christmas dinner together. The family will return here in the Spring, not being satisfied in their present location.

Unimproved land in Jackson county is assessed at \$1.25, improved land at \$5.75 per acre, but the best lands could not be purchased for less than \$30. The new law directs assessors to grade lands according to location and distance from market.

Henry Judge continues to keep one of the largest stocks of harness, and dials, whips etc., ever brought to Jacksonville and sells at a great reduction from former rates. He will not move his store as has been reported and can always be found at the old stand ready for business.

All persons having business with the Clerk or Sheriff, will bear in mind that all fees must now be paid in advance; no amounts go directly into the County treasury. Those officers can not keep accounts with individuals and their fees have to be promptly accounted for.

The Record notes a fatal accident to a lad named Nelson Filkins, aged eight years, in Crescent City last week. The boy was riding on a contrivance similar to a "teeter" when the heavy plank, balanced on a post, struck him on the breast and face causing his death in a few minutes.

Benjamin Higginbotham, who mined on Doorman's creek last winter with Thos. Keaton, has fallen heir to a farm worth about \$6,000 in Tillamook county, Oregon. It is said to have been willed to him by a former sheriff of Tillamook, almost a stranger to Ben, and who had no heirs.

Corlies Merritt has sold his interest in the Ashland Tidings to Mr. Leeds, and although it is now without "merit" the Tidings will continue to be a "leading" paper. Corlies started this week for a visit to the old home in New York and we wish better luck than another voyage on the journalistic sea.

One of our "cane" boys was hauling sand and a few days since with Sargent Dunlap's cart when the horse fell down and was unable to rise. The lad with great presence of mind procured a saw and saved the shafts of this extricated animal. Everyone but the boys father, who repairs damages thinks it a good joke.

Stock depredations in Lake county are becoming so annoying to herdsmen that a movement is on foot for mutual protection. It is intended to offer a sterling reward of \$250 for the arrest and conviction of any person stealing stock or altering brands. It is probable that this tempting bait will induce the thieves to tell on each other.

The two tramps arrested last week for burglary and highway robbery were bound over by Justice Huffer in the sum of \$300 each. Not being able to give bail they are enjoying the hospitalities of the "maison de Bybee," the hotel kept on the American plan by that gentlemanly host, Deputy Sheriff Canon. They may sing "tramp, tramp, tramp the boys are resting."

Ex Governor Woods in an address recently made at Reno, Nev., stated positively that the narrow gauge railroad would have its terminal point at the Columbia (undoubtedly at The Dalles) and that it would be pushed to Linkville and into Rogue River valley. A contract to construct the road from Reno to the Oregon line in the Goose Lake Valley has been let to Col. Moore a prominent railroad engineer of Elizabeth, New Jersey.

J. G. Birdseye has cured the antlers of two bucks that had "locked horns" which he intends presenting to the Order of Red Men. The antlers of the antelope were cut by Frank Smith in the "Sage" where they had evidently perished in an attempt to disengage themselves from their combat proving mortal. They are five point antlers and are finely locked that they can not be taken apart without bowing and are quite a curiosity.

Douglas county is credited by the census report with 189 sheep and 1613 lbs. of wool. The value of the wool and improvements in the county is \$3,897,375 of farm products and \$177,306 of live stock \$668,913. With only one thousand more population Douglas doubles Jackson initial values but with three times the acreage only doubles up in wheat production while we nearly double that country's production of barley. The great source of wealth in Douglas seems to be sheep and pasturage.

Speaking of the mining industry on the coast, the Portland Post remarks: "One of the important industries of Curry county, in the not distant future, be salmon fishing. Chetco, Pistol river, Rogue river, Eucher creek, Elk and Sixes rivers and Flores creek are important streams with view to the prosecution of mining enterprises. Although the fall rainfall far short of the reasonable expectations of the Rogue River Cannery Company, the catch for the year was considerable. Forty-eight thousand were taken, which, worked up, yield nine thousand cases."

he will ignore Port Orford as the point for the brakewater on account of his interest in the metropolis. There is not the slightest danger. Mr. George's views are too broad and he is the representative of the whole State, and desirous of assisting every section of it. The selection of the point for the harbor of refuge does not rest with Mr. George, and his location at Port Orford would not interfere in the slightest degree with the commerce of Portland. The measure is one of maritime safety rather than commercial advantage and the Board of Engineers have already decided that Port Orford is the proper point.

A FARMER'S OPINION OF AMBER CANE.

Mr. P. Dunn, one of the most successful and intelligent farmers of Rogue river valley, informs us that he made an experiment last season with "amber cane" the new variety of sorghum which, notwithstanding little care in cultivation and unfavorable weather was in every way satisfactory. Mr. Dunn planted one acre of cane on rich bottom land, late in May, paying little attention to it until July. At this time he commenced feeding three milch cows from the crop which was continued for over a month, the animals eating it voraciously and increasing largely in their yield of milk. Little more than one half of the crop was crushed, yielding one hundred and twenty gallons of syrup, equal to the best golden syrup ever brought to this market. Mr. Dunn's opinion is that if planted in rich soil or manured and receiving the ordinary care given to corn, this variety of cane will field two hundred and fifty gallons of syrup to the acre and as food for horses and cattle it can not be excelled by any known crop. The gentleman, however, supplements his opinion with the belief that if cane is planted by lazy people, on thin, poor land, that it will not be a profitable crop and that its profit is dependent on the conditions of rich soil and industrious tillage. In connection with this subject we have taken pains to investigate further and find that in Jackson county there is consumed, annually, not less than \$80,000 worth of sugars and syrup and it requires little arithmetic to show what would be the saving to the people if this new industry were pushed. Every family, owning a suitable piece of corn land, should manufacture its own syrup and sugar and by the use of the cheap portable mills in vogue in Iowa and Illinois the expense of the crushing process can be within the reach of any one. Our people may as well understand that they will grow poorer and poorer under the constant drain on their resources and if they would better their condition it must be by their own industry and not importing any thing they can produce themselves.

SUNDAY SCHOOL MEETING.—The teachers, officers and friends of the Union Sunday School, Jacksonville, met at 10 1/2 a. m. at the M. E. Church January 2, 1881, for the purpose of filling vacancies existing in the board of officers of the School. Wm. Hoffman, Esq., was called to the chair, and Dr. Geo. Kahler acted as secretary. The minutes of the previous meeting were read and approved; the constitution and by-laws, under which the school has heretofore been conducted, were also read and adopted.

The election of officers was then proceeded with resulting as follows: Superintendent, Adam Klippel; Assistant Supt., William Hoffman; Chorister, Geo. Kahler; Organist, Ida Klippel; Librarian, Wm. Linn; Treasurer, Kate Hoffman.

The committee who had charge of the Christmas tree festivities presented an itemized report. There were collected \$53.50 and expended \$49.62, leaving a balance of \$3.87, which sum was covered into the Sunday School treasury.

Mr. Merritt was completely surprised and taken aback but responded in his usual pleasant way and then the little visitors enjoyed the hospitality of the teacher and his lady the remainder of the evening. No better reminder can be found of the value of a teachers services than such marks of esteem on the part of his pupils.
