We understand that the work will be begun somewhere in the lowest gap of the mountains, working toward the Rogue river valley.

The Ashland Woolen Mills has over 60,000 lbs of wool on hand at the present time. Next year they propose using the entire crop of the valley.

At the recent meeting of the Board of Trustees of Ashland College, Prof. LaDru Royal was elected Vice President and Professor of Natural Sciences.

McNeal and Deskins have taken the contract for building the new bridge across upper Rogue river for \$350, the county furnishing the iron necessary.

A band of 10,000 head of sheep passed through the valley this week on their way to Lake county. They were owned by the Brumell Bros. of Douglas county.

Ten families from Sonoma county, California, passed through Lake county a few days ago on their way to Eastern Washington territory. So says Sargent Dunlap.

The entire route between Portland and Kalama has been surveyed and staked, ready for the construction of the extension of the North Pacific Railroad.

Justice Huffler's court has been engaged for two days past trying to find some missing chickens. D. C. Courtney is plaintiff and Joseph Lousignout defendant. Trial resulted in finding defendant \$25 and costs.

Hon. B. F. Dowell returned on the 12th inst. after an absence in Portland of three months. His daughter Annie also came home after an absence of three weeks.

On June 4th J. P. W. Davis, living on Eagle creek, 18 miles from Shasta, Cal., shot and killed Isaac M. Johnson. The coroner rendered a verdict of justifiable homicide.

Geo. McDowell Stroud, the popular conductor on the O. & C. Railroad, was elected Grand Master of the Masonic order in this State at the last session of the Grand Lodge.

Anderson Vannoy of Josephine county was in town last Tuesday and favored us with a call. He reports the crops looking fine on Rogue river since the late bountiful rains.

In San Francisco the past few days wool was quoted as follows: Fancy Sonoma, Humboldt and Mendocino, 29¢; choice free Northern, 25¢ to 27¢; slightly defective do, 21¢ to 23¢.

Geo. H. Young is doing the mason work on the foundation of John Orth's new building. The structure will soon assume proportions under the superintendence of David Linn, contractor.

Dr. Dixon, a Sacramento cattle man, against whom the testimony is considered conclusive of killing beef cattle, and mutilating the brand belonging to Arthur Langell, disappeared, forfeiting his bail.

The basket meeting at Central Point last Sunday was well attended. Prof. Rogers speaking in the forenoon and Prof. Royal in the afternoon. A deep interest was awakened on the subject of education.

The Local Capital Company of Coos county have bonded their interest in the proposed narrow gauge railroad route from Roseburg to Coos bay to ex Gov. S. F. Chadwick for a sum not to exceed \$3,000.

The Supreme Lodge of A. O. U. W., lately in session at Detroit, Michigan, has granted the petition for separate jurisdiction, of the Grand Lodge of Oregon a d Washington, separation to date from June 1, 1881.

General Joel Palmer, candidate for Governor against Governor Grover, and at one time Superintendent of Indian affairs in Oregon, died at Dayton, Yamhill county, June 9th. General Palmer came to this State in 1845.

Chauncey Nye, one of the old-time settlers of Jacksonville, but now of Florence Rock precinct, came down from his mountain home on Wednesday to attend to some business at the County Court and to see his old friends.

On June 7th, Father Wilbur passed through Goldendale with seventeen 4 horse wagons enroute to the Malheur agency, to get and take to Fort Simcoe the Indian supplies left there. His drivers were all Indians and the round trip will require some six weeks.—Goldendale Gazette.

The pulpits of Jacksonville were well filled last Sunday. In the forenoon Rev. M. A. Williams preached at the M. E. Church, and at night Prof. L. L. Rogers of Ashland college held forth to a good audience. At the Catholic church Father Blanchet held service both morning and evening.

Sol. Abrams and Simon Caro, of Roseburg, are in town this week, the former to look after mining interests on upper Appleton, and the latter to attend to some other business. Mr. Abrams is accompanied by his daughter, Mollie, and Miss Wheeler. The party returned to Roseburg on the 15th.

The sting of the fly is poisonous. Last week a black fly lit on a finger of Father Reames' right hand having a trifling scab on it. The finger began to pain badly and by night the whole hand was swollen out of all proportion up to the wrist. It required the usual antidotes to neutralize the poison and save the hand.

A number of loose horses have lately been running around the streets of Jacksonville, to the great annoyance of pedestrians. On Thursday afternoon little Sadie Noland who was playing in front of her home, was kicked over by one of the horses. Fortunately the little girl was not much injured. But it might have been much more serious.

On the 17th instant, Rev. D. A. Crowell finished moving his household goods into the building near the Methodist Church on 5th street, lately purchased for parsonage purposes, where the pastor may be found after this. The old parsonage property on California street, now owned by Dr. Jackson, is being rapidly repaired, extended and beautified for occupancy.

Prof. A. L. Johnson's panoramic lectures on Friday and Saturday of last week, at Holt's Hall on the decay of the Chinese Empire, were only moderately well attended. The subject matter was full of useful information, but the people on this coast have ceased to be interested in that phase of the Chinese question. The discussion of the subject how to get rid of them would interest our people much more.

GOT THROUGH ALL RIGHT.—Ladd Savage writes from Boise City, Idaho, under date of June 6th, conveying the intelligence that the Danforth party arrived safely at Boise on Saturday, June 4th, after a journey of just one month. Times were lively plenty of business and plenty of money in circulation. The Wood river country was "booming."

Ladd and Frank Savage were working in the harvest field, Eugene Savage was herding sheep, James Kincaid is employed at blacksmithing and Gro. Howard is employed at the printing office. Dr. Danforth had not yet got into business, but soon expected to start a drug store.

RECOVERING.—From L. Leonard, of Althous, who passed through here Thursday with some horses to Lake county, we learn, that his little daughter who some weeks ago was so severely kicked on the head by a horse, is out of danger and is in a fair way of recovering.

From R. S. Dunlap, our city sexton who has just returned from Linkville, we learn that the authorities of that town have lately set apart for cemetery purposes a beautiful eminence, located about 1/4 of a mile northeast of the village and within a short drive of the hot Springs. The work of removing the dead from the old to the new cemetery was entrusted to Mr. Dunlap, whose long experience at such business is well known. Below is a list of deceased persons reinterred by Mr. Dunlap:

Linnie Ettie Lewis, died March, 1876, aged 12 years; Charles Gaylord, died July 8, 1876, aged years; Mrs. Elizabeth Horton, died June 4, 1875, aged years; Alex Stuckel, died Dec. 25, 1872, 26 days; Alex Miller, died Oct. 31, 1874, aged 43 years; John Dick, drowned May 3, 1876, aged 37 years; Frances M. Dick, drowned May 3, 1876, aged 26 years; Isabel Rambo, died May 17, 1875, aged 19 years; Jesse C. Hamaker, died March 10, 1875, aged 6 months; Minnie Hamaker, died April 13, 1876, aged 6 years.

The following were disinterred and brought to Jacksonville for burial: William Boddy, killed by Indians Nov. 29, 1872, aged 44 years; Richard Boddy, killed by Indians, Nov. 29, 1872, aged 21 years; William Boddy, Jr., killed by Indians Nov. 29, 1872, aged 17 years; Nicholas Shirra, (son-in-law of Boddy) killed by Indians Nov. 29, 1872, aged 27 years. The widow of Wm. Boddy who resides in Tule Lake valley has ordered a \$500 monument of Mr. Record to be placed over the tomb of her ill-fated family.

Mr. Dunlap says he and Mr. Record had a pleasant trip, though, somewhat disagreeable on account of the rain. Whilst at Linkville he visited the "navy yard" at the mouth of Big Klamath lake, and witnessed the "ship on the stocks"—the new lake steamer now in course of construction. Mr. Damon is the master shipbuilder, assisted by a corps of workmen. It is to be a screw propelled, sixty feet long and twelve feet beam, and the capacity of the engine is thirty-five horse power.

Messrs. Thatcher & Worden are the owners of the vessel. The steamer, when completed, is to receive its name from Col. S. G. Whipple, post commander at Ft. Klamath. The citizens of Linkville and vicinity are in high glee at the prospect of soon getting steamboat connection with Ft. Klamath, thirty-nine miles north. Daily trips are contemplated. Joe Beach will be commander of the craft.

Mr. Dunlap says the outlook for a grain and hay crop was very good, also a fine prospect for raspberries, gooseberries, blackberries, and thinks the cranberry and huckleberry culture could be made very profitable in that part of Lake county.

Mr. D. says he had the pleasure of a fine bath at Quincey A. Brooks' establishment at the boiling springs, and says he has experienced nothing like it in all his travels. He also inspected Jay Beach's herd of fine horses. He thinks they are the best trotters in the State of Oregon.
