Railroad News.

It is currently reported that within thirty days there will be a force of at least five thousand Chinese at work south of Roseburg. There are at present over one thousand and all the piling and small bridging is finished to Myrtle Creek and work will soon begin on the large bridge across the South Umpqua.

Admission of Washington.

The Congressional Committee on Territories has recommended the passage of the bill to admit Washington Territory as a state. The bill is amended so as to leave off the portion of Idaho the inhabitants of which desired to be annexed to Washington.

A writer in the Albany "Herald" asks if the Republicans of Southern Oregon desire Mr. Beekman for Governor. We can only answer that Mr. Beekman is the first choice in this end of the State and point to the remarkable vote he received in Jackson county, four years since, as an earnest of his acceptability.

ADVICE-NOT DICTATION.

"The Republican papers have been captured by Congressman George, and contrary to all precedent, they are nearly unanimously at work advocating his nomination. This duty has heretofore devolved upon the convention, but the organs seem to dictate in his case what the convention should do."

The above, from the Portland "Standard" is true, only so far as it points to a unanimity on the part of the Republican press of Oregon regarding Mr. George's re-nomination. The press has not been "captured" by Mr. George but is, so far as he is concerned, merely a reflex of the feeling in the party. There is a general conviction that we have a useful and honorable representative in Congress whose sole ambition is to discharge his trust for the benefit of the whole commonwealth and, thus far, he has been a credit to his constituency.

FREE TRADE OR PROTECTION.

Which is it that the "Oregonian" advocates? "Hot or cold with the same breath" seems to be the rule of that paper and it is somewhat amusing to observe the inconsistencies of its various positions. Drifting with popular opinion it has been opposed to Chinese labor when performed on American soil but demands free trade in all foreign commodities knowing that "free trade" would build up manufacturing in China whose products could and would, if admitted free of duty, drive American artisans to the wall.

Hon. D. P. Thompson, Mayor of Portland, declines the nomination for Governor by a card in the "Oregonian". We know of no other man in Oregon better fitted for the executive office than Mr. Thompson and his services in the Legislative investigation of 1878 should be held in grateful remembrance. The office that he now holds is of equal importance with that of Governor and his own business demands on his time have prompted him to the declination of a position offering no additional honor or involving actual pecuniary loss to the person filling it.

Speaking of the Chinese bill the S. F. "Chronicle" says: "The bill passed the House without amendment, all those offered being promptly rejected. The amendments made in the Senate covered all the points which had been thought weak and doubtful. That extending the time when the law is to become operative to ninety days was a needless concession to corporate influence, but where everything else is so satisfactory we feel little disposition to complain. Grover's provision forbidding naturalization was a wise and thoughtful amendment. It was well to define the term 'Chinese laborers' to mean those skilled and unskilled, and those working in mines. The bill, in the form in which it will go to the President, provides that twenty years after it becomes operative there shall be no immigration of Chinese laborers into the United States and prescribes a fine not to exceed \$500, and a term of imprisonment not to exceed one year, as the punishment of any master of a vessel that shall bring them. From the operation of the law there are only excepted mechanics, teachers, students, travel agents, diplomatic agents, and Chinese laborers who were in the country previous to November 17, 1881, all of which classes must be properly identified by passports duly executed by the Chinese authorities, and countersigned by the representatives of the United States residing in China. It is in form that any friend of California has right to ask, and there is no apparent reason why it should not accomplish all that is expected of it."
