The report of the Census Bureau, containing statistics of the production of precious metals, which was prepared under the direction of Clarence King, has just been published. The report classes California first in the production of gold and sixth in silver and third in the output of both metals. The conclusion in regard to Oregon is as follows: "Oregon now ranks seventh on the roll of mining States in the production of gold, eleventh in the output of silver and ninth in its yield of both metals. The average yield per square mile is \$11.43 gold, 29 cents silver and \$11.72 total. The product per capita is \$6.28 gold."

The "Plaindealer" gives the following account of a distressing accident in Douglas county. That paper says: Tuesday morning last Mr. J. Clarke and Seward Hendricks of Elk Head started out for a hunt. Sometime during the day Mr. Clarke imagined he saw a deer quickly took aim and fired. Immediately he heard the distressing cries of his companion and as the smoke cleared away saw him writhing in agony at the very place where his imagined deer should have stood. The truth then flashed upon him that he had mistaken Seward for a deer and dangerously if not fatally wounded him. He immediately rushed to the boy and attempted to alleviate his sufferings, had him conveyed home to his anxious widowed mother, and speedily summoned Dr. Kaykendall of Drain. The Dr. upon examination found that the bullet, which was a 46 caliber Remington had passed entirely through his right hip and lodged in the left. The Dr. being unable to extract the ball telegraphed Wednesday to Eugene City for Dr. Sharples and H. H. and Robt. Hendricks, brothers of the unfortunate young man. This happened to be an unlucky spot as some three or four persons have met with death accidentally in this locality.

Washington dispatches of the 28th say: Representative George's bill for the payment of \$70,000 to the state of Oregon for Modoc war expenses and Berry's bill for the payment of \$4441 of similar California claims were favorably reported to the house from the military committee to-day and placed on the calendar.

Duplicate bills in the senate by Grover and Farley were reached on the calendar of that body this afternoon and passed unanimously.

The house committee on military affairs have unanimously endorsed Representative George's bill to appropriate \$30,000 for the construction of military roads from Scottsburg to Fort Klamath and \$8500 for a military road from Portland to Vancouver, and have turned them over to the committee on appropriation with this recommendation as a basis for inserting items to be made in the desired appropriation bills.

Shocking Affair.

On Tuesday last Gussie Graves, a stepson of W. J. Magoon, who resides at Mount Vernon, six miles from Kalamia, W. T., while at some distance from the house, was caught by a cougar, which in attempting to carry him off, inflicted injuries from the effects of which the boy died shortly after. The poor little fellow's screams attracted the attention of the family, and Miss Baird, a neighbor who was visiting at the house, rushing to the rescue, first caught sight of the animal; and her cries brought the others to the spot. When the cougar saw Miss B. he dropped the boy and turned to attack her, but seeing the others approaching, turned and seized the boy again and attempted to drag him over a fence. At this point Miss Graves struck him with a stick, when he dropped the boy and walked away growling. Mr. Magoon was in Kalamia when the accident occurred. Dr. Thornton, of Kalamia, was called to attend the little sufferer, and found his skull fractured in three places, the scalp nearly torn off, and an eye and ear torn out. Death kindly put an end to the little victim's suffering. A party of men started out with hounds in search of the ferocious beast, and no effort will be spared to make an end of him. [Standard.]

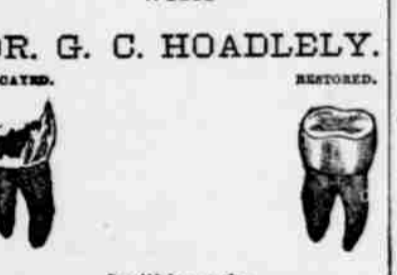

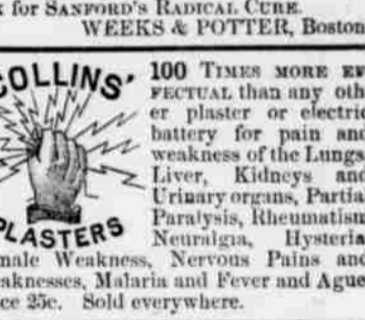
