SUDDEN DEATH.—Frank Ball, one of the earliest settlers of this valley, died at his home on Butte creek yesterday morning from a congestive chill after a very short illness aged 59 years. Deceased came to the valley in '49 and has been a resident here ever since.

THE ENTERTAINMENT.—The entertainment last Friday night passed off with good success some of those present even saying that our amateurs do better than the professionals who pass through here with comedy troupes. To say the least the performers all did well and deserve the praise bestowed on them. The receipts amounted to \$85.

APPORTIONMENT.—School Superintendent Colviguentis the annual apportionment for the year this week, but too late for this issue, and it will appear in our next. The apportionment gives \$1,124 to every scholar in the county. The total amount distributed is \$3,719.25 of which Jacksonville gets \$511.874 and Ashland \$507.374. We shall print the report in full next time.

ACCIDENT.—While at work in his claim near Willow Springs John Ambrose was caught under a cave one day this week receiving injuries from which he died on Thursday evening. He was brought to town immediately but his injuries were such that he was beyond the reach of medical aid and he breathed his last at the residence of Mrs. Conley one week after his arrival here. He was one of the old-timers, and was generally respected by all who knew him.

QUARTERLY MEETINGS.—The second quarterly meeting for Jacksonville circuit, M. E. Church, South, will commence Saturday, March 31st, and continue over Sunday, the quarterly conference meeting at 4 o'clock P. M. on Saturday at the M. E. church in this place. The Third Quarterly Meeting for Ashland and Jacksonville circuit of the Methodist Episcopal Church will be held at Grants Pass on Saturday and Sunday, March 31st and April 1st. The P. E. is not expected to be in attendance.

BUYING HORSES.—E. J. McClanahan and R. R. Hayes of Eugene City have been here for several days past buying heavy draft horses for that market and succeeded in getting all they wanted in this valley. They purchased eleven head in all and paid good prices. Among the lot were two extra large ones which they propose using for hauling trucks, one being purchased from General Ross, weighing 1,560 pounds, and the other from Sam Phillips, 1,440 pounds. They paid \$200 for the Ross horse and \$140 for the other. Besides this they bought six head from Sam Culver at Phoenix, one from John Tepper and one from John DeRoosam, paying good prices for all. Mr. McClanahan started north with the lot yesterday afternoon. W. G. Kenney and D. W. Crosby assisted in leading the stock as far as the terminus of the railroad.

M. Mickelson of Ashland says the "Times" has sold his Percheron stallion "French Boy," by W. C. Meyer's "Gen. Fleury," to M. G. Smith of Bieber, Cal., for \$1,000. The horse weighed 1,600 lbs.

Dr. J. H. Chittwood the well known physician and druggist of Ashland, paid us a short visit this week. He reports times fair in that locality with good prospects ahead when work on the tunnel commences.

Washington Cardwell, an aged and highly respected citizen of Canyonville, died at that place last Friday. Mr. Cardwell had resided in Oregon for 25 consecutive years and was esteemed by the entire community.

A shingle and picket machine are new additions to the Sterling saw-mill, owned by Parks & Son. They have also taken a contract for furnishing some of the lumber for the new Court House building.

About the liveliest place in town now-a-days is the Court House yard where seventeen men are now employed in laying the foundation, excavating and preparing the rock.

Messrs. Jacobs & Russell are laying the foundation while R. S. Dunlap excavates and supplies the rock. A derrick was constructed this week which facilitates operations considerably in the laying of the stone.

John Wolters of the Ashland Bakery was robbed of a large amount of money, several hundred dollars, last Wednesday afternoon or evening. It was stolen from his bakery while he was absent. "Tidings."

Marshal Shultz and numerous assistants had a lively chase last evening in trying to arrest a man. He will be brought before his honor, Judge Webster, this morning to answer the charge of disorderly conduct.

The President has appointed to serve on the Civil Service Commission, created by the Pendleton bill, Norman B. Eaton of New York; J. M. Gregory of Illinois and Judge L. D. Thoman of Ohio. The last is a Democrat and the others Republicans.

Messrs. McClellan, McVay and others are here from Del Norte and Humboldt counties, California, trying to purchase horses and mules for that market. They purchased several head of horses from George Stephenson and some mules from Col. Ross.

At a school meeting held at Foothills creek this week a majority of the voters decided on moving the school house to the other fork of the creek. Twenty-six votes were cast but it is claimed by some that a portion of these were illegal and a contest is likely to ensue.

Wm. M. Turner received official notification of his appointment as storekeeper of the new distillery at this place this week, and as soon as his bond is filed and approved Messrs. Lytle & Co. can commence work making liquor. Operations will likely begin on Mr. Turner's return from Portland.

United States District Attorney J. F. Watson, will be married to-day to Mrs. A. Kinney, of Salem, in Portland. Both parties are well known and have great many warm personal friends throughout the State and are very popular. The "Standard" of the 21st says the wedding will be private and unostentatious.

The new five cent piece is in circulation. It looks just like a \$5 piece in size and general appearance. The edge is not milled and on one side is the letter V encircled by a wreath with the words U. S. of America, E. Pluribus Unum. On the other side is a head of the Goddess of Liberty, thirteen stars and the date. The composition is nickel.

Thos. G. Reames, accompanied by E. H. Reames and family, started for Portland on last Sunday's stage. The former will extend his trip to San Francisco to purchase goods for the company's stores at this place and Linkville, while Mr. and Mrs. Evan Reames will remain in Portland for a short time, where the latter is seeking medical aid.

Miss Addie Langell, a young lady well and most favorably known in this community, departed this life last Tuesday night after an illness that dates from her early childhood. Addie was a bright little girl, beloved by all who knew her, and her death is now the cause of mourning among her many friends. She was something over twenty years of age.

The Portland "Standard" received a call from Mr. J. T. Meade, of Virginia, who is visiting Oregon in the interest of a number of people of his State with a view to coming here, if he finds suitable location. He has been east of the mountains, and now proposes to go to Jackson county. We trust Mr. M. will be pleased with his observations and make a favorable report.

From Thos Orr who returned from below on Friday last, the Yreka "Journal" learns that great preparations are in progress for railroad work, and the talk all round Redding and Shasta, indicates the certainty of from 6,000 to 8,000 men being put to work about the middle of April or the first May, as the weather may permit in rendering the ground workable to good advantage.

The cases of scarlet fever in our own family and in that of Mr. Higginbotham seem to have reached convalescence and no new cases have been reported this week. After having some experience ourselves we most sincerely hope there will be no further cases to report, as all who have seen it will bear witness with us that it is the worst and most treacherous sickness that children can be afflicted with.

Mrs. Louisa Boddy was here this week and accepted the monument placed over the remains of her husband and children, who were killed during the Modoc war. Ed. McGrath of San Francisco supplied the monument in which he shows excellent design and workmanship. Mrs. Boddy has just returned from Washington where she secured all of the claim against the government she asked for.

A number of parties having declined paying the Marshal for his services as night watch it will probably be necessary to levy a tax to raise funds for paying that official a salary. The necessity of such an officer can not be questioned at this time and it would probably be best to pay him a regular salary from a fund derived from a small levy on the tax payers of the town. This mode looks equitable at least and we hope to see our Board of Trustees adopt it.

The "Alta" reports that the work is about to begin with vigor on the extension of the California railroad northward to Oregon. Workmen are being forwarded to Redding in large numbers, and there will soon be several thousand hands at work upon the grading and track-laying. In order to enable the prosecution of the work to greater advantage when spring opened a force of carpenters and masons has been employed all winter in building bridges on the line of the road.

According to the Ashland "Tidings" "the people of Jacksonville have offered to pay the Oregon & California R. R. Co., \$190,000 to have the railroad brought to, or near, their town. A public or private, meeting of the citizens was held one day this week, and a telegram sent to Thos. G. Reames, who was then in Portland, directing him to make such proposition to the officers of the company."

We think this will be news to the aforesaid people of Jacksonville.

Jacob Klippel and Thos. Keaton are still trying to mine on Poorman's creek but are making very slow progress this year—not on account of lacking energy—but for the lack of water. They have gone to considerable expense this season in fitting up a hydraulic for their mines but up to this date they have been unable to pipe more than six hours per week with the water they get in their reservoir. Both are industrious and enterprising young men and we hope fortune will smile more favorably on them hereafter.

R. H. Dunlap, whose death occurred at Lakeview March 5, 1883, was a native of Michigan and at one time was book-keeper for Zach Chandler, U. S. senator from that state. He emigrated to Oregon about fifteen years ago. He was for a time principal of the Ashland school. He came to this county in 1873 where he has followed various avocations. He married a daughter of Mr. J. B. Phelps of Drews valley, and was well liked and universally respected in the community. His family have the earnest sympathy of all in their bereavement.—Lakeview "Examiner."

Immigration to Oregon and Washington Territory says the "Standard," has received a new impetus during the past week. Most of them are practical American farmers. A telegram has been received announcing the departure from Cincinnati of fifty-one immigrants, all provided with through tickets for Portland. They will arrive in San Francisco on Tuesday, and leave by steamer the following day. Sixty-five immigrants at present are in San Francisco waiting for the Sound steamer. Information received states that a party of 84 immigrants, for British Columbia, left Omaha on Saturday and are expected to arrive in San Francisco to-day. A large number of arrivals on the southern route are reported.

The "Astorian" gives us the following information: The March moon falls on the 23d at 1:20 o'clock in the evening. The full March moon plays an important part in the affairs of men. For as she fills three days after the vernal equinox, she determines, in accordance with the law, that Easter shall fall on the following Sunday, the 25th, and Easter in turn determines the movable feasts and fasts of the church. The short time intervening between the vernal equinox and the full of the moon brings Easter this year within three days of the earliest date the festival can occur. In 1818 Easter fell on the 23d of March, the earliest date possible. Such will not be the case again either in this or the following century.

Railroad Items.

Tunnels 4, 5 and 7 are cut through and within about three weeks No. 6 will be opened, so that the track may be laid as far as the big Cow creek tunnel.

Some of the material and tools for the commencement of work upon the Siskiyou tunnel will probably be hauled from the railroad front the first of April.

Work was begun on this side of the big tunnel week-before last. Chinese have opened the wagon roads, and timbers for bridges and trestles are now being hauled for that section.

The general appearance of increased working force and renewed vigor of operations since the winter has passed shows that the company intend to push the work to completion as early as it can be done. The long tunnels will retard the building more than anything else.

From W. A. Smith, who came up from the railroad front this week, the Tidings learn that the work of construction is progressing with the greatest speed possible. New men are being put to work constantly, and the company are still wanting to hire more. Teams are wanted especially. The company have bought many horses since failing to hire teams from this valley, but still want to hire teams and wagons. Mr. Smith says the horse disease has abated, and that he would not be at all afraid to take a team of his own there now.

TRUSTEES MEETING.

An adjourned meeting of the Board of Trustees was held at the city hall last Saturday evening with all the members present and President Linn in the chair, when the following business was transacted:

The President announced the following standing committees:

Finance—Duncan, Judge, Cronemiller.

Public Improvements—Jackson, Judge.

Sanitary—Judge, Duncan.

Fire Engine Fund—Jackson, Cronemiller, Duncan.

Streets and Roads—Cronemiller, Jackson.

Cemetery—Judge, Duncan.

Fire Wardens—Jackson, Schultz.

A petition was received from many citizens, praying that liquor license be fixed at \$250 per annum, which was received and filed.

It was moved that the prayer thereof be granted. Mr. Cronemiller moved to amend by inserting \$200 instead of \$250. The amendment was lost, and the original motion then prevailed, by a vote of three ayes to one nay.

Ordinance No. 77, in relation to the above, was read the first time.

The petition of Chas. Nickell, for the erection of a lamp post at the north west corner of Third and C streets was received and granted.

Petition of Riley & Tyler, for a liquor license for six months, was granted upon payment of \$125 to town treasurer. Bond approved.

The election of street commissioner being next in order, C. W. Cavage was elected as such for one year, receiving four votes to one for J. B. McDaniel.

The Board then adjourned to meet again this evening.

It was not our intention to detract from the merits of other horses in this valley or the enterprise of the owners when we spoke of Mr. Beach's horses as we did last week. We have a number of very enterprising stock men in this valley, who have done much for the improvement of stock in this section, but as they have all differed in the class of horses raised we see no cause for jealousy between them.
