We received a pleasant call this week from J. J. Dickenson, agent for Napa valley wines. Mr. D. will be remembered as an old resident and merchant of Crescent City. He will start for that place next Monday.

Seven tramps were locked up last Wednesday night to prevent them from doing mischief around town and after a hearty breakfast in the morning they started northward looking for work and praying they would not find it.

The following postal changes were announced this week: The name of Thomas' mail postoffice in this county was changed to Spikenard and J. Satterfield was appointed Postmaster. Chas. E. Stratton is the new postmaster at Rockford.

A. Umphlett of Del Norte county, Cal., was here this week on business connected with a stage line from Wadsworth to Crescent City. He purchased R. M. Garrett's stage coach while here and will make his first trip from Wadsworth next Tuesday.

Only \$5,700 was bid for the Jacksonville steam flouring mill property at the Sheriff's sale last Saturday, when Sheriff Jacobs decided on postponing the sale till to-day at one o'clock P. M. This is a good piece of property and should bring a good price.

Under the existing laws of this State, the regular meetings of the Board of Commissioners for the sale of State lands and the management and disposition of the proceeds arising therefrom, are held at Salem on the second and fourth Tuesdays of each month.

Bybee's Kentucky jack, Beecher and his stallion, Ben Ball will make the season of 1883 at the home place near Jacksonville and at Bybee's Ferry. Commencing April 1st they will be five days at the farm and four days at the ferry, continuing so through the season.

Quite a delegation from Ashland paid Jacksonville a visit last Tuesday. Among the number we noticed A. D. Helman J. D. Fountain, W. W. Kenton, H. C. Myer, A. Bish, Henry Emory, and Dr. J. M. Taylor. Most of them came down to attend the regular meeting of Table Rock Encampment, I. O. O. F.

Capt. H. Kelly has returned from Salem and gone to his mines near Grave Creek. The Kelly—Rubie case was submitted to the Supreme court several days ago but no decision had been announced up to the time of going to press. We hope to state next week that Kelly is on top once more—as he should be—in our opinion.

From Byron Cole, in town from the Siskiyou mountains this week, the Yreka Journal learns that the Oregon surveyors are busy at work on the north side of the Siskiyou, and the Central Pacific have just sent a man to make preparations on the California side, to commence work again in the matter of locating the route to be established in making connection at the boundary line.

It has been estimated that from ten to fifteen thousand Knight Templars will attend the Grand Triennial Encampment in San Francisco next summer. The encampment does not meet until August 12, 1883, but in order to secure railroad and other accommodations, the advance guard of the visiting Knights must start from the Eastern states by June last.

The sharp, determined handling given roughs here last year has had a most salutary effect, and has given abundant proof that punishment at the hands of the people is much more feared than at the hands of the law. Not a single murder has been committed for more than fourteen months; no act of highway robbery has been committed, no arson, and but a single case of burglary. Such a record in a seaport town of the importance and population of Seattle, cannot be repeated elsewhere in the United States, Canada or Mexico, and probably not in the world.—"Post," Seattle.

The paymaster of the O. & C. railroad left Roseburg on the 15th inst. and paid off the hands on the southern extension. From Wm. Pittelford, who accompanied him, we learn that all the tunnels are completed as far south as No. 7, which is expected to be finished in about one month. No. 8, the big tunnel, is progressing well and will be through, it is expected, by September next. A large force is being sent into Wolf creek valley beyond No. 8 to grade the road to the Grave creek tunnel. The work in Cow creek valley has been very expensive and the progress has not been as rapid as was anticipated.—Roseburg Independent.

Railroad Matters.

Last week three of our citizens had an interview with Manager Kohler of the O. & C. R. R. in relation to the location of the road through this valley but no definite conclusion was reached and the question of location is still open. The company express a desire to laying the line as near as possible to Jacksonville but expect to be reimbursed, partially at least, for the additional expense as the line will be nearly a mile longer than a straight line through the valley. For this favor our people are quite ready to respond in a reasonable amount and it is probable that before the line is finally located an arrangement will be made satisfactory to all parties. Under no circumstances will the line be nearer to us than the west side of Hanley's Butte and, if it is run there, our people will be perfectly satisfied and feel that it is sufficiently near to subserve our interests and, at the same time be an advantage to the company. Mr. Kohler announced that between the 25th of April and the 1st of May trains would be running to Julia, two miles below Redfield's on Cow Creek, and that freights would be landed there instead of at Redfield. From all information gleaned it is certain that the company intend to encourage our farmers to raise a surplus of wheat by fixing freights so low that a handsome margin will be left after transportation to the Portland market and, hereafter, there need be no complaints of hard times. Graders are being transferred south of the Cow Creek tunnel and the camps at Wolf Creek show much activity. The Cow Creek tunnel will not be finished till July and by that time the grade on this side is to be ready for track laying, probably to Jump-off Joe or Grant's Pass.

Ordinance No. 77, regulating liquor license, was read the second time. The fire engine fund committee was instructed to place note in favor of said fund against McKenzie & Foundry in the hands of an attorney for collection.

Messrs. Jackson, Duncan and Crane were appointed a committee to enquire into the necessity of appointing a night watch, to report next meeting. The board then adjourned to the 31st.

The Chinamen of this place had a grand time last Monday evening, celebrating the event, whatever it might have been, by the burning of over \$200 worth of fireworks and bombs. We failed in finding out just what the demonstration was for but one Chinaman told us that it was the birthday of one of their honored statesman whose birthday only comes every twenty years and he was ninety-eight years of age when he died. CRESCENT CITY NOTES.—Three schooners and two steamers make regular trips between that place and San Francisco. Mr. Hume agrees to deliver freight from S. F. and load it on wagons at Smith River for \$5 per ton and promises to reduce it to \$4 when sufficient freight is shipped that way. Teamsters will charge two cents to this place. The north fork bridge is finished and our merchants can safely ship by this route from now on.

LIBERAL LECTURES.

Dr. J. L. York, the eminent liberal lecturer, has, for the past week, been engaged in the delivery of a course of lectures in Holt's Hall. The scope of these lectures has embraced almost the whole field of the moral, mental and material improvement of humanity. The eminent fairness and impartiality of the Doctor's treatment of this wide range of subjects, made a favorable impression upon all who heard him; while the mastery logic, supplemented by a wealth of illustration, led his large audiences to a deeper and more careful study of the subject in hand, if it did not always result in convincing them of the truth of his teaching. We have not the space to favor our readers with an extended criticism of these lectures. It would be unfair to the lecturer as well as to our readers to point out those parts of his lectures with which we find it impossible to agree, without also giving equal attention to those parts which we endorse. But, whatever one may think of the ideas advanced by Dr. York, no one, who has heard him, can doubt the earnestness of his belief or the honesty of his purpose in every sentence that he utters. The field of liberal thought is the broadest and most beautiful region yet explored by the human intellect; and if the philosophers who labor in it sometimes pluck flowers too rare and beautiful for this every day life of ours, we are all the better for seeing and studying their beauty. Whenever human reason, extended in whatever direction, fetches forth a fact, it has done a great work in the elevation of the world and the advancement of humanity, no matter what system of government or religion it may unsettle or uproot. A man who shudders at the sight of a fact, or who flinches from the utterance of what he believes, is a coward. Next to the man who discovers truth, is the man who publishes it abroad to the world and thus sets to work the mental processes of the people with new impulses and purposes, and in new directions. This, to some extent at least, Dr. York has done by his course of lectures here. He has set people to thinking, and in this he has done a good work and we thank him for it.

Obituary.

On the 20th inst. Addie, third daughter of Nathaniel and Loretta Langell, was called from her relatives and associates by that mysterious power which all must obey; and the cheerful and loving voice of one who clung to mother and father, sister and brother, with passionate tenderness is hushed. Silent, yet its sweet echoes will linger forever in the hearts of those who loved the patient child who, for a whole life, struggled with a burden that was at last too heavy, and that entailed her to a more than ordinary share of affliction. Addie was a peculiarly bright young lady, rarely gifted, a favorite among her associates, and a life-long and incurable physical affliction, borne with hopeful patience, and a disordered her kindly and affectionate disposition. We call Death cruel when he crushes the tender bud, or the opening blossom, but, when he throws open the portals of the Eternal, leads the weary feet to rest and brings peace to the suffering, he should be called merciful. Poor gentle Addie! When his hand drew aside, for her, the veil of the Infinite, it was that she might exchange loads and sorrow for sunshine and peace, and the rest that the restless only find when they rest on the robes of immortality. Addie should not be mourned, but be remembered as one whose gentle and patient resignation won the love of all who knew her; and they should rejoice to know that the heart that so wildly throbbled and suffered there are none but thorough roses.
