The Oregon & California Railroad Company's statement for January is as follows: earnings, \$82,400, expenses, \$61,300—net earnings, \$21,100. Expenses include about \$10,000 for month's traffic during the month was much interrupted by storm.

Report says that J. H. Huffer is likely to succeed in introducing his device for making channels in shallow rivers, the Portland Board of Trade considering it with favor. We hope to hear of his making a success of the invention, which appears to be a good one.

According to Wel's, Fargo & Co's circular, the value of metals produced in 1882 west of the Missouri including British Columbia, Alaska and the west coast of Mexico, amounted to \$92,311,835, divided as follows: Gold, \$30,193,353; silver, \$50,155,288; copper, \$4,053,037; lead, \$8,008,155. This includes only what passed through the company's hands.

Mrs. Barnes claims that her husband beat her and threatened to kill her father that day, and in order to save her father's life she sacrificed her husband's.

A San Francisco dispatch of the 2nd inst. says that Senator Dolph is at the Palace, and leaves for Portland to-morrow. There has been a good deal of sickness lately, some of which are quite critical.

Much produce is being hauled to the railroad at good prices, but the greater part of the produce is away and what is left is bringing good prices.

A Wimer has made quite an improvement in his saw mill, and is getting just as good lumber as ever.

It is true Strong cannot get much more wheat down here but what flour he makes cannot be excelled in southern Oregon.

Applegate is navigable for a pretty good sized boat, for last week a fat boat run by four men was launched here and is now on its way to the coast—object, prospecting.

Applegate has been fordable all winter, and the recent rains have not raised it one foot, for the ground took up about all the rain that fell so far.

Everybody is so busy putting in spring crops that news if any is entirely absorbed at the present, but shortly I think much can be gathered.
