FOR THE AY-UM.—Suehah, son of Jacob Mills of this place, was examined by Drs. Robinson and Vrooman and admitted to the insane asylum at Salem this week. He has been an inmate of that institution before.

LARGE STOCK SALE.—John Fairchild of Klamath county this week sold 1,000 head of horses and 1,000 head of cattle to parties from below for \$75,000. The price paid for the horses was \$45 per head and the cattle about \$30 per head.

SETTLEMENT.—Those indebted to Dr. Aiken will please settle as soon as possible. And to those especially, who are seemingly indifferent whether their bills are ever paid or not, he could say, that if they are not settled in full by January 1st, he will not stop to say please, but put the accounts into proper hands for forced collection.

FOUND GUILTY.—On the 26th of last month a lot of washing was stolen from Mrs. J. M. Smith's clothes line and Thursday afternoon Michael Spahn was arrested and convicted of the crime in Justice Huffer's court, receiving a sentence of ninety days in the county jail. The sentence seems a heavy one but is no doubt justly deserved when the facts of the case are considered.

BURGLARY.—The store of C. Magruder at Central Point was entered last Friday night by some party unknown and the till robbed of about \$700 in cash. \$75 of this amount belonged to Wm. Tyler and the balance to the proprietor of the store. About \$100 was left in the till, evidently overlooked by the robber, belonging to parties who had left it there on deposit. No clue has yet been found.

HOUSES AND MULES WANTED.—Captain G. C. Smith, of the quartermaster's department, First Lieutenant J. Q. Adams, first cavalry, and First Lieutenant G. B. Backus, first cavalry, are consigned a board to inspect and purchase horses and mules for the service. The board will meet in Portland on the 15th of December, and will proceed to such localities in Southern Oregon as may be necessary for the purpose. The board will remain in session until the requisite number of animals are secured.

THE NEW TOWN.—Chas. J. Howard and party finished surveying and laying out the new town opposite Jacksonville making eighty two blocks out of the place. Two blacksmith shops—one owned by G. W. Wilfred and the other by Geo. W. Crystal—have already been erected and ready for business. J. S. Howard, and Henry Smith of Wolf creek, will open branch stores there and Wm. Egan proposes starting a livery stable. Mr. Howard and party started for Chavner's bridge this morning to survey the new town at that point with instructions to lay out thirty four blocks. After this they go to Phoenix where another new city of eighty blocks is to spring up. Jacksonville county will soon be well supplied with new towns.

It is believed that the warfare between Indians and whites can be ended by judicious measures. Secretary Teller recommends permanent reservations commensurate with the numbers of the tribes, discontinuance of cash annuities and the establishment of manual labor schools for the young. He urges that white adventurers be imprisoned for attempts to invade the Indian territory.

The book peddler Jenkins, from Eugene City, Ogn., who is somewhat deranged, has been in jail for over a week past, his actions rendering him unsafe to be at large. He does not seem to improve, and has not had any sleep for a week, although Dr. Robertson has been doing everything possible to improve his condition, expecting he might recover and obviate the necessity of sending him to the lunatic asylum.—Yreka Journal.

A correspondent of the Statesman says the first through passenger train reached Grants Pass Saturday night. About 300 people were there to welcome the iron horse and record another march forward. On Sunday the new terminus was filled with people, the saloons were running in full blast, there was a display of tight rope walking, a faro game, bucking farmers were hauling wood, and the sound of the hammer on new buildings added to the indications of business, making a lively week-day for Sunday.

The track will be finished to Rock Point this evening but no change of terminus will be made until the road reaches Ashland. A night shift has been placed on the heavy road work at Gold Hill so as to have it finished when the track layers reach that point. The road is expected to reach Ashland early next month. The passenger train going north leaves Grants Pass at 10 o'clock P. M. and the one coming from Portland arrives at the terminus at 12:30 A. M.

A half a dozen tenement houses here on short notice. A shoemaker, a blacksmith and butcher could make money here. Water is very scarce, which is very unusual at this time of the year. Wimer & Sons are running both their giant and night. The Haskins Bros. giant is well liked. Another locomotive head light has been ordered for this mine to be used with the giant. Bybee & Co. have run but little so far. Dossell & Co. have not started up yet. James Lytle got on a big "tender" a few days ago and lost his money which the Villard Co. paid him for his copper. After hunting in vain he called one of his friends to his assistance who found the bag; a little later the horrors came on him again and he lost it a second time; this time the friend found the box under some rubbish, untied and spilling the twenties out. Miss Mary Felely's school gives the best of satisfaction. There will be a Christmas tree here, (Monday the 24th) in the evening and a ball on New Year's. Mr. E. B. Hays bought the old Hartson place and says he comes here to stay. He has built a new house. Bennett's mill runs right along. The wagon road here has not been closed with snow as was reported. BOARD OF TRUSTEES.—The following is the substance of the business transacted by this body at two called meetings held this week. The semi-annual report of Sexton Dunlap was accepted. Fred Grob and Wm. Healy were granted liquor licenses for six months. President Linn was authorized to sign the name of town to contract for construction of certain cisterns, which was done. Report of President Linn, relative to the fire fund, showing \$41 31 balance on hand, was received, and was ordered to pay same into the treasury. D. Crone miller, and L. J. C. Duncan were appointed a committee to purchase pipe to conduct water to cisterns. Bilger and Maegly were awarded contract for furnishing said pipe at \$647. Special committee on water pipe authorized to purchase fifteen feet of suction hose for fire engine. Report of committee on improvements recommending the accepting of cisterns was adopted and a warrant for \$400 ordered drawn in favor of G. W. Holt. Bill of G. W. Holt of \$50, for extra work on cisterns, referred to finance committee.

RAILROAD NOTES.

WOODVILLE, Or., Dec. 5, 1883.

The track was laid across Evan's creek Monday evening just at dusk. Tuesday morning about a thousand feet more was laid, when track laying was suspended, the supply of rails and ties having run out owing to the non arrival of the construction train at the front Monday evening, as expected. The opportunity, however, was not to be thrown away; so, although it was the fourth of December, quite a number of the boys resolved themselves into a committee to hold a fourth of July celebration, which resolution they carried out with commendable zeal, not forgetting also to mix also a fair share of St. Patrick's day performances with the entertainment.

Tuesday afternoon the construction train loaded with material came up from below, and about half past three o'clock, it moved slowly into Woodville, the first railroad train in Jackson county south of Evan's creek. I have ridden many thousand miles on the cars, and have seen perhaps tens of thousands of railroad trains, but I never looked at any train of cars with the same interest as I did at this, nor, indeed, with anything like the same emotions as those with which I gazed upon the first train standing on the banks of Evan's creek. Old settlers, or those of us at least who came here before the war, can appreciate one's feelings in this respect.

Rails and ties, however, were quickly dumped off, and the train left us again—not, however, "alone in our glory," for the track layers were here, and the fourth of July celebration, or literary entertainment, which ever it was, was renewed with apparent determination to see the thing through in good style, and was carried on with no lack in variety of incident far into the small hours of the night, greatly to the delight, perhaps, and certainly much to the edification of our more peaceable citizens.

Track-laying was resumed this morning, road master Waite being on the ground to see after things, as the force was somewhat demoralized by the events of the preceding evening.

The construction train came up again this evening, and passed on to the end of the track, which is now about one mile south of this place.

The train has gone back again, and the long "Jed" for event has come to us,—trains are passing daily each way.
