Senator Sherman's resolutions to inquire into the murders in Virginia and in Mississippi was passed without debate. The Democrats concurred, and came out with a finger on the lower lip—mum's the word. They were entirely right, keep dark and his low is the best hold.

It is understood that a syndicate of American capitalists have made the Canadian Government an offer to take the Canadian Pacific Railway and complete it without further Government aid. The syndicate also agrees to give up the monopoly privilege and pay a duty upon their material.

Frightful floods are prevailing in Ohio, Pennsylvania and Kentucky. The waters in the Ohio are higher than last winter. Much suffering and loss of property has been entailed upon the people of Cincinnati, Covington, Newport, and other points. Relief from the country is urgently called for by local committees.

We desire to call the attention of that patriotic and virtuous south which is now attempting to get possession of the federal government to the facts that one Vincent, who robbed the state treasury of Alabama, is still at large, and that one Polk, who performed a similar service by the state treasury of Tennessee, is also wearing the clothes of a respected and honorable citizen.

The Senate has passed a bill directing the secretary of the treasury to pay Mrs. Louisa Boddy of Oregon \$5,400, in full settlement of her claim against the Government for depredations committed and property taken and destroyed by Modoc Indians, in November, 1872. The Boddy family settled on public lands in Oregon, and were among the first victims of the Modoc war. The husband of the claimant, her two sons and son-in-law were murdered, and their property taken. For this she put in a claim, which the Senate voted to allow.

The Atlanta "Constitution" says that the Republican party has never made a campaign in the south, and that the south will remain solid as long as the Republican party is in power. That is the trouble in the south. There is no real issue, and the opposition to the Republican party is merely a tradition, strengthened by social prejudice. If there were a real issue between the two parties, the tariff, for instance, there would be an opportunity to overcome the old prejudice and induce those who think alike to act together.

What State grows the best wheat is a question not easily answered, because there are different qualities of flour, and different kinds of grain are used to make different kinds of bread. We were lately told that Minneapolis millers discard our wheat as lacking in gluten, while their Minnesota wheat they say far exceeds ours in true bread making qualities. Our wheat is soft and there is flinty and hard; ours is white and theirs is red; the difference in the flour is very perceptible. Western Oregon wheat is much sought after and commands in England even a higher price than is paid.

NOT WANTED.

While the Eastern press is agitating the question of restricting immigration of the most shiftless class of foreigners who come to our shores with no means and with vile and vicious habits, it would also be well for journals of the northwest to be careful how they hold out inducements to the same shiftless kind. Our population is continually being augmented, and we must expect to receive some of the shiftless as well as the industrious classes who are seeking to better their condition by moving farther west. The pauper immigrants who land at Castle Garden do no all stop in the East, but a great many of them take the railroad line to the far west. These are very undesirable, as they are not producers, and are not sufficiently industrious to make homes for themselves.

We have all the natural resources of a rich country, and by means of labor and economy any one can make a livelihood and in time acquire a competence. But there is a certain class of men who hold as their gospel that the world owes them a living, and to be orthodox they never consider themselves indebted to society for anything they receive. To such, the Pacific Northwest is not a desirable location. It will be better for them and for us that they do not come to Oregon. We have room only for workers, who expect by habits of industry to help themselves, and in so doing aid in developing the country. We have rich, unoccupied lands, for the agriculturist, and opportunities for mechanics and artisans. To men of capital, no place offers better inducements than the Pacific northwest. We have the resources of an empire, and only need development to take the rank that nature has destined we should occupy. Among our population we number some of the sturdiest toilers, and we desire no commingling with a worthless element.

Those who dream that coming to Oregon insures them wealth without arduously working for it, should dispel such silly notions. Fortunes are acquired here, as elsewhere, by toil and economy. There are no twenty-dollar pieces "lying around loose" which can be picked up without the least effort; money represents labor, and is only given in exchange for value received. We have less poverty than in the crowded east, and more room for laborers. In our early history, fortunes, in many instances, were accumulated quickly; but that era has passed, and now but few, if any, opportunities present themselves for the sudden acquisition of wealth. Our citizens must gain a competence by the products of the soil or by honest labor at the mechanic arts. To the farmer, mechanic and laborer, we offer good lands and little competition in the labor market, and to these we give every encouragement to come and make their homes with us; but to the lazy or vicious, we have no words of welcome. We have a full supply of these; in fact, if it were not for the penitentiaries and vigilantes, our country would be overcrowded. Honesty and industry are usually successful; and vice and laziness are punished. If the immigrant possesses the former, let him come; if the latter, he had better stay at home or go elsewhere.—"Times Mountaineer."

Free Postage for Newspapers.

Hon. A. M. Dockery has introduced a bill in congress granting the freedom of the mails to newspapers, to take effect June 1st. The question has called forth a great deal of discussion from the press. It has its supporters and its opponents. By the latter, in some instances, it is argued that it is a "poor newspaper which cannot afford to pay its postage." This view of the matter is peculiarly simple, in our opinion. The amount of postage is so small that any publisher can pay it. If his list is small the postage is also small. We think the press makes no concessions by asking Congress to place newspapers on the free list. The franking privilege is allowed on pound after pound of public documents, which are never read and which are of little benefit to the masses. Yet a newspaper, a necessity, a disseminator of news which is of value to the people, a promoter of intelligence and prosperity is charged for each pound. It is not the amount involved but the principle which we contend for. The "back pay" congress is responsible for this tax and we think it is among the things which should go. We hope our representative will lend his support to this bill and assist in its speedy passage.

His excellency, the Governor, has made proclamation that the amendment to the State constitution, granting women the right of suffrage, will be submitted to the legal voters of the State for ratification or rejection at the general election, to be held on the 2d day of June, 1884.

Rev. Talmage, the man of graceful (1) gestures, hit the nail square on the head when he said: "One of the greatest trials of newspaper men is that they are compelled to see more of the shame of the world than any other profession. Through the editorial and reportorial rooms all the follies and sins of the world are seen day after day, and the temptation is to believe in neither God, man nor woman. It is no surprise to me that in this profession there are skeptical men. I only wonder that journalists believe in anything."

Two passages in Beecher's eulogy of Wendell Phillips delivered in the Plymouth church, which will live along with the popular memory of Mr. Phillips, and which deserve to live, are here quoted: "He confronted the spirit of the nation and the spirit of the age as if he had been a decree of God, overriding all things." And, "He was not a man that tempted himself upon an orchestra of a hundred instruments. The nation slept and God wanted a trumpet large, wide sounding, intense; and that was Mr. Phillips."

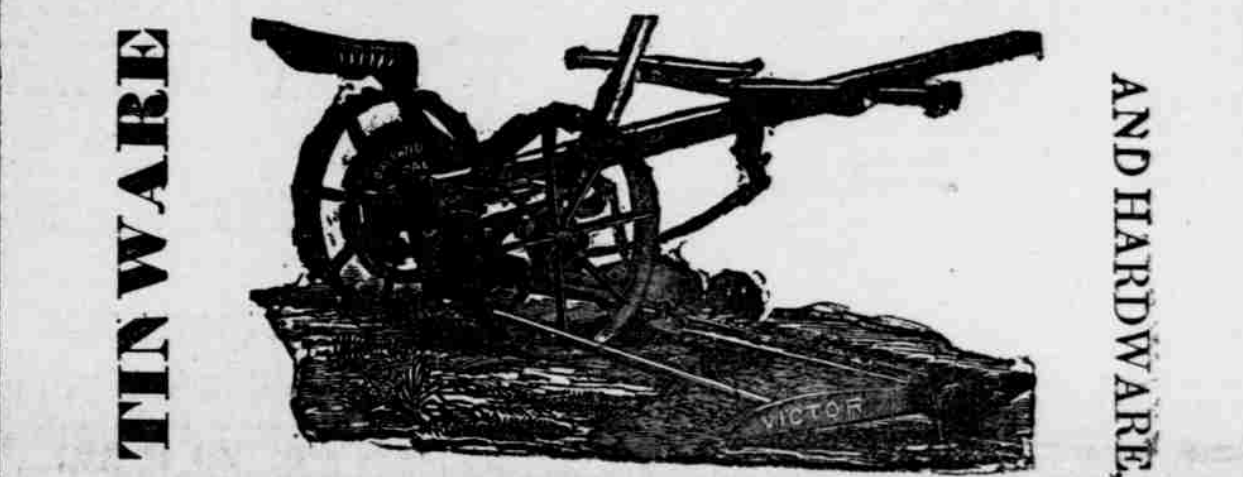
