J. C. Whipp has gone to Crescent City to do the stone work for the Del Norte county court house and R. S. Dunlap will attend to his business here while R. M. Shelly will conduct the work in his shop.

The road from here to Medford is in fine condition and it is a pleasant drive out there in time to see the train pass in the evening and get a splendid supper at the Empire Hotel which is kept by J. W. Cunningham.

Wm. Angle, of the firm of Angle & Plymale went to Portland on Tuesday to purchase good for their house. Their business is increasing so rapidly that they will soon have to enlarge their place of business.

During the celebrations at different points in the valley excursion trains were run between Grants Pass and Asland and it seemed as though the railroad company could not get cars enough to accommodate the people.

The Medford people complain that there is great injustice done them by having the mail carried by Phoenix instead of direct to Jacksonville that it delays their mail that goes by the Crescent City route sometimes several days. Also letters intended for Jacksonville are necessarily a day later. They should have equal mail facilities with the rest of the world and there is no doubt but the matter will be straightened if brought before the proper authorities.

The new commissioners say it was a big campaign for about building a bridge across Sam's creek but an actual fact and one that can't be rubbed out that they intend to build one across Rogue river—So there now.

About sixty persons from Asland and Northern California arrived here last week on a visit to this city. They form a private excursion party and will remain several days seeing the sights of the city.—Portland "News."

W. H. Byars of Medford and J. C. Whipp of Jacksonville left for Crescent City this week, having subcontracted the stone work on the new court house there; they are both first-class workmen and will give entire satisfaction.

There was an unusually hard fall of rain in Manzanita precinct last Sunday, although none fell at Jacksonville or Medford. It knocked down some of the heaviest wheat, but one of the substantial farmers of that precinct says there is plenty left.

John Witjen an old time resident of Jacksonville returned home this week. He has been on an extensive tour through Europe and the United States but finds his old home in Jacksonville the best after all. He will probably stay some time with us.

Iowa reports a corn crop thirty per cent. larger than last year, and a wheat crop fully as large. But the dispatches this morning say the prohibition law has closed out nearly all the saloons, leaving nothing but cold water to irrigate the thirsty harvesters with.

Dr. Whipp having recently purchased a neat and nobby one horse outfit it is better than ever prepared to attend professional call, and besides that is the boss marble man in this part of the state and can erect monuments over his patients at reduced cash rates.

The fourth of July excursionists to Portland have returned and report having had a splendid time. There were a great many people there some say at least fifty thousand. The liberal discount railroad fare had much to do with increasing the multitude that witnessed the celebration there.

L. S. P. Marsh who received the contract for building the Crescent City court house left here this week with a good force of carpenters and the structure will be commenced immediately after their arrival. J. C. Whipp and W. H. Byars will also go down to do the stone and brick work.

Wm. Egan of Medford is the boss stable keeper for a big crowd. On the 4th he filled his stables and all the sheds and yards full of horses and when there was no more room to tie in that vicinity he politely offered to hitch teams out in the suburbs and see that they were watered to oblige his customers.

J. W. Cunningham of the Empire Hotel at Medford was robbed of \$87.00 last Saturday night. Having left that amount in his pants when retiring and the next morning his pants was found in the street with the pockets empty. He may be very thankful to think that the robbers did not take the pants.

District Attorney Kent returned from Kerbyville on Tuesday where he had gone to be present at the preliminary examination of Martin Mackie and son William Mackie held for the murder of Mike Purcell. The coroners jury committed Martin Mackie without bail and placed William Mackie as an accessory under \$500 bonds.

It is the opinion of many that artesian wells could be made a success in a portion of our valley called the desert. Though there are several gardens and orchards on this land that does well water would be of great service generally and persons having land in this desert will give from twenty five to one hundred dollars towards a trial well.

Thos. E. Nichols who has been the Assessor of Jackson county for the past four years visited Jacksonville Thursday. He came over to appoint a deputy to assist in the completion of his work which he says will take two months. Mr. Nichols has made a good officer and is in every way a first class gentleman, all right except his politics.

John Bonham, an old time resident of this place, was examined on last Tuesday, by Drs. Aiken and Robinson before Judge DePeatt, and adjudged insane. He has been an invalid for several years past and for some time an inmate of the county hospital. When examined he was erratic and delirious though apparently perfectly harmless; he was taken below by J. H. Huffer on Tuesday last.

From a prominent citizen of Eagle Point we learn that there came near being a serious shooting scrape in that vicinity last Tuesday evening in which a woman was the prominent actor. From his account of the occurrence it seems that an old gentleman who resides near Eagle Point had business in Lake county and left the premises in charge of his daughter and a hired man. The conduct of the hired man was not satisfactory to the lady and she paid him off and discharged him. He returned the next day and was ordered to leave the premises which he refused to when the lady drew a pistol and fired at him, the ball passing through the rim of his hat and the powder burning his face badly. The District Attorney Kent was sent for but the case will probably not be investigated.

Our new judge DePeatt entered upon the duties of his position on Monday last with the confident air of a man who fully understood the duties and responsibilities of the office. There was considerable local objection to Mr. DePeatt but never any personal—as a man he was always spoken of in the highest terms and he will no doubt fully satisfy public expectation and make a good judge.

Coles Circus which gave an exhibition in Asland on the 5th of July drew a large crowd from all parts of the county. All those who witnessed the performance speak in the highest terms of it, and are especially well pleased that everything promised on their large hand bills was faithfully performed something that has never been done here before. It is the best show of the kind that has ever come to this part of the country.

There was a most brutal murder committed in Willow Springs precinct on last Saturday night. The victim was George S. Smith, who was living on the old Ambrose place. He was found dead in a barn near by terribly bruised and mangled. Suspicion pointed to a neighbor John M. Culp who was immediately placed under arrest, he had a preliminary examination before Justice Huffer Thursday and was placed under \$1,000 bonds which he failed to give and is now in jail. Smith had a wife and family of 5 children and Culp has a wife and two children.

The new county officers entered upon the duties of their various offices on Monday last. There is an entire change with the exception of Judge, District Attorney, Sheriff and Constable for this precinct. Whatever sectional political feeling may have entered into the contest before the election seems to have passed away and the new officers were warmly welcomed as though they had been elected by the entire vote of the county. There are three Republicans elected in this largely Democratic county Judge, Representative and Constable for Jacksonville and the SENTINEL feels as though it had some victory of which to feel proud.

Mike Colwell, an old and respected citizen of Jackson county, died on Thursday, at 6 A. M., aged 56 years. Mr. Colwell had the misfortune to lose his wife to whom he was very much attached not quite one year since and has been in low spirits until stricken down by his last long and painful illness. He has been a resident of this county for over 20 years and was married here. He had accumulated quite a competence by his energy and industry and leaves many friends to mourn his loss. The funeral services were conducted by Rev. Father Blanchet, the fire company attending in full uniform, Mr. Colwell having been a member.

A SAD BEREAVEMENT.—We take the following sad news from the "State Journal" of Eugene City. The parties will be remembered as brother and sister of T. L. Skaggs who for some time was railroad operator at Grants Pass and Phoenix: Miss Lulu Skaggs, daughter of Mrs. Skaggs, of this city, and niece of H. T. G. Hendricks, was teaching school four miles west of Cottage Grove. She was taken sick and died of inflammation of the bowels and stomach, after an illness of four days, at the residence of R. H. Hazleton, on Friday, June 27, 1884, aged 17 years and 9 months. Her mother and other kind friends were summoned and did all in their power to make her dying hours as peaceful as possible. The students who had been attending her school visited her during her sickness, and their innocent, tearful eyes told how truly they loved her. She was in every respect an intelligent and worthy girl, highly esteemed by all who knew her. The remains were interred at Pleasant Hill, June 26th.

The procession and attendance was one of the largest ever seen at a funeral at that place. The old saying that misfortunes seldom come singly, was again verified. In the midst of her grief, Mrs. Skaggs received a telegram stating that her son, Elsie B. Skaggs, had been killed by a railroad train at La Grande, Oregon, while acting as brake man, June 30th, 1884. He was 22 years and 5 months old. He was an excellent young man, and his sudden death is a terrible shock to his mother and other relatives and friends. His remains were brought here by the railroad company, and were buried at Pleasant Hill, July 3.

Many of the most exquisite monuments have been erected by Whipp & Dunlap, some of which, chiseled from Italian marble and lettered with artistic skill, would be ornaments to any "silent city" in the world. The justly created by J. C. Whipp over the yet fresh grave of the lamented wife and babe of Prof. Merritt is eloquent silence, speaking through its symmetry and the delicate lines of its exquisite drapery of the purity and perfectly rounded character of her whom we all know so well, and a visit to it makes one wonder how the cold marble can be so endowed with an inexpressible expression. In the yard of Mr. Whipp, just north of town, can be seen an elegant monument, just finished, and soon to mark the resting place of Mrs. Joseph Sattfield in Sam's valley; also another, chiseled from Vermont marble with artistic taste, bearing the names of three of the children of Mr. and Mrs. Thomas Curry, and to be erected in the same locality. Some of this work is imported, without lettering, but the largest part of Mr. Whipp's work is done here by skilled mechanics and equally as well done as it could be elsewhere. We hope to see this branch of business prosper, as it employs quite a number of good citizens whose earnings add to the wealth of the community and whose labor is adorning the quiet resting place of loved ones and keeping their memories from fading away by associating them with the beautiful. A visit to Mr. Whipp's establishment will well repay the trouble and will give a better idea of the amount and superior work he is doing than anything we can write. We will only add the remark that Mr. W. is deserving of much credit for his enterprise in building up a home industry that will fully satisfy our people's patrons, while saving them money and keeping wealth at home that has heretofore been sent abroad.
