Southern Oregon is probably more suitably adapted for fruit growing than any other part of the United States; that is, when the vast variety is taken into consideration. A gentleman who arrived in Portland a day or two ago, after having spent nearly a year in the southern part of the State, related an instance to a "News" reporter, which is certainly very flattering to this country. Joseph Dowden owns a farm at the junction of Sau's creek and Rogue river, where he has resided for over fifteen years. Seven or eight years ago he planted a variety of young trees, consisting of cherry, peach, two varieties of plum, pear, apricots and almond, and several varieties of grapes. He did not plant them in regular order, according to the variety of fruit, but scattered and mixed them, the entire assortment covering considerable ground. The gentleman referred to saw the orchard last year and says that the fruit came nearer to perfection than any he had ever before seen. Mr. Dowden's place is thirteen miles from Jacksonville, and the entire surrounding country is one continual orchard, and the fruit is in excellent condition. During the winter Mr. Dowden has had the orchard, he states the trees have not been injured by insects, and the crop of last season was simply a repetition of those of the preceding six years.

The Portland "News" says that suit has been commenced by the State of Oregon against Multnomah county, in the State Circuit Court. The suit is to be decided without controversy. In the complaint, the State of Oregon claims that the county of Multnomah is indebted to it in the sum of \$6,209 86, with interest from the first Monday in April, 1884. In 1883, the tax levy for State purposes in Multnomah county was \$98,857 38, and for county purposes \$176,531 05. The State estimate was transmitted to the State Treasurer, and placed in his books as evidence of the indebtedness of the county of Multnomah to the State of Oregon. Through an injunction suit, double assessments, etc., only \$92,647-51 was collected of the tax due the State and only the same proportion of the county tax also. This left a deficit of \$6,209, 78 still due the State on the face of the levy, but though the Sheriff made a diligent effort, he has been unable to collect this balance. It is admitted that the State got its pro rata of the taxes as collected, but the question is to be carried to the Supreme Court, in order to settle the question as to whether a county has to pay the full face value of the tax levy, or the regular pro rata of the amount collected. There are several counties which occupy the same position on this question as Multnomah, and it is proposed in the present instance to make a test case.

State Fair Races.

The managers of the State Agricultural Society have received the following entries for the races to be held at the Fair in September. Trotting races—2.50 class, 9 entries; two-year-old class, 9; 2.40 class, 7; 2.30 class, 7; three-year-old class, 3, which lacks one of filling the regular number for the class. This makes a total of 35 entries for trotting races. In the running races there have been 49 entries, as follows: For the introductory scramble, 12 entries; one mile dash, 11; five eighths dash for two year olds, 7; one and one quarter mile dash, 9; special purse for two year olds, 7; which lacks one of filling. This makes a total of \$1, and the committee think the entries will reach 100, as others have been made, but not paid for. The committee will allow races to be run as advertised, deducting from those not filled.

SAN FRANCISCO, June 9.—In regard to the discharge of engineer corps on the Central and Southern Pacific railroads, General Manager A. N. Towne says that the force was laid off on the score of economy, as no road building is being done. Repairs, which have heretofore fallen under the direction of the staff of engineers, will be done by other employes of the road. All work on the California and Oregon has been suspended, and will not be resumed again for some time.

From the fact that some of the congregation of Dr. Sutherland's church in Washington City took exceptions to Fred Douglas renting and occupying a few directly in front of the church, it would appear that the church is not entirely obliterated at the national Capital. The pastor, Dr. Sutherland, cordially greeted the representative of the colored people of his service.

The finance committee canvassed the town this week and raised near \$300 by subscription which will yet be raised considerably when those of our citizens return, who are now absent. As the band has offered their services free it is the intention of making everything else the same, thus making it a free celebration, free dinner and a free dance at night. The money raised will be expended in fireworks, for the purchase of prizes to be distributed by the amusement committee and such other expenses as will naturally be incurred in making this the grandest Fourth of July celebration ever held in this end of the State. A cordial invitation is extended to everybody to come and enjoy the celebration.

The Secretary has received from the Board of Managers of the World's Industrial Exposition at New Orleans a statement of their indebtedness, of which the following is a recapitulation: Undisputed indebtedness, \$253,355; disputed indebtedness, claimed, \$105,387; rejected, \$72,752; admitted, \$77,585; premiums, \$66,388; total of claims, \$397,318; appropriation, \$335,600; difference, \$62,318.

The President appointed, June 3, Herbert Foote Beecher, son of Henry Ward Beecher, to be collector of customs for the district of Puget Sound at Port Townsend. This and the appointment of Phelps Minister to England, pays Henry Ward Beecher well for his political services in the Presidential campaign.

The debt of the United States, less cash in the Treasury, is now less than fifteen hundred millions. In July 1866, it was more than twenty-seven hundred millions. Almost half of it has been paid within nineteen years. At the recent rate of decrease less than nineteen years more will be required to pay the rest of the debt.

When Congress meets next winter, one of the first things that a Republican Senate will probably do will be to elect Gen. Logan pro tem President of that body, and when Mr. Hendricks is absent our ought to be Vice President will sit where the people intended he should sit.
