

Catholics and Temperance.

CHICAGO, Nov. 23.—Bishop Ireland has been interviewed on the action of the Plenary Council. He said there was one subject before the public, especially, which the Catholic Church is deeply interested in—temperance. He further said: "I am happy to say the decrees as they relate to that particular subject have been returned by the Pope without an alteration. The purport of these decrees is that the Sunday laws must be observed by all Catholics. They especially emphasize that Catholics must abstain from the liquor traffic and seek nobler means of livelihood. More particularly do the decrees condemn the selling of liquor. The greatest restrictions are placed upon the drinking of liquor. Even to use it at church fairs, picnics or any celebration except that in which the church is concerned is forbidden. Total abstinence is especially extolled. "It is a great thing," added the bishop, "for the Catholic Church to take an aggressive step in this direction. We have undertaken a great work, but I have faith in accomplishing it. The hour and the day demand it. Something must be done, for intemperance is the living curse of the present day."

The Liquor Bill Stolen.

SALAM, Nov. 25.—The Keady liquor bill, which passed both houses by a unanimous vote, has been stolen and the enrolled copy, which bears the signatures of the president of the senate and the speaker of the house, has been mutilated by erasure of the words "Be it enacted." The mutilation consists of a single pen stroke through the written line, and is made with the quality of ink in use at the house during the session and distinctly different from the ink in which the body of the bill is copied. The enrolled copy has not been out of the hands of officers of the legislature, and someone in high position has done this dastardly business. The enrolled bill is now in the hands of the governor, who does not think its mutilation fatal to its effect. He will consider it precisely as if it were without blemish. That is the bill enacted last session, in which there was a fatal defect, and which formed one of the points in Governor Moody's call for the extra session. It was re-enacted at the session just ended in perfect form. The whiskey interest has particularly desired to defeat this measure, and it has found somebody in high position brave enough to do the infamous work for a bribe.

We have received a communication signed "Observer," which we decline to publish for the reason that it contains scandalous insinuations regarding the young people of our town. While no names are mentioned, circumstances are cited and descriptions given sufficient to identify the parties aimed to be struck. The writer may be detected solely by a desire to preserve and purify society but we scarcely think the article in question is calculated to do any good in that direction. Besides, the publication of articles with a personal application over a fictitious signature furnishes too often a vent hole for anonymous malice. No doubt some of the young girls here do imprudent things, are too indifferent about the character of their associations, and too careless of their dignity and reputation, but this paper declines to make itself the medium of scandalous gossip and vague insinuations. That some of our young men and women might profitably mend their manners is probably true—so might others in other communities—but stabling reputation in the public prints under the cloak of a "non de plume" is hardly the way to work the desired reform, if reform be desired. Such articles as "Observer's" exhibit, to our mind, more a desire to vent spleen than to effect reform, and are more calculated to excite opprobrium against certain parties than to elevate society. We do not know that society is as bad as some people here to paint it, and we are loath to work any harm to any woman's, much less a young girl's reputation. It is easy to blacken a reputation, but the stain is exceedingly hard to wash out.

The California Democrats will transfer their factional fight to the House of Representatives. The opening scene will be a dead set against the admission of Mr. Hensley on the ground that he is not a citizen of the United States. Mr. Hensley says this is the same old straw that he has threshed over and over again "for years and years."

Notable Death.

INDIANAPOLIS, Nov. 25.—Hon. Thos. A. Hendricks, vice-president of the United States, died very suddenly at his residence in this city, at 4:45 this evening, under circumstances that were particularly distressing to his family and friends, inasmuch as they had not anticipated a fatal termination of his brief illness, and nobody was with him when death came. He returned from Chicago last Saturday, and since then had been complaining somewhat of pain in his head and breast, but nothing serious was thought of it. Last night he and Mrs. Hendricks attended a reception at the residence of Hon. John J. Cooper, treasurer of the state, returning home in their carriage about midnight. Hendricks had taken off the heavy clothing he usually wore, and put on a dress suit of lighter material, and before he got home complained of chilliness and a certain degree of exhaustion, but attributed it to malarial influence. He sat by the fire for an hour or more before retiring, but declined to send for a doctor, although urged to do so.
