

The Full Vote.

The official vote as declared by the state board of canvassers on state officers is as follows:

For Congress, Binger Hermann, 26,918; N. L. Butler, 25,922; G. M. Miller, 2,753; Hermann's plurality 1,735

For Secretary of State, Geo. W. McBride 26,213; R. F. Gibbons 25,922; A. C. Kinney, 2,775; McBride's plurality 200;

For State Treasurer, H. L. Marston 25,130; G. W. Webb, 26,908; John Long, 2,725 Webb's plurality 1,778.

For Sup't. Pub. Instruction, E. B. McElroy, 25,629; Napoleon Davis, 25,331; W. D. Lyman, 2,666; McElroy's plurality, 1,296.

For State Printer, F. C. Baker, 26,963; Chas. Nickell, 25,375; J. B. Sheppard, 2,700; Baker's plurality, 688.

For Supreme Judge, John B. Waldo, 26,886; R. S. Strahan, 27,094; Strahan's plurality, 234.

In the above the Republican candidate is named first, democratic second and prohibition third. The vote for Governor is canvassed by the legislature when it meets, the first Monday in January.

It is reported as falling a few votes short of 3,000 plurality for Penney, the democratic candidate, but the exact figures will not be known until it is officially declared.

Death of Modoc Frank.

Following is from the Springfield (Mass.) Republican: "F. Modoc a remarkable Indian, one of the 200 prisoners of Gen. Canby in the Modoc war, died at Portland, Me., Saturday night. While with his fellows in the Indian territory he became a Christian by his urgent and repeated requests prevailed on the Indian office to pay his expenses to Oregon, where he labored to convert his people to Christianity. He made some converts, but desiring to be educated so as to be of more value in his chosen work, he came East by the aid of the society of Friends to attend the Oak Grove seminary, a Quaker institution in Portland. He devoted himself to study with earnestness, and won the respect of all by his high mental capacity, as well as his earnest religious nature; but he wore his life out in the task he had set himself, and died at a decline at the age of 45."

Oregon Notes.

WASHINGTON, July 7th.—Nothing recently has attracted so much attention in the interior department as the decision of the Oregon and California swamp land cases. All the law talent in the department together with Assistant Secretary Hawkins, has been studying the case, and finally a decision has been prepared and admitted to the secretary which will practically settle the whole matter, involving 30,000 acres. There is much confidence in the special agent who is now engaged in looking up unsegregated lands in both States. It is thought probable that settlers who have gone onto lands with good faith, understanding them to be government lands will not be molested.

WASHINGTON, July 7th.—Hermann has secured the re-establishment of the postoffice at Willow Springs in Oregon, and the appointment of Nicholas Cooke as postmaster. Also the appointment of Arthur McGraw as postmaster at Bradbury, in Columbia county, Oregon. He has also secured an increase in the mail service from Eugene city to Coburg in Oregon.

The senate agreed today to an amendment to the river and harbor bill increasing the appropriation for the Coquille river. Coos bay and Yaquina harbor. Other Oregon items in the bill were not reached.

Congressman Bayne, of Pennsylvania, has attacked the President's veto in a speech to the House, in which he made free use of profane blasphemous language. Bayne, you are crying "rats," Bayne. You are an old hen, Bayne.

Our Railroad.

Now that the Fourth of July is over, and there being nothing of any great importance to attract the attention of our people, we would therefore recommend to them to immediately make a start in the enterprise of building a railroad from this place to the road passing through the valley. If our people ever expect to do anything to build up our city, we say now is the time. It is well known throughout the State that we have one of the healthiest cities on the coast, which is an important consideration to those who are seeking health above all other inducements; again we have the best assurance that our mines will be thoroughly prospected during the summer and fall, as a ten-stamp mill will be put in operation as soon as the work can be done, with all the new improvement for saving gold that is now in use. We have an immense lime-stone quarry from which hundreds of tons of fine lime as ever was placed in any market can be made, and by easy transportation to the railroad in the valley, would doubtless be a source of profit to the owner. For these and other good reasons we might present, we would earnestly urge upon our business men and property holders of our city the importance of immediate action in that direction. Delay is dangerous, and the interest manifested by our people may be lessened by delay.

Administration not True to Their Promise.

During the Presidential campaign in 1884 the Democracy through their platforms and public speakers made many promises which they knew at the time they could never fulfill. The people throughout the entire country are beginning to realize that fact and hence a feeling of distrust as well as disappointment is to be felt in every section of our country. They promised that the \$400,000,000 was to be taken from the Treasury in the event of their success and set afloat among the people. They made the people believe, or at least a portion of them, that each would receive his share; but instead of that, they allowed \$50,000,000 more to accumulate in the Treasury before a dollar was paid upon the public debt. For one month the interest on the public debt was allowed to increase amounting to hundreds of thousands of dollars, before a single payment was made. They have no settled policy to pursue; their two leaders in the House, Morrison and Randall are as wide apart as Blaine and Cleveland. This unsettled condition of public affairs has the same unsettled effect upon business throughout the country, hence we have a money drought. The Democracy at Washington seem to be dazed, bewildered and utterly incapable of managing the affairs of the country. Business is stagnated; cotton never was lower than now; manufacturers are afraid to start their factories for fear of a reduction of the tariff on the goods they manufacture by high labor, which will necessarily bring them in competition with the pauper labor of Europe. We believe the working people of the country has enough of this vasaletic administration, and should James G. Blaine be the next Republican candidate for President, we believe he will reach the executive chair with ease, for the people begin to realize the want of a statesman in the executive chair.

As we predicted the offices are entirely inadequate to the wants of the Jackson county Democracy, and just now we are enjoying the ludicrous squabble over the offices, of District Attorney and Justice of the Peace that is going on amongst the "harmonious Democracy." Each party has a good backing of friends and it is hard to tell who will win.

The elections held so far in England are not encouraging to Gladstone, and the outlook for immediate Home Rule grows more gloomy every day. This morning's election returns indicate that Gladstone's last hope of controlling the next Parliament is gone.

Obituary.

Addison Helms, one of Jacksonville's best known pioneers, died at his home in Jacksonville July 4th, 1886, after several months of failing health. Add had been a resident of Jacksonville for more than 30 years past and had by his universally kind and generous disposition and courteous and gentlemanly manner won the good will and esteem of all who knew him. A fortune passed through his hands since he came to Jacksonville but with that unselfish generosity that was the ruling characteristic of his life, his only appreciation of fortune's golden favors was measured by his unstinted liberality to all. He was twice elected marshal of Jacksonville and will ever be remembered as one of its most painstaking and obliging officials. He leaves a wife, a sister of Gen. John E. Ross—and a host of friends to mourn his demise. While every generous act of his life is held in grateful remembrance by the friends he has left behind, may his spirit rest in peace. We extend to the bereaved wife our sincere sympathy.

Patrick McMahon who has been a resident of Jacksonville since his early manhood died at his home in this place last Saturday of heart disease. Mr. M. had been in poor health for some time past, and about six weeks since while he was at the Soda Springs for the benefit of his health, his eldest son Eddie was accidentally drowned. The shock was so great that his early demise was then anticipated. Mr. McMahon was a man of great energy, and was one of our most industrious and enterprising citizens. He left his family in affluent circumstances. The bereaved wife and mother, who is almost prostrated by this double affliction, has the sincere sympathy of the entire community.

Carrie, the infant daughter of Mr. and Mrs. J. C. Whipp, died on Sunday last after a short illness, aged three months and ten days. Just as the infant was unfolding its tiny petals in the sunlight of its parents love and affection, it was transplanted among the Angels to blossom in the gardens of Eternity. May the memory of its brief span of life be a cherished incense arising from the hearts of the bereaved, up to the All-wise One who governs the little one from the storm and temptations of earth life. "For such is the kingdom of Heaven."

SENATOR MITCHELL, of this state, has dipped into the much-discussed John Roach matter. On the 6th inst. he submitted a proposed amendment to the general deficiency bill to provide for the payment to John Roach & Son of \$20,270 for wharfage and care of the monitor Roanoke from March 17, 1871, to the time of its sale in 1883 including towage, pilotage, etc., also to pay them \$38,840 in full for the cost of changing thereon the frame of the Puritan.
