ABRIVALS .- The Rev. Mr. Walker and family, associated with Rev. Mr. Eels, in the missionary cause among the Spokan Indians, arrived in town on Thursday night. Mr. Eels and family are daily expected. We are happy to hear of the health and safety of these families. As long as there are any of the Cayuse murderers at large, we should regard it as extremely hazardous for any family of whiles to remain in the Indian country.

The Rev. Mr. Atkinson and family, attached to the Presbyterian Mission, arrived in town on Wednesday. They came passengers on the Samoset from the States to the Islands, and from thence by the Cowlitz.

RETURN OF THE TROOPS.—The volunteers have been returning in detached parties for the past week, and we presume that they have all arrived by this time, excepting the garrisons of Forts Lee and Waters, which are to remain. Whether they have been discharged we are unable to say, nor have we been able to get hold of any official report or document that will enlighten us as to vyhat has been accomplished.

Col. GILLIAM'S OBSEQUIES .- We understand that the funeral solemnities, in honor of the late Col. Gilliam, will take place on the fourth of July, at the homestead in Polk county. Dr. McBride is expected to pronounce a eulogy upon the occasion. A procession and other testimonials of respect for the deceased, will constitute a part of the obsequies.

ROGUE RIVER TRIP.-We learn that Mr. John Sexton intends starting, on the 10th of next month, for Rogue river, to attempt to recover the horses which were stolen from him as he came in from California a few weeks since.

RAILROAD TO OREGON .--- VVe see that the Legislature of Georgia, by the passage of resolutions, have instructed their Representatives in Congress to support the project of a railroad to Oregon.
