Taking the liberty of invoking your assistance, to enable me to present this subject in a proper and judicious manner for the consideration of Congress...

I take it for granted that the best mode of carrying out the measure would be the appointment of suitable persons or commissioners...

I would also be pleased to have your opinion as to the number of agents, sub-agents, and interpreters, you consider necessary for the Indians as they are now distributed and located in the territory...
