A New 65c.

New York, Sept. 1.—A Herald Washington special has a story about friends of General Grant, including distinguished Southerners, moving in a scheme to reward his patriotic services by creating the office of Captain-General of the army with suitable pay and allowances to afford him permanent occupation in a congenial employment the remainder of his life. This idea has been quietly canvassed among members of the Senate and House, who have visited Washington during the recess, as well as Saratoga, Newport, Long Branch and White Sulphur Springs. It can be said that the proposition has been received with great favor and will take shape in a bill accomplishing the purposes named, early at next session of Congress. The mover in each House will be a Southerner.

Fifty-six Tons of Silver.

WASHINGTON, Sept. 1.—During August the silver payments from the U. S. treasury and U. S. mint amounted to \$1,865,000, exclusive of the amount returned for silver certificates. The aggregate weight of the coin was fifty-six tons.

Refunding Operations.

Up to and including today the receipts of refunding certificates for the conversion of 4 per cent. bonds, aggregated \$35,706,000. The issue of the 4 per cent. loan by the treasury department amounted to \$740,735,300.

A T. S. Marshal Murdered.

WICHITA, Kan., Sept. 1.—Richard Stevenson, a U. S. deputy marshal, was shot and killed in Kingman county Saturday by a horse thief, who escaped to the Indian Territory. He had arrested the thief at Wellington and was returning with his prisoner and property to Kingman. Both men, together with a drummer, were in a carriage. In descending a sudden declivity the thief snatched Stevenson's revolver and shot him through the breast. He then dismissed the commercial traveler, mounted the best horse and fled.

Came to Webster.

WATERBURY, N. Y., Sept. 1.—Towns on the black river and tributaries are suffering greatly from want of water. Since January the rainfall here is nine and one fourth inches less than for the same time in 1878.

Starving Animals.

New York, Sept. 1.—A World Ottawa special gives an intelligent and concise account of the situation of the Manitoba Indians and the movements for the relief of their suffering, and for the engagement of the threatened revolt from one end of the country to the other. They are suffering from famine and the region is so vast and generally so difficult of access, that it is impossible for the government to meet their demands for provisions.

Indiana in the northwest is estimated at 40,000, and across the Rocky Mountains in British Columbia there are 30,000 more. To these add fugitive Sioux and Nez Perce bands, and the total population between Lake Manitoba and the Pacific Ocean is not far short of 90,000. In case the outbreak should prove a serious one, the government will organize an expedition similar to the Canadian contingent which accompanied Wolsey and the imperial troops to Fort Garry in 1870.

The Chinaman Murderers on Trial.

SCOTLAND, Sept. 1.—The September term of the Scotch Court for Criminal cases, began at Dalkeith county seat today, Judge Hamm presiding. The State docket was set for to-morrow, when will commence the trial of the cases of the State vs Henry V. Gully, Virgil Gully, Houston Gully and Vloem Gully, indicted for the murder of Miss Cornelia Chisholm.

The steamboats Samboe and Alberta were sunk. A portion of the ice shed at Morgan City's wharf, and a portion of the engine shed have blown down. Some dwellings were also blown down by their foundations. The damage to crops along the Teche is immense. A sawmill at Berwick, across the bay, was blown down. The Presbyterian church and a new school house were wrecked and the streets were flooded. Morgan's Teche warehouse was blown down and carried across Front street, injuring the stores of L. Loeb and A. Emar. The gale was frightful in the evening.

Produce Export from New York.

NEW YORK, Sept. 2.—The exports of domestic produce from this port during the week are the largest on record—\$9,982,008, against \$7,625,433 for the corresponding week of last year, and \$7,261,045 the year previous. Of this week's total, \$33,000,000 went to Liverpool and London alone. The total since Jan. 1st, is \$220,551,748 against \$223,999,933 for the same time last year.

English Emigration.

The Earl of Devonport, who arrived with several others of his English nobility yesterday, goes hence to look after his property in the Colorado. He is accompanied by the Earl of Colchester and Lord Lonsdale, both of the 1st Life Guards, for a hunting expedition. Being asked by a World reporter if any English farmers had emigrated to Colorado, he replied, "No," and that he thought it was not particularly adapted to farming. He thought the English farmers to America not likely to increase; the causes now impelling them were only temporary.

Grant Homeward Bound.

NEW YORK, Sept. 2.—The Pacific Mail Steamship Co. received the following dispatch from Yokohama Sept. 1: "The steamship City of Tokio sailed on the 31 of September and will probably arrive at San Francisco Sept. 21st. Gen. U. S. Grant was a passenger on the steamer."

Public Debt Statement.

The debt statement shows a decrease of the debt for August of \$3,527,365; cash in the Treasury, \$243,696,225; gold certificates, \$15,128,700; silver certificates, \$3,286,831; currency certificates, \$35,175,000; refunding certificates, \$1,396,500; legal tenders outstanding, \$19,581,016; fractional currency outstanding, \$15,681,004.

The Southern Storm.

NEW ORLEANS, Sept. 2.—The sinking of the steamer Gilmore and the barge canoe a loss of \$125,000. The steamer Portage, during the storm, landed at Newton Bend, 20 miles above Bayou Sara. Her officers report the warehouse at Texas Landing high and dry. All the sugar cane and cotton bolls of the river at Texas Landing were destroyed, and three or four gin houses were demolished. Fences and cabins were blown down, and great damage to sugar houses, dwellings and crops is reported along the coast. Houses were blown down in Bayou Sara, Baton Rouge, at Port Eclair and other towns. So far as could be ascertained no lives were lost. The storm in St. John Baptist was fierce, a continuous gale of wind and rain prevailing from 8 A. M. till 11 P. M. An occasional fall of a few minutes was followed by increased fury of the gale, carrying away trees, shaking houses and prostrating fences. Some sugar houses and cabins were blown down. The orange crop is badly damaged. Pecan trees are stripped of fruit, and cane and rice are in a deplorable condition.

Southern Crops Rained.

NEW ORLEANS, Sept. 2.—Monday's storm lasted from noon till 10 at night. The damage to property in the town, glass in buildings, fencing and crops in the country is incalculable. From every section of the parish comes the old tale of great destruction of cotton, and then the corn crop is leveled with the ground and will be barely able to recover. Losses in town, independent of coal and ferry boats, are estimated at \$300,000. The roof of Henry Von Pulse's sugar house fell in and killed 20 to 25 mules placed there for safety. Fifty yards of wall around the penitentiary was demolished and part of the building unroofed and machinery damaged.

Monument to Gen. Bangs.

CALGARY, Sept. 4.—A monument erected to the memory of the late Gen. Geo. S. Bangs, superintendent of the railway mail service, will be unveiled at the Exposition building Saturday evening at 8.30, with appropriate ceremonies, including an oratorical tribute by Hon. Every Storm, a life-long friend of Gen. Bangs. The monument is of grey marble, 18 feet high, and the design is very complete and elaborate.

A Month's Business.

NEW YORK, Sept. 4.—The public table of business transactions, as shown by clearing house statistics for the month ending the 30th, gives the following losses and gains compared with August, 1878. Gains—New York, 61 1/2; Boston, 25 1/2; Philadelphia, 30 1/2; Chicago, 13 1/2; Baltimore, 14 1/2; Cincinnati, 8 1/2; St. Louis, 9 1/2; Louisville, 5 1/2; Pittsburg, 21 1/2; Providence, 10; Kansas City, 120 1/2; Indianapolis, 6 1/2; Cleveland, 11 1/2; New Haven, 22 1/2; Columbus, 23 1/2; Springfield, 6 1/2; Lowell, 12 1/2. The cities that have lost are San Francisco, 34 1/2; Milwaukee, 19 1/2; New Orleans, 17 1/2. The decline in San Francisco is accounted for by transactions last year being unusually swelled by speculation, and distrust of capitalists and uncertainty of business men respecting the effects of the new coinage and the impending election producing stagnation this year.

Sailor Sports.

NEW YORK, Sept. 4.—A dispatch from Arica, Peru, Aug. 13th, states that the Chilean transport Lamare, chased by the Huascar, had a number of sick soldiers on board when she ran ashore at Callera. The Huascar afterwards pursued the transport Statu, but the latter took refuge under the guns of the ironclad Blanca Esclada, which in turn chased the Huascar eight hours, the latter escaping.

MEMPHIS, Sept. 1.—Sixteen cases reported to-day, 13 white, 3 colored. Four additional deaths are reported. The city is being thoroughly disinfected under the auspices of the State Board of Health officers.
