NOTES FROM ECHO

ROUSING FOURTH OF JULY CELEBRATION.

Incorporation of the Newport Land and Construction Company—Natal Day of Nation Will Be Observed in Teal's Grove—Alberta Men Buying Horses for Shipment—Money Raised for Site for Packing & Storage Company.

Echo, Ore., June 14.—An incorporation is being formed here to be known as the Newport Land & Construction Company of Echo, Ore., for the purpose of buying and selling land and doing general contracting work. The company is capitalized at \$500, divided into 1000 shares at \$5 a share.

The Fourth of July committee has decided upon the Teal Grove just above town, as the location for the celebration. A very fine race track adjoins the grounds which will be put in first-class shape.

Buying Horses for Canada.
Sam De Rinzy and Mr. Day, of Medicine Hat, Alberta, came yesterday for the purpose of purchasing horses for the Alberta range. They say people are pouring into Canada from all directions and that it is only a matter of a few years until the range there will be completely filled. Mr. Day is connected with Day & Crosswell, very extensive horse dealers of the Alberta district.

Ice Cream and Fruit Festival.
An ice cream and strawberry festival will be given Tuesday evening, June 16, at 8 o'clock, at Odd Fellows' Hall, under the auspices of the Ladies' Aid Society of the M. E. church. The proceeds go to the church. This will be the event of the season.

Packing & Cold Storage Company.
In response to a call by the chairman a rousing meeting of the commercial association met at the office of L. A. Esteb, at 2 o'clock p. m., on June 13th, to take steps toward securing a site for the much-talked-of Hare Packing & Cold Storage plant.

Messrs. Willis and Fletcher were there in the interest of the company, and after an assurance that the money was ready with which to build the plant and that all was wanted to bring it to Echo was grounds for the buildings, and after rousing talks by various members of the association and an expression from all present that they were willing to contribute to the purchase of a site in case one could be secured at a reasonable figure, it was regularly moved and carried that the chairman appoint a committee of three to confer with the representatives of the company and the property owners with reference to a suitable location. The committee was instructed to report back to the body at 8 p. m.

Will Select From Two Sites.
Two propositions were submitted to the committee, one each by Joel Holstead and J. H. Coontz. At 8 o'clock the committee reported and recommended that we submit the two propositions to the company and guarantee whichever they preferred. The report of the committee, which consisted of H. G. Newport, A. W. Robinson and J. S. Rogers, was accepted and the committee discharged. It was then moved and carried that the chair appoint a committee of four to see what amount could be raised toward the purchase by public subscription. The chair appointed as such committee, H. G. Newport, A. W. Robinson, J. S. Rogers and R. Jones, with instructions that they report to the body at 3 p. m. on June 14th.

The committee started a subscription list and enough is already in sight to fully assure the purchase of the grounds.

GONE TO SUMPTER.
President of Standard Consolidated Mining Company Leaves for the Mines.

Zach Houser, president of the Standard Consolidated Mines Company, of Sumpter, left for that place Saturday night. Extensive work will begin on the property of this company at Copper Ridge, immediately. The mountain roads are now in good condition and supplies can be hauled in. Mr. Houser will stop a day or two at Sumpter to confer with Dr. Mueller, secretary and general manager of the company, before proceeding to the mines.

The Standard Consolidated includes 26 claims, formerly under the three different companies. The Standard, the Copper Ridge, Gold Mining Company, and the Willie Boy claims, all located contiguously on Copper mountain, near Quartzburg.

Cattle Going West.
T. W. Gordon, of Falk's store, Idaho, passed down the O. R. & N. with a shipment of beef cattle for the Portland markets last night. Mr. Gordon says that stock cattle in Southern and Western Idaho are declining in price owing to the scarcity of feed in many of the best buy districts. Owners will sell their stock at reduced prices rather than pay the high price that feed will necessarily command this winter.

A work train has been engaged in clearing up loose rock from the cuts on the mountain, the past week. School is now in progress, with Miss Ada Roberts, of Meacham, as teacher, with 12 scholars in attendance.

MORE ATTRACTIONS

HOSE TEAM RACES AND BALLOON ASCENSIONS.

Large Number of Novelty Competitions Will Be Pulled Off—Definitely Concluded to Pitch the Big Tent on the Island—Other Details Will Be Published.

The general committee in arrangements for the Fourth of July celebration is working hard and is fast getting things in shape for the day. The program is being moulded into final form, and in a few days the entire list of events will be made public.

Balloon Ascensions.
One thing that is assured is the balloon ascension, and from the reports of the work of Professor D. McClellan, who will make the ascension, the event will be a novelty and a decided success. There will be two balloon events, one in the morning and one in the evening, and at each one the professor will make a parachute jump from a great height. The ascension is an Eastern man of much experience, and guarantees a novel and spectacular event.

Horse Team Races.
Another thing that is always of interest to the public will be given, and that is competition races by the horse teams of the city. There are seven teams in town, and each of them is anxious to test the speed of the other teams. A prize of \$50 has been offered by the committee for the winning team, and the probability begins practicing for the event in the near future.

Specialty Races.
Another thing of the day will be the specialty races by the young men. There will be a number of races and all of them will be novelty races with the exception of one which will be a straight race. There will be no cash prizes offered for these races, so that the high school and college boys can compete. A cash prize would throw all the competitors in the professional class and under the conditions the committee thought best to hold it open so that all the young athletes of the vicinity could compete.

Tent on the Island.

The committee is looking for a location for the tent for the general exercises of the day, and they have about decided that the place for it is on the island below the bridge on Main street. The only thing that holds them back is the lack of funds. This will be overcome by private subscription, and the tent will be placed in a short time, and the platforms erected. After the celebration the persons putting up the funds hope to make back the money expended by renting the property for summer dances and concerts.

The other details of the celebration will be ready for the public in a short time.

WALLA WALLA QUIT.

PREDICTS WOOD FAMINE.

Indications Point to a Shortage of 100,000 Cords Next Winter.

"This market will suffer from a heavy shortage of wood, both in kind and cord, the coming winter," says M. C. Banfield to the Telegram. "Forest fires and other misfortunes have combined to decrease the supply of wood and I estimate there will be fully 75,000 cords of wood less on the market than there was last season, and the demand will exceed the supply on hand by 100,000 cords in Portland."

Mr. Banfield thinks the population of the city will have increased in the neighborhood of 12,000 by the beginning of 1904. Such a condition is looked upon as a most serious one and many will be the sources of householders to get in the necessary allotment of fuel before the "snow flies."

STRUCK BY LIGHTNING.

Horses Killed at Dixie—Worst Storm in Years.

Eureka Flat, June 15.—During a terrific rain and thunderstorm which swept over the Dixie country Saturday a bolt of lightning struck and killed two valuable work horses belonging to W. S. Cantonwine, a big farmer of that district. The animals were in pasture about distance from the Cantonwine home.

The storm is reported to be one of the worst to occur in the mountain region for years. Rain fell, and lightning zigzagged about in a bewildering fashion, striking in terror to the younger hearts. The bolt which killed the horses was felt for a considerable distance.

WOOL SALES TODAY.

About One Quarter Million Pounds Changes Hands This Afternoon. The second series of the annual wool sales are being held in the city this afternoon and the wool in the big warehouses of the place are being emptied of their load of fleeces. There is a large number of buyers here and they all seem to want to buy and as a result their crop is moving at a good rate. On the other hand the growers seem to be as anxious to sell as the buyers to buy and welcome any bid that is in the nature of reason.

During the day but two bids have been rejected and one of them has been reconsidered and the original offer has been accepted. The prices offered have been about the same as they were on the last day here, with one or two exceptions. On the last day the highest price offered was 13½, as against 14½ on today, but this figure was only offered for the clip of one man. It is thought that the evening will see most of the wool stored here sold, only a few of the growers being willing to take the risk of holding their clips for private sale, and to pay the insurance required by the warehouses. DARVEAU BUILDING

LARGE BRICK TO BE BUILT ON SITE OF RECENT FIRE.

Will Be One Hundred By Twenty-Five Feet in Size, With Full Basement and Strictly Modern—To Be Used Mainly as Sample Rooms—T. F. Howard is the Architect.

George Darveau, the proprietor of the St. George hotel, has a large force of men at work this morning tearing down the old ruins left by the fire, and will erect as soon as he can secure the brick, a large sample room on the site of the one recently destroyed by the fire.

The new building will be 100x25 feet in dimensions and will be practically two stories. The first story will be on a level with the street and will be fitted with all the conveniences that go to make glad the heart of the overworked traveling man. The basement will be as large as the upper floor and will be in every way as convenient as the first.

The basement may be floored with cement and the entire place will be well lighted and so arranged as to display the wares of the commercial man to the best possible advantage.

T. F. Howard has the plans of the building under his direction and will rush the work along as fast as may be possible for the most and much needed at the present time and when the drummers begin to bring in their holiday goods there will be no room in which to display them.

The knights of the road are put to all kinds of shifts to transport their business. The warehouse of the W. S. Ragan, lately destroyed by the St. George lobby, the back of the bar room of that hotel, and any old place in fact, are pressed into service when the rush demands.

PENDLETON IS SENDING HELP

THREE FOUR-HORSE LOADS OF GOODS HAVE LEFT TOWN.

The Destruction of Heppner and Drowning of its People is Regarded Here as a Calamity That Concerns the Entire State—Much Private Aid Will Be Sent.

The entire city of Pendleton is responding nobly to the relief of the stricken city of Heppner, even before any call for help has come. This morning business men of the city met and agreed to send all the things needed in the way of supplies to the help of the homeless people at Heppner, and in accordance with this plan provisions have been collected and are being sent from here by way of Vinson this morning, and one big load left early in the forenoon from Echo, by order of the merchants of this place.

All the available rigs of the city have been pressed into service, and a large number of the people of the town have gone to render what assistance is in their power to those in need of help at the scene of the disaster. G. W. Hartman has gone to the scene to take charge of the forces from this place, and has been given the power by the men of the city to use his discretion as to what is needed, and to call on the people here for what help he may need. The Commercial Club also empowered Mr. Hartman to draw on the people for anything that was necessary and they would stand behind his order.

The wagons going out of here were loaded with tents, provisions, blankets and utensils of all kinds.

The men going over in their own rigs took private supplies and the total of things sent will in all probability foot up to three or four loads from this place.

The two loads sent today are mere starters and Mr. Hartman will draw on the town for what he wants additional. The county and the city governments are expected to stand the expense of the provisions.

Each man furnishing supplies in large quantities will keep an account of it and turn it in to the authorities hereafter; but at the present time they are simply sending the goods without question as to the price, or when, if ever, they will be paid for them.

The streets are lined with anxious people having friends and relatives in Heppner who are eagerly awaiting news of the catastrophe.

Each man with messages all seeking the latest news from the scene. Pendleton is closely related to Heppner, and many of the people here have near and dear relatives there.
