SOLDIERS'
WAR CLAIM AGENCY,
No. 5 MONTGOMERY BLOCK,
San Francisco, Cal.

W. H. AIKEN, Attorney-at-Law, and Com-
mander of the Grand Army of the Repub-
lic in California and Nevada, will give
travel pay, now due California and Nevada
soldiers, discharged more or less than 100
miles from home. Soldiers can depend on
his dealing. Information given free of charge.
Ref. Indl. for travel pay, if not paid the same
time company and regiment and whether you
were discharged. Congress has extended the
deadline for filing claims for additional bounty
under the Act of July 3d, 1906, to January, 1907,
if that six months claim period be made before
that time. Original Bounty of \$500 has been
allowed all volunteers who enlisted before July
3rd, 1861, to three years, if not paid the same
time company and regiment and whether you
were discharged. Land warrants can be obtained
for soldiers discharged before July 3rd, 1861,
or services in the late war. Penalties for the
late war and war of 1812 obtained and improved.
If allowed for less than disability warrants
as no pensions are allowed to Mexican and
Africa war soldiers. State of Texas has grant-
ed pensions to surviving veterans of Texas revo-
lution. New Orleans and Mobile Prize Money
now due and being paid. W. H. Aiken also
