### NOTES OF INTEREST.

**BELLIGERANT YET PEACEFUL.**  
 Reception Given in Honor of Our Distinguished Military Visitors.  
 Monday evening the O. N. G. of this city gave a public reception at the McChallen, to Brigadier General C. F. Beebe, Colonel J. Jackson, U. S. A., and Major Sidney Collins, D. J. Moore and L. C. Jones, O. N. G., who had just returned from Bandon, Coos county, where they had been on a tour of inspection of the O. N. G. in that county.  
 Quite a number of invited guests, prominent citizens of the city, were present to welcome the distinguished military visitors. After an hour spent in social intercourse an invitation was given to file into the dining hall, where plates were laid for 40 by the hostess Mrs. D. C. McChallen, queen caterer to the palate.  
 D. S. K. Buick was made master of ceremonies and in a brief speech of welcome to the military visitors, on behalf of the citizens of Roseburg, the seats were taken at the festal board. After fully discussing the spread of edibles and wine, toasts and responses were indulged in for over an hour.  
 The first sentiment responded to was, "Our Guests. Hon. Binger Hermann responded in his happiest mood for 20 minutes.  
 The second, "The O. N. G." was responded to by General Beebe, complimenting A. C. O. N. G., as to its proficiency and military discipline. He spoke of the necessity of the militia being drilled in military tactics in case of invasion or internal disturbances. He spoke favorably of the public sentiment with regard to the necessity of being in a condition of self defense.  
 Colonel Jackson followed General Beebe on the same line of thought. He pointed out the great need of our being prepared for war as the best means of avoiding a conflict. He said a nation that is well prepared to defend itself is not so liable to be assailed as one which is not prepared. The strength of the nation is its salutariness, that strength can only be shown by its army and navy. Military training fosters patriotism, the bulwark of a nation. With an organized and well equipped army we may dominate the destiny of the world, without it we will be the puppets of tyrants.  
 Major Collins concurred in the sentiments of those who preceded him. He complimented Mr. Hermann for the efficient aid in the work of organizing the militia of Oregon and its equipment.  
 Major Jones made a brief speech laudatory of the O. N. G. of the state. He, too, pointed out the necessity of organizing and properly instructing the militia as a means of protection in case of emergency which at any time is liable to arise, as instances in the past have demonstrated.  
 Major Moore was thankful for the favorable sentiment expressed by his predecessor's remarks, which he endorsed.  
 W. F. Benjamin, editor of the PLAINDEALER, responded to the toast, "The Press." He endorsed the sentiment, "In time of peace prepare for war," and that training the militia was furnishing teachers to instruct the citizen soldiers in cases of emergency.  
 Chas. H. Fisher, editor of the Review, also responded on behalf of the press. He thought that the reason why the people were not more favorable to military organization and training is because of high taxes and hard times, but he was glad to be present and participate in welcoming the distinguished guests.  
 Colonel Jackson was again called for and spoke very feelingly and eloquently as well as logically of the great need of a well organized army and navy.  
 Dr. Du Gas was called out. He thought the profession played a noble part in the work of protection. He facetiously referred to the death dealing pill as effective as the death dealing bullet.  
 Dr. K. L. Miller said the sons of Esculapion could wield the sword as effectively as they could the scalpel, and was ready to do so when he saw fit.  
 F. W. Benson, county clerk, was called for as a good talker. He responded with a toast in honor of the guests. "The Microbe Killer," which was drunk with a gusto.  
 Hon. J. H. Shupe was called for. He responded with some well timed remarks saying that now we had preserved the union he expected those young men coming after us would still maintain the old flag and pass it over to posterity unimpaired.  
 Commandant Byars of the soldiers home made a few appropriate remarks.  
 F. B. Hamlin, Capt. "A" Co., O. N. G., upon call, made a short speech of a military nature.  
 Mayor A. C. Marsters responded to a call for a speech. He thought that, though now the white winged Angel of Peace was hovering over us, it would be well to prepare for the possible contingency of war, which seemed to be rising in the Orient, and might not escape our fair land. He felt proud of Co. A., O. N. G., and thought it should receive proper encouragement from our citizens.  
 Judge Stratford responded with a few patriotic words of encouragement for our state militia.  
 Major Flynn of the Soldiers' Home also offered some well chosen words of advice in the work of organization of the militia of the state as a wire precaution for safety. He also advised a better and more efficient navy.  
 Lieutenant Chas. Graham being called for, responded. He spoke of the detail work necessary to make a far showing. This part of the work falls upon officers of the companies and requires great patience and painstaking. He also spoke of the necessity of thorough organization, endorsing the remarks that point made by Colonel Jackson and General Beebe.  
 W. A. Frater, our county treasurer, responded to "Our Citizens" briefly but forcibly, as ever ready to support every laudable effort for improvement or

necessary undertaking for the general welfare.  
 The hour having arrived for our distinguished guests to depart by the north bound overland, adjournment was in order, and a toast by Major Moore, "The Hospitality of Roseburg" was turned off with a full glass and the party arose to depart. A general hand shaking closed the parting salutation.  
 This reception was one of the pleasant episodes in the history of Roseburg and will long be remembered by all the participants.  
 While it was somewhat on a line military, a spirit of peace and harmony prevailed throughout.

**To Indian War Veterans.**  
 The grand commander urges upon all Indian war veterans to consider the results of what has been done by our organization at so little cost and what might have resulted had each and every one joined one of our camps or instituted new camps and paid his small sum of 40 cents to the grand encampment with a consciousness that he was but doing a good thing for himself and his comrades.  
 We have secured to comrades places in the Soldiers' Homes of Washington and Oregon and the registration by each state of the name of each veteran in the archives of the state with the company and regiment in which he served. In the state of Oregon we have secured funds from the county courts of Oregon at the call of the camp commander, approved by the camp committee, in the care of sick and needy members of the camp and a goodly sum for burial expenses. It is held that these benefits amply repay us for our financial expense, and their remains additional the social advantages of the camp.  
 We have also created an interest in congressional circles which will not cease till each veteran shall receive from the general government a pension in recognition of his services to the country.  
 Money is required to pay printing bills, postage, record and other books, all of which are necessary to keep up the organization and to keep our interests before congress and the people.  
 The grand commander accordingly appeals to each veteran not a member of a camp to apply to the camp most convenient to him on Nov. 16th, 1895, for membership, or in case members sufficient can be found where a new camp can be instituted to correspond with the grand adjutant in regard to the same, who will be gratified to give all needed information. Let each new and old member be willing to glad to pay his dues and all march on to victory.

**In Thirteen States.**  
 To day 13 states will elect officers: Massachusetts, New York, New Jersey, Pennsylvania and Maryland in the East; Virginia, Kentucky and Mississippi in the South; and Ohio, Iowa, Kansas, Nebraska and Utah in the West. Full state tickets are to be elected in Massachusetts, New Jersey, Ohio, Mississippi and Utah. In New Jersey, Maryland and Iowa, governors and one or more state officers will be chosen. New York and Pennsylvania elect minor state officials, and Virginia will choose a legislature that will elect six state officers. In Nebraska and Kansas the election will be practically confined to the judiciary and university regents. In addition to Virginia, Ohio, Iowa, Kentucky, New York, Maryland, New Jersey and Utah elect legislators. Those of New York, Maryland, Kentucky, Ohio and Iowa elect United States senators, and so will that of Utah, provided the constitution is adopted.

**Jailbreaker and Stage Robber.**  
 KLANATH FALLS, Nov. 3.—Adolphus C. Frick, arrested in August last for horse stealing, and bound over for the November term of the circuit court, broke jail Friday night by sawing off two iron bars. This morning about 4 o'clock Frick robbed the stage from Ager, 10 miles south of this place. District Attorney Benson and Deputy Sheriff West Gordon were passengers. Frick stood behind a telegraph pole on the other side of the fence and ordered the driver to halt, pointing at him what afterward proved to be a stick. The driver threw the mail sack on the ground and was then told by Frick to drive on. Gordon got out of the stage just as it started and fired a load of buckshot at Frick, who was climbing the fence to get the mail sack. Frick started to run and Gordon fired again. Frick ran to the tules, chased by Gordon, who overtook him and made him come out. Gordon then took Frick to Grants Pass for examination before the commissioner.  
 Frick had several buckshot in his body, but is not seriously injured. He is an old offender, and served one term in San Quentin for nearly killing a man with a rock a year ago in California.

**The Cuban War.**
