HOFFER'S WAGE ROLL

The Salem Typographical Union Analyzes It.
Salem Statesman.
The following preamble and resolutions were adopted at the last meeting of Salem Typographical Union, No. 210, and will be issued in circular form for distribution to all of the labor organizations throughout Oregon:
"Whereas, The Salem Typographical Union, No. 210, is a labor organization, united for the purpose of uplifting the intellectual, moral and pecuniary standard of the working classes, as law-abiding citizens; it is, therefore, the bounden duty of each and every member and members as a whole to further our interests by any legitimate action aiming to that end. Therefore, it is not only in harmony with good unionism, but it is our duty to resort to our rights of suffrage when all other efforts have failed to accomplish such purposes; and when an enemy to our cause and an antagonist to our principles seeks political preferment at the hands of the voters, as organized people with the right to vote, should exercise that right in accordance to the welfare of our obligation; and
"Whereas, We find such a man in E. Hoffer, editor and proprietor of the Salem Capital Journal, and candidate for United States presidential elector on the Bryan-democratic ticket, to be voted for on the 31 day of November, this year. For years Mr. Hoffer has been a menace to labor and its union in this city, working his employees at starvation wages.
"He has been petitioned many times to grant this union some concessions, but without avail, until in the year 1891 his office was declared 'unfair,' and again in 1895, in the month of March, for the last time. A boycott was then ordered by the union; and the following notice printed in the Statesman of April 1 by the secretary:
"To Business Men—By order of Capital Typographical Union, No. 210, the following are the 'fair' printing offices in the city of Salem: State, E. M. Waite, R. E. Moore & Co., and the Statesman. All other offices are 'unfair.' W. D. Torrey, secretary.
"On the following day, April 2, the Capital Journal published the above notice at the head of a half column of abuse, denouncing labor unions and their methods. Editorially were several paragraphs devoted to the members of this union, to wit:
"The 'dastardly un-American method of dictating to business men whom they shall employ and whom they shall do business with is played out and ought to be smashed here in Salem, as it has been everywhere.' 'A few cigarette-smoking blatherskites cannot dictate to the business men of this city who they may or may not order printing of.' 'Men who cannot run their own business have no right to dictate to others how they shall run theirs.' It remains to be seen whether a few labor agitators can hold up the town.'
"In the face of all this Mr. Hoffer has and is now stamping the state declaring that he is the friend of the farming and laboring classes, while one week ago he discharged a typesetter with a family that he was paying \$6 a week and hired two in his stead, paying one \$3.50 per week and the other \$1.50. He said he did it to 'cut down expenses'—of \$1 per week. Three more typesetters he pays \$4 each per week, who have worked years at the business; another \$1 a week, and his pressman \$3 per week, making a total of \$21 per week for seven people; an average of \$3 per week, or a fair week's wages for one man. His foreman is a 'rat' and receives \$10 per week. And yet Mr. Hoffer says that he is the 'workingman's friend.' The sweat-shops of New York cannot be worse. His employees are all poor people and depend upon their wages for their bread. One young woman keeps herself and aged mother upon \$4 per week and a man and his wife subsist on \$3.50 per week. These are truths on record; therefore, be it
"Resolved, That we denounce such damnable oppression of the poor laborers and refuse to support any man that is responsible for it. We, therefore, ask the laboring classes and unions to join with us in the defeat of Mr. Hoffer for presidential elector. W. D. Torrey, Secretary, Typographical Union, No. 210."
Attached to the above and forming a part of the circular is the following affidavit:
State of Oregon, County of Marion—s: s: I, O. D. Rennie, being first duly sworn on oath say, that the wages paid by the Salem Capital Journal to its employees, as set forth in the resolutions adopted by the Salem Typographical Union, No. 210, at its last session, are correct up to the 17th of October, 1896, the time when I severed my connection with that paper.

His Brain Was Destroyed.
SAN FRANCISCO, Oct. 27.—William Kennedy, the welder who was pinned to the bottom of a 60-foot well last Friday by a crowbar which fell from the surface of the ground and penetrated his brain, and lived to tell how it happened, died at the city and county hospital in great agony last night.
How Kennedy lived at all after the accident is a puzzle to physicians. When the wound was laid open by Autopsy Surgeon Morgan at the morgue yesterday, it was found that fully one-third of the brain had escaped through the great hole made by the crowbar, and the remainder was badly decomposed. The point of the heavy crowbar had penetrated the skull just over the right temple, passing through the brain and out through the skull in the rear, fracturing the bone in a hundred pieces. Yet Kennedy lived three days and was able to tell of his sufferings almost up to the time that death claimed him.
Died, at 4 a. m., Wednesday, Mrs. Wm. Callahan, at the residence on Mill street. The funeral was held at 2 p. m. today. Services at the M. E. church south, conducted by Rev. Mr. Jones. Mrs. Callahan has been prostrated for several months with that insatiable disease, pulmonary consumption and has finally succumbed to the ravages of that fell destroyer and passed over the bridge of sorrow to join that innumerable host gone before. Her remains were laid to rest in the Odd Fellow's cemetery today.
