FROM THE PHILIPPINES.

CANTER ADRIAN, LONDON, P. I., July 17, 1898.

EDITOR PLAINDEALER: I write you a letter again today. Have received no mail since leaving Honolulu, but expect to this afternoon, as the second expedition is now anchored in the harbor. The China arrived last night. The Boston, sent out by Dewey as a scout, with three transports came in this morning. The Monterey is about two or three days behind. When she arrives Manila will be at our mercy. There is said to be 600 sacks of mail on the transports for us. Suppose I will get some of it. Many of the boys have not had any mail since leaving the Philippines. The weather is still quite warm but getting cooler. I have gained several pounds in weight and now weigh 151. George Starnes is the only Roseburg boy who is not standing it well. He fell down the hatchway of the Australia coming over and has not gotten over it yet. He feels better at times but is in the hospital most of the time. The slim boys are feeling up and fat boys falling off as a rule. Bob't. Wilcox is just about the same. Dixon has fallen off considerably and is looking and feeling well. Harry Slocum is filling out. D. B. Shamrock is holding his own.

We went out on a practice march Friday. Stayed out all day. Marched about 8 or 10 miles all together, had target practice during the heat of the day and came to camp in the evening. I am one of the 15 members of Brigade Count Mardal. Court was in session from 9 till 3 Saturday trying a 14th Infantry case. The health of the camp is much better since more attention is paid to preventing the boys from eating so much fruit and drinking unboiled water.

The natives wash and iron clothes for 5 cents per piece, Spanish money, equal to about 25 cents of our money. They get a great deal of it to do. It is now about noon so I will stop for dinner and write some more this afternoon or in the morning after we get the mail from the ships.

2:30 p. m.—The mail came on shore and has been distributed. I received several letters. We got about 10 large mail sacks full for our regiment. Nearly every man got three or four letters or papers and some got twenty or 30. The weather is very pleasant this afternoon. Must close for the present as the mail leaves in half an hour.

July 21.—Wm. Warm, a member of our company from Newport, Or., has been discharged for disability and will be sent home. I will not basket containing packages, home by him, and so will have Shamrock and Harry Slocum. We are still expecting hourly the arrival of the Monterey and third expedition under General Merritt. Manila is still in the hands of the Spanish, but we think a demand for surrender by Dewey backed by Merritt will be accepted at once. If not, the plan is for a bombardment of Manila by warships, followed by the landing of troops. The California boys are camped within two miles of Manila on the east. We are still in Cavite, about seven miles directly south of Manila, across the Pasig river, opposite New Manila to be taken when general action begins. Insurgents are still keeping up a desultory fight. It amounts to nothing except to harass the Spaniards and helps to keep them shut up in Manila. Have received news of the surrender of Santiago de Cuba. Weather is now comparatively cool. We sleep under single blanket at night. Rain is more or less every day. It is raining at drill time, drill is usually suspended. The soil is very porous and dries off very quickly. I wear cork-soled shoes which I have had a few times, and can paddle in mud all day and my feet are dry at night. Boys are all well except George Starnes and he is improving.

Lieutenant Huston, Sergeant Shamrock and Slocum and Corporal Day and myself went down to a native village of San Roque yesterday to get some sea shells.

July 20.—Mail leaves today. All well. F. B. H.

ON INSECTS AND BEETLES.

Two Argonauts' Horrible Experience On the Sticken.

The Sticken route has given up another horror. J. Cassidy, direct from Sticken river, says: "As the steamer Monte Cristo passed a point in the river she was hailed by two men from the bank. As the boat approached it was seen that the men were in a dreadful plight. Cassidy jumped from the deck to the shore, and stood agape at the sight of the two emaciated and scathed skeletons, which confronted him. One wore but a vest to cover his nakedness; the other was dressed in tattered trousers. They essayed to speak, but their joy at delivery being too much, both fell in a heap of bones at his feet. The two gray-haired, shriveled forms were lifted on board tenderly. Lying comfortably in bed they told their story.

"They had much difficulty with swollen tongues and throats. Their names were Jorgensen, of Seattle, father and son. The boy, gray-haired, wrinkled and bent, was 19; the father 50. They had two years' provision, and were exploring a branch of the Sticken river, never navigated. In the rapids their boat upset and they lost everything except what they had on their backs. They could not go back, so they cut across country, starving for 16 days.

"They went three days with no food. The fourth they ate grass and bark of young trees. The fifth they devoured a nest of beetles and grass with dew on it. The sixth, seventh and eighth they lived on tree loads. The ninth, tenth and eleventh they struck a stream and devoured every living insect they could find.

"A bear drank by their side with her cubs. They did not dare to stir her by killing her cubs. The bear stayed two hours gazing at them. The next day they were followed by wolves, which chased them from the stream. They lived on berries and insects. The wolves spurred them on to a last effort. In another day they would have been torn to pieces by the wild-eyed band which formed a circle around them, 20 or 30 of them every night, waiting till they judged them too weak to resist.

"Mr. Cassidy says this is one of the many horrors the Sticken will produce. It is probable that the elder man cannot rally.

A SUDDEN DEATH.

Harry Houghton Found Dead in Bed at the Churchhill.

Harry Houghton was found dead in his bed at the Churchill House, Monday morning at 11:30 o'clock. It was his custom to retire to his room about 9:30 each day and remain until called to dinner. The dinner hour having arrived, one of the inmates of the hotel called him at the usual hour, and receiving no response, the room was entered to find Houghton dead. Dr. Page was called, who upon examination found that death was caused by heart failure, due, in the opinion of the physician, to alcoholism, the deceased being what is known in saloon parlance as "a heavy drinker." The house of the deceased in Chicago, where his mother now resides. He had been on the coast about ten years, engaged principally in mining, but his investments were not successful and loss followed his ventures until finally reduced he was given to excessive drink. He came to Oakland about three months ago, since which time he made his home at the Churchill house. His mother lives in Chicago, from whom he has from time to time received small sums of money, a small unpaid check being in the hands of E. G. Young & Co., at the time of his death. Relatives of the deceased also reside at Spokane. The friends were immediately notified by wire, when E. G. Young & Co. received the following dispatch from the mother at Chicago: Chicago, Aug. 28, 1898.

E. G. Young & Co., Oakland, Ore.

Funeral of Herbert Applegate.

Herbert H. Applegate, the young soldier who died in San Francisco on Thursday, August 18, 1898, aged 22 years, 5 months and 16 days, was a son of Henry and Nancy Applegate of Ashland, and a grandson of Jesse Applegate and Samuel Grubbe, the Oregon pioneers. He enlisted as a volunteer recruit for the Second Regiment, Oregon Volunteers, June 17, 1898, and was mustered into the service July 12, 1898. Soon after going to San Francisco he was attacked with measles, which followed by pneumonia, which speedily terminated his life. He was a young man of lovable character, exemplary life and of bright promise. He leaves a father and mother, four brothers and one sister to mourn his untimely departure. His father being away in the mountains could not be found in time to be present at the funeral service, which was attended by a large concourse of relatives and friends from the residence of Mrs. M. L. McCall, interment in Ashland cemetery. In his sickness he was tenderly cared for by the Red Cross Society of San Francisco. His remains were carried to the Ashland Cemetery by the Ashland militia company, accompanied by the ladies of the Red, White and Blue and Relief Corps societies. The funeral took place Monday afternoon, the services being conducted by Rev. F. G. Strange. The music was furnished by a selected quartette.

Mr. Applegate was the first one of our Ashland soldiers to give up his life while in the service of his country.—Valley Record, Ashland.
