TAKES AGGRESSIVE.

Active Campaign Against the Filipinos Will Be Begun

AMERICANS ABOUT TO ADVANCE

The Second Oregon Made Part of General Wheaton's Brigade, Seventeenth Regulars Relieving Them.

MANILA, March 12—11:30 a. m.—In all probability the current week will see the beginning of an active campaign on a scale hitherto unknown to the Philippines. For the last few days there has been unusual activity at headquarters, and there is every indication of a complete reorganization of the entire corps in the near future.

Since the arrival of the American reinforcements several changes have been made, the most important being the appointment of a divisional brigade under General Wheaton, consisting of the Twentieth and Twenty-second regiments of infantry, eight companies of the Washington and seven companies of the Oregon volunteers, three mounted troops of cavalry and a battalion of light artillery.

All the troops have disembarked. A battalion of the Fourth regular infantry is already on the firing line, assigned to General MacArthur's division. The others have been held in reserve, and are encamped on the Luneta parade ground.

A battalion of the Seventeenth regulars has been assigned to prevent guard, relieving the Oregon volunteers.

During a rainstorm which occurred before daylight this morning the rebels on the extreme left fired several volleys at the Americans, but without effect. Otherwise everything is quiet.

MANILA, March 11—3:15 p. m.—At daylight the rebels were caught enfilading the entrenchments at Calocan, and were shelled by a battery. Desultory firing also took place at San Pedro Macati.

The United States cruiser Charleston has relieved the armed transport Buffalo off Parangue.

The last batch of Spanish soldiers, numbering 885 men, including a few, who are in the hospital, were embarked on the transport Buenos Ayres today.

NO INSTRUCTIONS TO OTIS.

The General's Plans Are Not Known in Washington.

WASHINGTON, March 11.—It was positively denied in the adjutant-general's office today that any dispatch had been received from General Otis regarding a conference with General Lawton. It is well understood that General Otis is only awaiting the arrival of the remainder of his reinforcements to inaugurate an active campaign, though the department has heard nothing from him on the subject.

The war department, according to its officials, is awaiting with quite as much interest as the public some definite news from the Philippines, which will show just how General Otis intends to utilize General Lawton and his reinforcements in the campaign against the natives.

It has been quite generally understood without official confirmation, however, that General Lawton, on his arrival, will be assigned to active command of the operations in the field, leaving General Otis more time for the administration duties of military governor. The fact is that none save very general instructions have been sent to General Otis, and the department avers that it has not tied the commanding general's hands with any hard-and-fast orders.

The probabilities are that General Lawton will take a very active part in the offensive campaign soon to begin. His training in Indian fighting has peculiarly fitted him for his present command, and General Otis is well acquainted with his capabilities.

One of Lawton's numerous Indian souvenirs being literally translated is "The Man Who Gets Up and Fights in the Middle of the Night." It was his surprise dash into Siboney that sent the Spanish detachment there flying to La Guasimas, leaving its breakfast on the fire for American troops to eat.

The department fully expects Lawton to spring a few like surprises on the Filipinos, and is awaiting news of the field campaign with proportionate interest.

NOT SAFE FOR THEM.

No More Officers' Families Will Be Taken to Manila.

WASHINGTON, March 11.—The war department today issued the following: "Adjutant-General's Office, Washington, March 11, 1899.—Commanding General, Department of the East, Governor's Island, New York: The following cablegram has been received from General Otis:

"Manila is not a safe place for officers' families; great difficulty is experienced in caring for those now here, and their safety is one of the chief causes of anxiety. Officers' families should remain in the United States."

"Under such conditions, the secretary of war regrets that no more families of officers or enlisted men will be permitted to accompany the troops. Families of officers and all non-commissioned officers for whom quarters are legally provided will be permitted to retain their quarters at the posts from which troops depart, according to the provisions in the memorandum circular dated Adjutant-General's Office, January 18, 1899." Resolutions of Respect to the memory of Aaron Rose by Laurel Lodge

Hall of Laurel Lodge No. 13 A. F. & A. M. To His Worshipful Master, Warden and Brethren—Your committee to whom was assigned the duty of preparing the report expressive of the feelings of the brethren of the lodge, relative to the death of our venerable brother Aaron Rose, beg leave to report:

That for more than forty years Aaron Rose has been a faithful member of this lodge, the pioneer lodge of the Umpqua valley.

To a large extent by his exertion and financial assistance the lodge was enabled to maintain itself in its vicissitudes and struggles in its youth. He lived to see masonry, which he helped to establish in southern Oregon, grow from a few members scattered over a wide territory, into a powerful organization comprising a membership of many thousands, with a lodge in almost every town and village. He lived to see the territory in which he was a pioneer settler, grow from a few hundred inhabitants in 1851 into a great state.

He lived to see the ox team by which he made the tedious toilsome journey to the unknown territory of Oregon, superseded by railroad and electric car, and the trading posts of the early fifties grow into thriving cities.

He lived to see the ground upon which he erected the first log cabin within the confines of the present city of Roseburg, covered with a stately brick. He lived to see the town which he had out and platted, grow into the leading city of southern Oregon, largely through his judgment and liberality. He was the poor man's friend. His needy and distressed neighbor appealed to him in vain. He was foremost in every good work that tended to the material advancement of the community. He was a just and upright citizen, and a progressive, honorable and useful citizen.

This lodge and community have lost a member who will be missed as none other would have been missed.

Resolved, That this report be spread upon the records of the lodge, and that a copy thereof be forwarded to the members of the family of our deceased brother.

That our lodge be draped in mourning, and that the members wear the usual badge of mourning for thirty days, and a copy of this report be given to the newspapers of our city for publication.
