ains, all efforts to send parcels of clothes and other necessities to Miss Stone, who must be suffering from the cold, have been baffled. All attempts to communicate with the brigands have been unsuccessful. The bandits are apparently afraid of treachery, and determined not to disclose their hiding place."

OREGON MEN DROWNED AT SKAGWAY.

SEATTLE, Oct. 22.—If strong circumstantial evidence counts for anything it is almost certain that Benjamin Carey, of Astoria, Or., and James Torey, of Montana, were victims of the mad torrent which flooded Skagway. It appears that the two men arrived at White Horse from down the river Thursday and started to walk to Skagway. C. Pierson was accompanying them. Pierson stated at Skagway that the trio camped on the summit Thursday night and late Friday morning struck out for Skagway, following the railway track on account of the bad condition of the trail. Pierson left the two men warming themselves by a fire, and walked into Skagway. When he awoke next morning the flood was raging. A search was made, but no trace of the men has been found. The damage at Porcupine was far greater than that brought about by the flood in August. The swollen stream went high above the high water mark and destruction amounting to many thousands of dollars followed in the wake of the flood.

GIRL'S BODY FOUND IN A TRUNK.

WALLA WALLA, Oct. 22.—Frank Virod, a prospector in the Salmon River country, found in an old tunnel near a shack in the blue mountains a trunk containing a human body, twisted and bent to fit the receptacle. It had been left there by a man and a woman, who had passed through six weeks before. Virod did not know they had left it. The discovery was made two months ago. Only by accident was the information secured from him on his first trip out of the mountains. He is now on his way to Washtucna county.

Who the man and woman were Virod does not know, and he has no idea who the victim was. He said they came last June and said they had lost their way. They camped all night in a tunnel near his shack. Next morning they went away. In August Virod looked in the tunnel and found a trunk containing the body. He thought it was the body of a girl 6 or 8 years old. The skull had been cleft by an ax and the legs broken. He buried the trunk. He says the woman who left the trunk was about 40 years old, dark, and dressed in black. The man was tall, dark and had a squint.

PRESIDENT AT FARMINGTON.

FARMINGTON, Conn., Oct. 22.—President Roosevelt, on the way to New Haven to receive a Yale University degree, spent the day here, the guest of his sister, wife of Commander Cowles, U. S. N. His train reached the station, two miles from the village, at 3:30 a. m. and there the presidential special car was side-tracked. Mr. Roosevelt sleeping until 7 o'clock. At that time Mrs. Cowles arrived and welcomed her brother and others of the presidential party escorting them to the family residence in the village. Before leaving the station the president shook hands and conversed with several residents of that place, but in conformity to his expressed wish that his visit here should be regarded as a private affair, there was no demonstration such as the townspeople would have been glad to extend: Later in the morning the president received the Warden and Burgess of the borough, who expressed their best wishes.

KILLED AND EATEN BY WILD BEAST.

METROPOLIS, Ill., Oct. 22.—News has been received here that a hunter was killed and partly eaten by a wild animal among the bluffs near Glendale, 20 miles from here. Another hunter heard the man's cries, and on reaching the spot was horrified to see the lion crouching over the dead form of his companion and tearing at his mangled and bleeding flesh, a large portion of which had already been eaten. When the animal saw the second hunter it sprang at him and a desperate fight followed. By the use of a hunting knife he fought the animal off. There were evidences that the dead hunter and the beast had a fierce struggle.

NEW YORK STARTS FOR SAMAR.

WASHINGTON, Oct. 22.—The Navy Department has received the following cablegram from Rear-Admiral Rodgers:
"Cavite, Oct. 22.—Secretary of the Navy, Washington: Active insurrection in Samar. New York leaves today for Catbalogan with 300 marines, to return to Basey and Balangiga to co-operate with army. Nearly all naval force concentrated on Samar patrol. Services of Arethusa and Zafiro, two colliers, needed and being utilized."
Naval officers construe the dispatch to mean that the New York will go first to Catbalogan and then to Basey and Balangiga, landing detachments of marines at each point.

PRIEST VISITS CZOLGOSZ.

AUBURN, N. Y., Oct. 22.—In accordance with Czolgosz' wishes, the Rev. John Hockey, pastor of the church of the Holy Family and the Catholic chaplain of the prison, has appointed Rev. Father Szadzinski, pastor of the Polish church of Rochester, to attend Czolgosz in his last hours. He visited the assassin today. After his baptism, Czolgosz never practiced his religion, and as an anarchist denounced all its tenets. He will make a statement to this effect before his death.
