LATE NEWS SUMMARY

Important Events of the Past few Days.

STATE, GENERAL, FOREIGN.

Cream of the Dispatches Dished Up in Condensed Form for the Busy Reader.

The public school at Amity was closed for the term last week on account of diphtheria.

The U. of O. is to lose the ablest president it has ever had, Dr. Frank Strong, who has been elected president of the University of Kansas.

Charles Kieley, of Marquam, and T. Sault of Woodburn, have contracted for 2,000 bushels of their next year's crop of hops to a New York firm at 12 1/2 cents a pound.

The fate of the obnoxious bill is now in the hands of President Roosevelt. The Senate, after passing the measure, took up the Philippine government bill which was still under consideration when adjournment was taken.

The remaining unpassed supply of bills in Congress are in such shape that they can be disposed of in a month. Measures which would be abandoned would be those pertaining to the Nicaragua Canal, Cuban reciprocity, irrigation, interstate commerce, the Pacific cable, ship subsidy, and pure-food legislation. President Roosevelt will oppose any such scheme.

A new one-cent postal card is now being printed at the bureau of engraving and printing, and when the first issue of 4,000,000 has been counted and bundled, the new card will be placed on sale. Its distinctive feature is that the new card contains a vignette of President McKinley in lieu of President Jefferson's portrait. The issue of the Jefferson card will be discontinued when the present stock on hand is exhausted.

GOOD WORK IN DOUGLAS COUNTY. F. J. Cleton's Report of His Campaign in this County.

PORTLAND, April 28.—F. J. Cleton reported yesterday from Douglas County, where he has been campaigning in the interests of the Republican state ticket.

He spoke at Canyonville, Ribbles, Myrtle Creek and Drain and reported much Republican enthusiasm at each meeting. Speaking of his trip yesterday, Mr. Cleton said: "I reached Roseburg Sunday evening, and on Monday, accompanied by State Senator A. C. Masters, and a number of the county candidates, drove to Canyonville, where we addressed a gathering of some 75, at an afternoon meeting. The meeting was a very enthusiastic one, and Canyonville Republicans are going to vote right in the June election. That evening we addressed another crowded house at Ribbles, and Tuesday night found us face to face with a big Republican meeting at Myrtle Creek. Last night we were at Drain and were received with genuine Republican enthusiasm. In regard to the theme of my own discourse at these meetings, I will only say that I made a comparison of the records of the Republican and Democratic parties. I concluded that the Democratic party has sidetracked its paramount issues of 1896 and 1898, practically admitting that these issues were false. I endeavored to persuade my hearers that Oregon will derive vast benefits from our trade with the Philippines, and that the present campaign is one for National expansion and trade extension.

"I found little or no sentiment among the Republicans against Mr. Furnish, and I believe that he will make a strong run in Douglas County, receiving the full strength of his ticket. The county is Republican, and I am convinced that the local state ticket will win out there."

LATEST NEWS.

Geary Law Re-Enacted. Gala Day at Cottage Grove. Portland Strikes.

WASHINGTON, April 28.—The conferees on the Chinese exclusion bill reached a complete agreement on the bill today. Their report was submitted to the Senate and House this afternoon, and in each instance adopted without debate. The bill now goes to the President for his approval, which is assured by the firm stand he has taken for the measure. The Geary exclusion law is extended without any limitation as to time. Operation of the law in the Philippines is placed in the hands of the commission, and is to be extended, as far as applicable, to all American island territory.

COTTAGE GROVE'S GALA DAY.

COTTAGE GROVE, April 30.—Wednesday was a day long to be remembered in this city. The active work on the Oregon & Southeastern Railway to the Bohemian mines commenced on this day and the citizens carried out a monster celebration. In spite of the limited time a large crowd was present from Douglas and Lane counties.

Gov. T. T. Geer broke the first sod and delivered an address. The mayors of Cottage Grove and Eugene assisted in the ceremonies. Speeches were made by Hon. R. A. Booth, Hon. Wm. Kuykendall, Hon. L. Bilyeu, Hon. E. R. Skipworth and others. In the evening a public reception was tendered Governor Geer. The city is alive with new arrivals, and property is rapidly advancing.

FURNISH IS THE MAN.

Judge Lowell's Bad Break. He Commands No Streight.

Judge W. R. Ellis, ex-Congressman from Oregon was in Portland Tuesday, on legal business. In speaking of the political outlook, Judge Ellis said: "Umatilla county will give Mr. Furnish all the way from 800 to 1800 majority. I do not personally know much of the feeling in the other counties."

"I know Mr. Furnish, and have known him for a long time. He is a good, clean man and commands the entire respect of the people of Eastern Oregon who know him. Unless Mr. Chamberlain gets a vote in the western part of the state that is unprecedented, Mr. Furnish will be elected by a safe majority."

"In regard to Judge Lowell's bolt, I think that the Judge made a mistake. While it will have no big influence, it shows his impracticable nature. Judge Lowell personally is a good and lovable man, but in politics he does not command much strength."

PORTLAND STRIKES.

PORTLAND, April 28.—The sawmill's union has called out 75 employees of the Jones mill here, because Jones refuses to recognize the union and to raise wages. It is feared this may result in a general lockout, in which case 10,000 men will be affected.

PORTLAND, April 28.—All the laundries here today are closed by a strike of the union employees. Three hundred are out, 200 of whom are women and girls. The strikers demand recognition of the union, and better prices for their work.

RESCUE WORKER NEARLY MURDERED.

PORTLAND, April 29.—Miss Faith Stewart, a rescue worker among the denizens of slum Portland, is in a dying condition at her home, East Sixth and East Mill streets, as a result of a brutal and murderous assault made upon her last Sunday night by five men in the Bad Lands district. Since her terrible experience she has been only semi-conscious most of the time, and has suffered terrible agony. She can speak but a few words at a time. An attendant today said she was sinking rapidly. Her assailants have not been captured. The police are working on the case.

DEATH AND RUIN IN TEXAS.

DALLAS, Tex., April 29.—The only details received from the vicinity of Glenrose, which was swept by a tornado last night, say that the property loss is greater than at first reported. No mention is made of greater loss of life than is shown in the early reports. It is now said that 50 or 60 persons were injured. A report received from Morgan says that two persons are reported killed near Brazos Point, as a result of the storm. Supplies and doctors have been sent to the scene of the tornado.

YOUNG MEN BOUND OVER

Must Answer To Circuit Court For Bank Robbery.

DEATH OF J. S. MORTON

Governor Geer Announces His Candidacy for United States Senator.

ROSEBURG, April 29.—William T. Geer and Thomas Vannoy were bound over to the Circuit Court today to answer to a charge of robbing the bank of Roseburg yesterday of \$1200. Their bonds were placed at \$2000 each. While the cashier of the Bank of Roseburg was at dinner yesterday someone entered the bank from the rear part and took \$1200 in gold. The robbery must have been between 12 and 12:30 p. m. No one saw anybody in the bank during that time, and the bank building stands in the center of the business part of town. The suspicion is the person or persons that committed the robbery entered the woodshed of A. A. Tensing, which joins the bank building on the west, and entered the rear of the bank by way of a window. After gaining entrance it was an easy matter to get into the bank proper.

The cashier in going to dinner did not turn the combination on the safe but simply locked it. The robber was evidently acquainted with the construction of the lock, and was prepared with a small piece of straw which fitted into the lock and sprung it back. The two young men arrested, William O. Tynd and Thomas Vannoy, were both real boys, and both being to good families. The evidence against them at present is not very strong. The young men are being defended by Russell Wyatt of Albany. The prosecution is being conducted by Prosecuting Attorney J. N. Hart.

Morton Dead.

On April 27, Hon. J. Sterling Morton, ex-secretary of agriculture, died at 10 o'clock this afternoon at Lake Forest, at the home of his son, Mark Morton. He was 67 years of age. Mr. Morton had been gradually failing. The nature of his sickness had not been determined, and a week ago he was brought from his home at Nebraska City, Neb., to Lake Forest for medical attention. The change brought no improvement, and he died gradually until death came. He was born April 22, 1835, secretary of Nebraska Territory, 1850; secretary of agriculture, 1862-67; founder of Arbor Day; member of Nebraska Territorial legislature; president of Nebraska Territorial Board of Agriculture; president of Nebraska Horticultural society; president of American Forestry Association.

The Supreme Lodge, A. O. U. W.

In Portland, the members of the order and business men generally are making great preparations for the coming of the Supreme Lodge, A. O. U. W., and the Supreme Lodge of the Degree of Honor, The Oregonian and the Telegram have devoted much space to this event, showing how important they consider it. Mr. C. C. Hoque, the Grand Master Workman of Oregon, has arranged to have the members and visiting friends take a trip up the valley. The usual rule is for similar bodies to make excursions to Astoria and up the Columbia river and not one in ten of eastern visitors see our beautiful valleys, on such occasions. It is fortunate that we have a valley man at the head of the order in this state at this time, otherwise such an arrangement would have not been carried out.

Justice in Democratic Idaho.

In one of the sparsely settled districts of Idaho a man convicted of murder was called up before the judge for sentence. The judge angrily began by saying, "John Smith, when I ran for office in this district there were seven qualified voters here. Four were Democrats and three were Republicans. I was a Democratic candidate and elected by a majority of 1. You have killed that majority and it is the sentence of the court."

"Hold on, judge," said the culprit, "I reckon we can fix that. If you will let me go I'll vote the Democratic ticket next election."

For U. S. Senator.

Governor Geer has announced his candidacy for the United States Senate in a statement given out at Salem. He said that he had long declined to enter the race, but had received so many requests from all parts of the state that he was forced to yield. He has always favored the selection of United States senators by the direct vote of the people, and in keeping with this opinion consents to allow his name to go on the official ballot under the Mays law.
